Item 11 of the Provisional Agenda: Presentation of the World Heritage Fund and of the state and forecasts of income; approval of the workplan and budget for 1999, and of the provisional budget for 2000.

SUMMARY

In accordance with the Financial Regulations for the World Heritage Fund, Article 4.1, the resources of the Fund may be used only for such purposes as the World Heritage Committee shall define. The World Heritage Centre presents herewith the proposed budget of the World Heritage Fund for 1999 and the indicative budget for 2000.

Decision required: The Committee is requested to take note of the accounts of the World Heritage Fund for 1997 approved by the Comptroller and the provisional accounts of the World Heritage Fund for 1998, as of 31 August 1998, and to decide upon a ceiling for the budgetary allocation for 1999 and to allocate within this ceiling the amounts for the different budgetary codes. The Committee is also requested to examine and approve the work plan for 1999 and to decide upon provisions for 2000.

I. INTRODUCTION

I.1. At its twenty-first session (Naples, 1-6 December 1997), the World Heritage Committee considered that the general presentation of the work plan and the budget had greatly improved. However, it noted that (i) the implementation of the recommendations of the external auditors had not been fully completed; (ii) the response to the requests for assistance and their implementation was not sufficiently rapid and, (iii) better advantage should be taken of the financial reserves of the Fund.

I.2. Since then, several important measures have been undertaken and have substantially improved the implementation of the Committee's decisions as well as co-operation financed from the World Heritage Fund. Hence:

- the World Heritage Centre has successfully established a database for international assistance (Chapter III) and emergency assistance; this database, used on a regular basis by the Centre, has improved the implementation and the monitoring of operations; it also serves as a tool for analysis, improving decision-making;
- this database is used with a detailed list of obligations showing the funding source and the region, thus allowing a better management of the allocation of resources to World Heritage;
- the preparation of the budget and the work plan of the World Heritage Fund is more functional and presents more clearly the principle actions foreseen; this simplifies the analysis;
- the external auditors have continued the verification of the implementation of their recommendations which have all been applied.

I.3. This document follows the same structure as that submitted at the twenty-first session in Naples in 1997. It presents herewith:

- a synthesis of objectives defined during the work of the Committee and those of the « Approved Programme and Budget for 1998-1999 » (29/C 5, III.1.2 « Promotion of the Convention concerning the Protection of the World Cultural and Natural Heritage »), in particular for the period 1999, the year 2000 relating to the « Draft Programme and Budget for 2000-2001 » under preparation;
- the allocation of resources of the Fund for 1999 based on (i) the indicative budget approved by the Committee at its twenty-first session and (ii) the financial situation of the Fund; as well as the indicative budget for 2000.

II. ACCOUNTS OF THE WORLD HERITAGE FUND

II.1. In accordance with Article 4.1 of the Financial Regulations for the World Heritage Fund (WHC 7), the resources of the Fund may be used only for such purposes as the World Heritage Committee shall define and the expenditure may only be engaged to the amount of funds available.

II.2. After examination of the financial situation as at 31 August 1998 and taking into account the proposals made at the twenty-first session of the Committee to reduce the unused available resources, for 1999 the Secretariat recommended an increase of the 1998 budget by US\$ 589,250 (five hundred and eighty-nine thousand two hundred and fifty US dollars) and an increase of US\$ 660,000 (six hundred and sixty thousand US dollars) in the provisional budget proposed for 1999 at the twenty-first session of the World Heritage Committee (Naples, December 1997), over and above funds for « Services for promotional activities » which are presented in a separate line.

II.3. This represents an increase in 1999 of 14.17% in comparison to the 1998 budget (US\$ 4,750,000 instead of US\$ 4,160,750 not including funds allocated for promotional activities). **The total budget proposed for the World Heritage Fund (including funds allocated for promotional activities) for 1999 amounts to US\$ 4,900,000.**

II.4. Furthermore, the Secretariat proposes that the **Emergency Reserve Fund** to finance assistance requests in the event of natural disasters and catastrophes, be reprovisioned to an amount of **US\$ 600,000** as of 1 January 1999. In fact, the allocations approved in 1998 for emergency requests have exceeded the amount allocated by the twenty-first session of the Committee (US\$ 600,000 against US\$ 500,000) and the Bureau at its twenty-second session, had to authorise the Chairperson to use the international assistance budgetary line to honour the other emergency requests.

II.5. In examining these proposals, the Committee should note that the mandatory contributions evaluated for 1998 will be in the order of US\$ 2 million, that the voluntary contributions should amount approximately to US\$ 1,100,000 and that the total for other income

should amount approximately to US\$ 460,000¹. Implementation of this budget will therefore reduce the reserves by approximately US\$1,190,000, not including the reprovisioning of the Emergency Reserve Fund and its increase to US\$ 600,000.

II.6. In order to maintain this tendency in the coming years as well as a strict and prudent management, the Secretariat proposes that the proposed budget for the year 2000 be US\$ 4,800,000, excluding the reprovisioning of the Emergency Reserve Fund and the funds allocated for promotional activities.

II.7. With regard to the Reserve for contingent liabilities, it was established for an amount of US\$ 2 million by a decision taken at the seventeenth session of the Committee (Cartagena, 1993). The Secretariat considers that it would be wise to maintain this Reserve at its present level, taking into account the global financial situation and the fact that the budget proposed for 1999 exceeds the income foreseen for this year.

II.8. The following table (Table 1) presents the situation of the allocations and expenditure for the period 1 January to 31 August 1998 of the World Heritage Fund. A revised version of this situation, established as at 31 October 1998, will be presented during the twenty-second session. Table 2 presents the level of implementation for 1997 and the budget proposals for 1999 and 2000.

III. FORECAST FOR INCOME FROM PROMOTIONAL AND EDUCATIONAL ACTIVITIES

1. Section (D) of the Document WHC-98/CONF.203/15 "World Heritage Documentation, Information and Education Activities" provides details on the income received in 1997 and to be received in 1998 in the framework of the partnerships between the World Heritage Centre and the audio-visual production companies, publishing houses as well as the **Rhône Poulenc Foundation and the Norwegian Development Agency (NORAD)**. The forecasts of this income for 1999, detailed below, are based on the income to be received in 1998.

2. Euro-Média (represented by Südwestfunk) - Germany

Südwestfunk (SWF) has produced more than one hundred television films in the framework of the agreement between Euro-Media and the World Heritage. For each film produced, SWF pays an amount of 3,000 DM (approx. US\$ 1,820) to the World Heritage Fund for the servicing of this contract. In 1997, a sum of US\$ 11,413 was received for the production of seven new films and a sum of US\$ 29,905 will be received in 1998 for the production of fifteen new films. Exceptionally, a double contribution (6,000 DM) will be received for the production of three of these fifteen films.

In 1998, SWF produced about twenty other films in the framework of this agreement for which a contribution will be paid to the World Heritage Fund in 1999, estimated at US\$ 35,000. A second agreement for the production of these films was signed between the successor of SWF, Südwestrundfunk (SWR), and the Centre to continue the production of films of World Heritage sites. This agreement will generate a financial contribution of a minimum annual amount of approximately US\$ 40,000 as of the year 2000.

1. National Federation of UNESCO Associations in Japan (NFUAJ) – Japan

NFUAJ pays each year an amount of US\$ 60,000 to the World Heritage Fund in the framework of an agreement between the Centre and NFUAJ for the production of a television series diffused by Tokyo Broadcasting Systems (TBS) in Japan. US\$ 30,000 are earmarked for the servicing of this contract and US\$ 30,000 are to be earmarked for a specific project, decided upon by the Federation and in agreement with the Centre and the Chairperson of the World Heritage Committee.

This contract is renewable each year in agreement with the two parties.

1. Verlagshaus Stuttgart (Germany) and Plaza y Janes (Spain)

The last payment (100,000 DM) corresponds to the minimum guaranteed as set out in the multilateral contract between Verlagshaus Stuttgart, Plaza y Janes and UNESCO, to be received in December 1999.

1. Kodansha (Japan)

The sales of the encyclopedia produced by the publishing house Kodansha for the Japanese market having begun in 1997, UNESCO receives 4% or 5% of the sale price of the encyclopedia, depending upon the number of copies sold in 1998 and 1999, to be divided between the World Heritage Fund and UNESCO Publications.

2. KOBI Graphics (Japan)

A minimum guarantee of an amount of US\$ 50,000 each year has been contributed to the World Heritage Fund by Kobi Graphics for Panasonic for three consecutive years (1996, 1997 et 1998) in the framework of an agreement between Kobi Graphics and the Centre. The eventual renewal of this agreement remains uncertain and consequently no payment can be foreseen for 1999.

In 1998, a certain number of contracts between the Centre and its different media partners come to an end (Kobi Graphics and Frederking and Thaler). The Walk Associates Ltd. (Japan) contract could not be renewed in 1998 and the one between Planetary Dialogues Inc. (Japan) and the Centre is seriously threatened due to certain economic and technical factors. Furthermore, no new fund-raising contract can be concluded until decisions by the World Heritage Committee concerning the use of the World Heritage emblem and fund-raising are forthcoming. These factors have contributed towards a fall in income for 1999.

On the other hand, thanks to a contract between SWR and the World Heritage Centre, income should increase as of the year 2000.

IV. ACTION PLAN FOR 1999 AND PROVISIONAL BUDGET FOR 2000

IV.1. General Objectives of the Action Plan (cf. 29C/5)

In 1999, the Centre will continue the implementation of the objectives inscribed in UNESCO's "Approved Programme and Budget for 1999-2000" (29C/5) at the General Conference of UNESCO, Major Programme III, Section III.1.2 "Promotion of the Convention Concerning the Protection of the World Cultural and Natural Heritage."

In 1999 and 2000, the Centre will continue to ensure the Secretariat of the Convention. It will furthermore make efforts to improve the implementation of the Convention in the following domains:

IV.1.1. Improvement of the representivity of the World Heritage List. The Centre will endeavour to :

- a) pursue the implementation of the Global Strategy for cultural and natural heritage;
- b) identify and contribute towards the dissemination of information on the new categories of sites situated in different cultural and biogeographical zones;
- c) encourage and pursue work on the links between cultural heritage and natural heritage;
- d) organise regional and thematic expert meetings;
- e) provide increased assistance to States Parties, in particular in Africa and in the less developed countries to help them to establish tentative lists, compile nomination dossiers and to formulate international assistance requests.

IV.1.2. Strengthening of the national capacities necessary for the protection of sites

The Centre, in co-operation with its advisory bodies and the UNESCO substantive sectors and field units, will continue to:

- a) assist States Parties to set up and reinforce local and national capabilities necessary for the application of the Convention;
- b) identify World Heritage properties in danger and provide adequate assistance to the States Parties in order that they may undertake the necessary emergency measures;
- c) contribute towards the implementation of training strategies for cultural and natural heritage specialists;
- d) use the World Heritage Fund as a catalyser to attract additional support from donors, bilateral aid organisms and private foundations. In this way, the Centre will encourage the establishment of medium-term co-operation programmes (2 to 3 years) for which it will seek co-financing arrangements as well as external contributions in order to strengthen the Fund's resources for these programmes.

IV.1.3 **Reporting on the state of conservation of World Heritage properties**

Once the Committee has chosen the first region or the first group of countries, the Secretariat will begin the preparation of a periodic report on the state of conservation of inscribed properties. This action will include awareness-building and training activities as well as technical support. The Centre will also encourage monitoring missions on the state of conservation each time the situation of a site necessitates this.

IV.1.4. **Awareness-building with the public and persons responsible for the World Heritage**

The Centre will:

- a) continue its efforts aimed at the development of information materials for different target groups : media, decision-makers, local authorities, general public, etc.
- b) facilitate access to information and its dissemination, particularly by Internet and through the use of the World Heritage Information Network (WHIN); it will also begin, with the support of States Parties, the establishment of a global information system to allow improved access to information;
- c) continue to co-operate with specialised international and national publishing houses for the production of printed multimedia documents and texts;
- d) pay particular attention to information for local communities.

IV.1.5. **Participation of Young People in the Preservation and Promotion of World Heritage.**

The Centre will continue the implementation of this project launched in 1994 with the Associated Schools of UNESCO and in close co-operation with the Education Sector. During the period of this plan, an educational kit produced in 1997 is in the process of being tested in 75 countries and will be distributed in 1999. At the same time, related activities such as teacher training will be undertaken.

IV.2. **Action Plan and Budget for 1999; indicative Budget for 2000**

This Section of the document provides a detailed presentation of the World Heritage Fund, according to activities foreseen and the resources necessary for their implementation.

IV.2.1. Chapter I : Implementation of the World Heritage Convention

IV.2.1.1 In conformity with the "Operational Guidelines for the Implementation of the World Heritage Convention" (paras. 133 and 134), the World Heritage Fund may be used to fund the participation of specialists representing the States members of the Committee figuring on the list of the least developed countries, as recognised by the United Nations, to statutory meetings of the World Heritage Convention. Experience gained from past years has shown that the amount allocated to this chapter of the Fund has never been fully utilised. Consequently, it is proposed to maintain the allocation of US\$ 70,000 for 1999 - year of the General Assembly of States Parties - and to reduce it to US\$ 65,000 in 2000.

IV.2.1.2 Furthermore, the World Heritage Centre will continue to finance the organisation of statutory meetings of the Convention from funds that are allocated to it from the Regular Programme of the Organisation. This includes the services of the Secretariat, translation and interpretation during the sessions, reproduction and dispatch of documents, room services and hospitality, communication costs, etc. The amount foreseen under budget line « Support for the organisation of statutory meetings » is US\$88,500 from the Regular Programme. This budget item is not sufficiently covered in the Regular Programme 1999-2000 of the World Heritage Centre in comparison to the preceding budget and it should be substantially increased in the new Draft Programme and Budget for 2000-2001.

IV.2.1.3 Co-ordination with other Conventions and programmes and organisations concerned with World Heritage, inscribed in the Fund's budget since 1998 has proved useful. The Secretariat has consequently been able to participate in:

- co-ordination or statutory meetings of other Conventions (CITES, RAMSAR, Biodiversity Convention – CBD - as well as that of Migratory Species – CMS),
- international and regional meetings organised by non-governmental organisations (WHCO),
- finally, meetings with staff from other United Nations agencies, international development banks and programmes which have encouraged better co-operation and an improved understanding of the Convention.

This co-operation is now aimed at the development of joint pilot projects for a co-ordinated approach to the state of conservation or for the strengthening of management methods of the sites. A common documentary database is under preparation, whilst an effort is being made, within the framework of other conventions and agreements, to strengthen the implementation of the World Heritage Convention.

Financial contributions for 1999 have been fixed at US\$ 25,000 from the World Heritage Fund and US\$ 15,000 from the Regular Programme.

IV.2.1.4. Running costs of the Secretariat of the World Heritage Convention are covered by the Regular Programme of UNESCO. These costs are divided into three categories:

- staff salaries (established or temporary posts),
- daily running costs,
- allocations of funds to implement the Workplan of the World Heritage Fund.

The UNESCO contribution is presented in the Approved Programme and Budget for 1998-1999 (29 C/5) of the Organisation, Major Programme III, Section III.1.2 “Promotion of the Convention concerning the Protection of the Cultural and Natural Heritage”. For 1998-1999, the total allocation of funds approved for the functioning of the Centre, Headquarters and Field, amounts to US\$ 982,600. This allocation was reduced by 10.7%, e.g. a net reduction of US\$ 117,700. Furthermore, about 25% of this budget is allocated for decentralised activities in the Field Offices, which limits the Centre's capacity to ensure the Secretariat of the Convention, although at the same time the number of properties inscribed and the consequent activities increase each year.

- The Committee may wish to recommend that the Director-General allocates to the Centre sufficient funds under the Regular Programme Budget for the next biennium 2000-2001 in order to enable the Centre to fulfil its obligations for the organisation of the Statutory meetings and to ensure the effective overall functioning of the Secretariat. As per actual costs incurred by the Centre at present, an amount of US\$1.280.000 is needed for the biennium 2000-2001;

this implies that the Regular Programme allocation needs to be increased by 30 % over the amount provided for the 1998-1999 biennium (US\$982.600). The Committee may wish to also suggest that the Director-General exempts the Centre from having to abide by minimum percentage decentralisation required of other UNESCO Sectors and Bureaux, since many of the World Heritage Fund financed projects and activities are implemented via the UNESCO Regional Offices.

IV.2.1.5 The daily running costs cover the overall general expenditures which cannot be attributed to a specific activity or chapter of the Fund: temporary staff assistance, communications (telephone, fax), dispatch of mail and air freight, reproduction and photocopying, office equipment and supplies (micro-computers and supplies and ancillary equipment), hospitality and office improvement. In this respect, at the beginning of 1999, the Centre will be able to regroup all the offices on one floor and henceforth proceed with a rational distribution of its allotted space. This will improve communications as well as the documentation and stockage capacities for its archives.

IV.2.1.6 At the date of this report, the staff of the World Heritage Centre, is presented in the Table and organisational chart which follow, by statute and function.

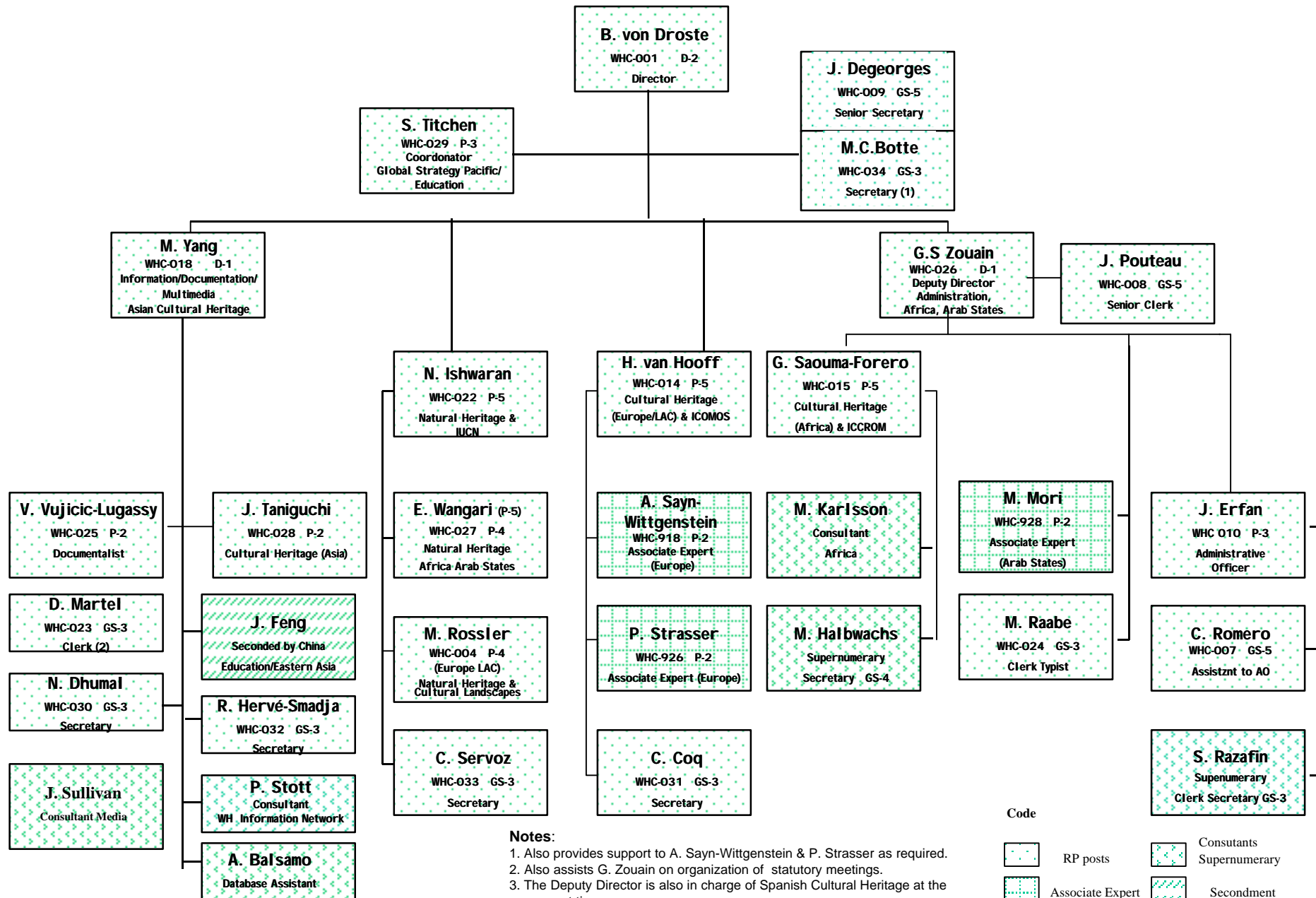

IV.2.2. Chapter II : Establishment of the World Heritage List

IV.2.2.1 Global Strategy

IV.2.2.1.1 Objectives 1998-1999.

The Global Strategy, adopted by the World Heritage Committee at its eighteenth session in December 1994, aims at improving the balance and the representivity of the World heritage List. As outlined in the Approved Programme and Budget for 1998-1999 (29C/5), the objectives of the Global Strategy in 1998-1999 are :

- to encourage countries to become States Parties to the *Convention* (particularly in Africa and the Caribbean and in the Pacific where few Member States of UNESCO have ratified it);
- to identify and help to diffuse knowledge about new categories of cultural and natural properties (including cultural landscapes), existing in different cultural and biogeographic areas;
- to encourage further research on the links between cultural and natural heritage;
- to provide assistance to States Parties (particularly in Africa, the Pacific and least developed countries) for the preparation of tentative lists, nominations and requests for international assistance.

IV.2.2.1.2 Expected outcomes 1999-2000.

Based on regional analyses presented in Document WHC-98/CONF-203/12, a better understanding of the *World Heritage Convention* is envisaged, and the diversity of categories representative of heritage of outstanding universal value in all regions which present, to different degrees, imbalances. Thus, the means available for conservation in the framework of the implementation of the Convention will be strengthened. More particularly, from now until end 2000, according to estimates, at least 20 new tentative lists and at least 15 new proposals for inscription of properties situated in regions of the world or pertaining to categories of cultural and natural heritage until now underrepresented on the World Heritage List, will be prepared. Particular attention will be given to the Pacific and the Caribbean, natural heritage in the Arab States and cultural heritage in Africa.

This work will be facilitated thanks to clearly defined regional activities such as analyses, thematic studies, expert meetings, publications and translations in languages other than English, French, Spanish.

IV.2.2.1.3 World Heritage Fund

At its twenty-first session in December 1997, the Committee approved five expert meetings, of which three will be held in 1999: (i) Expert Meeting on Cultural Landscapes in Africa (US\$ 40,000); (ii) Meeting on the Monitoring of Global Strategy for the Pacific (US\$ 30,000) and (iii) Sub-regional Meeting for Cultural Heritage in Central Asia (US\$ 20,000).

The budget requested for the implementation of the Global Strategy in 1999 (US\$ 213,000) is less than the budget for 1998 (US\$ 243,000). The activities identified will concern each region with a view to encouraging proposals for inscription of categories of cultural and natural properties presently underrepresented on the World heritage List. Section V of Working Document WHC-99/CONF.203/12 provides details of all the activities linked to the implementation of the Global Strategy, region by region. Section V presents activities by region which will be financed from Chapter II of the budget.

All the meetings and the activities proposed will be organised jointly by the World Heritage Centre and the advisory bodies.

The **ICOMOS** draft workplan and budget (see Annex I) includes the amount of US\$ 23,000 requested from the World Heritage Fund for the preparation of thematic studies. ICOMOS has proposed to continue the studies on underrepresented categories of industrial heritage, in particular the prehistoric sites of western Africa, and in collaboration with IUCN, studies on cultural landscapes in southern Africa and the Pacific.

The **IUCN** draft workplan and budget (see Annex II) includes the amount of US\$ 15,000 requested from the World Heritage Fund for the preparation of thematic studies in the field of natural heritage.¹

IV.2.2.1.4 Regular Programme

In 1999 and 2000 respectively, US\$ 20,500 (including US\$7.000 decentralised) will be deducted from the budget to cover mission costs for staff and consultants taking part in the implementation of the Global Strategy.

IV.2.2.2 Advisory Services – Evaluation of nominations

IV.2.2.2.1 Objectives

To provide the necessary advisory services in accordance with the World Heritage Convention and the “Operational Guidelines for the implementation of the World Heritage Convention”: evaluation of nominations, advisory body meetings with the World Heritage Centre, evaluation of international assistance requests and participation at specialists meetings.

IV.2.2.2.2 Expected outcomes

In 1999, 84 properties are submitted for evaluation by ICOMOS and IUCN: 16 natural, 62 cultural and 6 mixed.

In the case of natural heritage and cultural landscapes, the number of nominations which IUCN has been requested to evaluate has **increased from 8 in 1998 to 24 in 1999**. Hence, IUCN has increased the amount requested for this purpose from US\$ 210,750 in 1998, to US\$ 313,595 in 1999. The contribution to the World Conservation Monitoring Centre (WCMC) which provides information and data base management services to IUCN has annually received a contribution under this budget item which in most years has been included in UNESCO’s contract with IUCN for Advisory Services. In view of the sharp increase in the number of nominations to be evaluated, the request for an increase in the proposed budgets of IUCN and WCMC is justifiable.

With regard to cultural heritage, landscapes and mixed properties, ICOMOS will evaluate or participate in the evaluation of 64 properties, which explains the increase between the 1998 and 1999 budget requested.

IV.2.3. Chapter III: Technical Implementation of the World Heritage Convention

IV.2.3.1 Introduction.

Taking into account the implementation rate of the activities financed from the World Heritage Fund and the increase in the number of properties inscribed, which entails a growth in the requests for technical co-operation, the amount allocated in Chapter III of the budget of the Fund for 1999 continues to represent an important part of the Fund's budget (53% in 1999), not including emergency assistance, another form of international co-operation - which undergoes an increase of 20% of its budget - and the funds for services utilised for promotional activities.

IV.2.3.2. Objectives

In consultation and co-operation with the advisory bodies and the States Parties, to:

- for preparatory assistance, contribute towards identifying, conceiving, elaborating and executing technical co-operation projects adapted to each site, with funding from the World Heritage Fund;
- through advisory bodies, permit the Committee to examine the nominations for inscription of a selected number of cultural and natural properties on the World heritage List;
- through training, accelerate the implementation of the Training Strategies relating to cultural and natural heritage and to strengthen the national capabilities with regard to world heritage;
- finally, to promote and increase awareness of the work of the Convention and the importance of World Heritage through promotional activities at the local level.

IV.2.3.3. Activities foreseen in 1999.

- **Preparatory Assistance** : In 1999, efforts initiated in 1998 to use preparatory assistance in the conception and launching of technical co-operation projects will be continued.

Technical Co-operation : is used in conformity with paragraphs 99-106 of the « Operational Guidelines for the implementation of the World Heritage Convention », to support activities adapted to each site. In 1998, this co-operation was very much in demand and it is to be expected that this trend will continue. Furthermore, it should be noted that the amounts requested in favour of this assistance are increasing, thus reflecting the normal increase in service costs since the creation of the Fund and the escalating needs of States Parties for the good management of the inscribed sites. The Fourth World Parks Congress, a once-in-a-decade event, is to be convened in 2002 in Africa, most probably hosted by a southern African country. It is suggested that the Committee earmarks an amount of US\$50,000 for the year 2000, in order to support preparatory activities for this event « Africa 2002 ». The Committee may wish to request the Centre and IUCN to co-operate to prepare a workplan for a set of activities to be implemented during 2000 and submit a workplan to the twenty-third session of the Committee in December 1999.

- **Assistance for Training** will continue to be focused on the implementation of the Training Strategies for specialists in cultural and natural heritage, as adopted by the Committee over the past years. Africa will continue to be the priority for the conception and organisation of training activities relating to cultural heritage as for natural heritage. In the case of natural heritage, an examination of assistance for training granted to a regional training centre (e.g. Mweka (Tanzania); Garoua (Cameroon); CATIE (Costa Rica) and Wildlife Institute of India(WII)) will be carried out in collaboration with IUCN, and the emphasis will be placed on the elaboration of training programmes and materials for the management of protected areas.

A meeting of Regional Training Centres and academic institutions held in Dehra Dun, India, in April 1998, has identified several functional areas of protected area management as priorities for the development of curriculum and training materials. Specific World Heritage Convention related themes have also been identified for training module development. Meetings of experts and staff of training institutions will be convened to develop training modules which will be incorporated into the curricula of training institutions. The first such meeting, to be hosted by WCMC, will focus on "Integrating Biodiversity Information Management into the Curricula of Wildlife Training Institutions" in March 1999.

- The international assistance category "Assistance for Promotional Activities" was introduced in accordance with the Operational Guidelines, paragraphs 107 (a) and (b) in 1998. The maximum amount made available per grant, i.e. US\$ 10,000, has been found to be insufficient. It is suggested that the Committee consider raising the ceiling for this category of assistance to US\$ 30,000.

IV.2.4 Chapter IV : Reactive Monitoring and Periodic Reporting

IV.2.4.1 Reactive monitoring

There is an increased need for reactive monitoring the state of conservation of properties inscribed on the List of World Heritage in Danger and of specific properties that are under threat. As indicated in paragraph 75 of the Operational Guidelines, this reactive monitoring on the state of conservation of these properties can be undertaken by the Secretariat or the Advisory Bodies. In view of this increased need and the growing number of monitoring missions requested by the State parties, the Committee and/or its Bureau, it is proposed to increase the allocation for reactive monitoring from US\$ 120,000 to US\$ 195,000 (of which US\$ 45,000 for IUCN and US\$ 60,000 for ICOMOS).

IV.2.4.2 Periodic Reporting

IV.2.4.2.1 The requirement of periodic reporting by States Parties under Article 29 of the World Heritage Convention, has been confirmed by the Eleventh General Assembly of States Parties and the 29th General Conference of UNESCO. If the Committee adopts the proposals made in Working Document WHC-98/CONF.203/6, a six-year cycle will be applied for the periodic reporting and the examination of the reports per region by the Committee. In this connection, it is proposed that the World Heritage Committee, at its twenty-third session in 1999, adopts for each region a strategy for a six-year periodic reporting process, including budgetary proposals.

IV.2.4.2.2 It is to be foreseen that increased funding will be required for the periodic reporting process to accommodate support to States Parties for the preparation of periodic reports, the analysis and synthesis of the reports and the preparation and reproduction of the Regional State of the World Heritage Reports. It is estimated that an amount of maximum US\$ 280,000 per year will be required. This is presented in the following table. It should be noted here that increased funding will be required for the region concerned in the two years leading to the examination of its Regional State of the World Heritage Report.

- distribution of interpretive public information printed material
- Support World Heritage public information activities and events carried out by States Parties, non-governmental organisations and other partners
- Co-produce the World Heritage Review and edit and distribute the World Heritage Newsletter

IV.2.5.3. **Internet/WHIN** (C), the public dissemination, via the Internet, of World Heritage documentation. Thousands of partners in the World Heritage Information Network (WHIN) have made this one of the most cost-effective means of distribution of critical information about World Heritage;

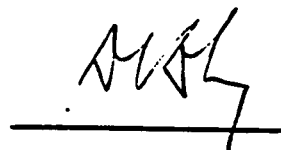
