Item 5D of the Provisional Agenda: Follow-up on the Periodic Reporting in Asia and the Pacific

SUMMARY

This document summarises the achievements of the first cycle of Periodic Reporting for the Asia-Pacific region and presents the follow-up strategy and activities elaborated by the World Heritage Centre, in line with the two regional programmes – Action Asia 2003-2009 and World Heritage – Pacific 2009 – adopted by the World Heritage Committee at its 27th session in July 2003 (see document *WHC-03/27.COM/20B*, pages 22-29).

This document was prepared for the 28th session of the World Heritage Committee (as document *WHC-04/28 COM/17D*), but was not presented, due to time constraints. It is presented herewith with an updated information (changes are highlighted).

I. Core of the document

1. The Periodic Reporting Exercise in brief:

39 States Parties from Asia (27) and the Pacific (12) participated in the exercise. 88 World Heritage properties inscribed on the World Heritage List until 1994 (55 cultural and 33 natural and mixed) were reviewed. 4,000 pages of national and site-specific reports were read, synthesized and analyzed by the World Heritage Centre, in co-operation with the Advisory Bodies and UNESCO Field Offices. National Focal Points for Periodic Reporting were appointed in each country for cultural and for natural heritage, thus enabling a strong participatory approach. Between 2001 and 2003, five national workshops, seven sub-regional / regional workshops, and three meetings with the Asia-Pacific Permanent Delegations to UNESCO were organized.

2. Following the presentation of the results of the Periodic Reporting Exercise to the World Heritage Committee at its 27th session, the Committee adopted the *Synthesis Regional Periodic Report* and the Regional programmes “Action Asia 2003-2009” and “World Heritage – Pacific 2009”. These programmes are focused on the following objectives:

- a) Capacity-building in the preparation of nomination dossiers and in site management planning;
- b) Poverty alleviation and community participation through the preservation of heritage;
- c) Thematic studies for a more representative World Heritage List;
- d) Dissemination of information on World Heritage in the region.

3. As a result of this first Periodic Reporting exercise, a publication entitled *The State of World Heritage in the Asia-Pacific Region*, which contains the summaries of the national Periodic Reports, is currently being published. Its CD-Rom was distributed in July 2004. Country and site profiles, good models of official World Heritage documents, best practices and case studies are being collected and digitalized to be disseminated through the new World Heritage Centre website.

4. In addition to these achievements, the Periodic Reporting exercise successfully provided an assessment of the application of the *World Heritage Convention* by the States Parties involved in the exercise. It also provided a real time picture of the state of conservation and the management and monitoring arrangements of the Asia-Pacific World Heritage properties inscribed on the World Heritage List before or in 1994. Finally, it enhanced regional co-operation and exchange of information and experiences between States Parties in the region

concerning the implementation of the *World Heritage Convention* and heritage conservation.

5. The follow-up activities to the Periodic Report in the Asia-Pacific Region have been elaborated according to the regional programmes adopted by the World Heritage Committee at its 27th session, taking into account the comments and recommendations of the Asia-Pacific States Parties.
6. The following phased approach has been adopted:
