#### **SUMMARY**

The following document includes:

- I. Background information summarizing the history of the proposal made by the World Heritage Centre to propose a World Heritage Visual Identity and Legal Protection of the Emblem.

This document was prepared for the 28th session of the World Heritage Committee (as document *WHC-04/28 COM/22*), but was not presented, due to time constraints. It is presented herewith with an updated information (changes are highlighted).

#### I. Background information

- 1. In 2001, the World Heritage Centre recommended that a new World Heritage Visual Identity be developed in an attempt to respond to a wide range of questions raised by users of the World Heritage Emblem, at the site level, and national and international levels. As a result, a draft User's Manual was proposed and discussed during the 25th session of the World Heritage Committee (Helsinki, December 2001), the 26th session of the Bureau of the World Heritage Committee (Paris, April 2002) and subsequently circulated to the Members of the Committee and other interested States Parties to allow for further consultations on this issue before a User's Manual could be finalised.
- 2. In 2002, the proposed World Heritage Visual Identity was re-examined by the Committee, which reached the following decision:

26 COM 15: The World Heritage Committee:

- 1. Invites the Director-General to take the necessary actions to ensure the legal protection of the World Heritage Emblem and "World Heritage" name and its derivatives;
- 2. Decides to postpone the discussion on the manual and its visual identity to its 27th session in June/July 2003.
- 3. The 27th session of the World Heritage Committee did not resume discussions on the manual but reiterated the need to report on requests made to the Centre for authorisations to use the World Heritage Emblem as well as the status granted or denied of these requests, in accordance with the *Guidelines and Principles for the Use of the World Heritage Emblem*, included in Annex 3 of the *Operational Guidelines for the Implementation of the World Heritage Convention*.

## II. Report on actions taken by the Director-General of UNESCO to protect the World Heritage Emblem

- 4. On 9 April 2003, following the invitation of the World Heritage Committee at its 26th session, the Director of the World Heritage Centre, on behalf of the Director-General of UNESCO addressed a letter to Mr Shozo Uemura, Deputy Director-General of the World Intellectual Property Organization (WIPO) to request the communication of the World Heritage Emblem, in pursuance of Article 6ter (1)(b) and (3)(b) of the Paris Convention for the Protection of Industrial Property (see Annex 2), for its protection to be made possible (see copy of letter in Annex 1).
- 5. A response was received by the Deputy Director-General of WIPO on 21 May 2003, confirming that UNESCO's request had been honoured

and, as a result, countries party to the Paris Convention as well as Members of the World Trade Organization (WTO), which are not bound by the said Convention, received circular letters from WIPO to present the name and emblem of the *World Heritage Convention* and request their protection under the Paris Convention (see Annex 3).

## III. Table of requests for authorisation to use the World Heritage Emblem and status of said requests as foreseen by the *Operational Guidelines for the Implementation of the World Heritage Convention*, Annex 3.

6. A table summarizing the requests made to the World Heritage Centre between 6 July 2003 and end August 2004, for the right to use the World Heritage Emblem has been developed (pages 3-14 of this document) in accordance with the Guidelines and Principles for the Use of the World Heritage Emblem (Annex 3 of the *Operational Guidelines for the Implementation of the World Heritage Convention*). The attached table will also include information pertaining to the date of request, the person or entity having made the request, whether the permission to use the World Heritage Emblem was granted or not, and any other relevant comments to each request. For ease of reference the requests have been classified in chronological order. In addition, the requests denied by the World Heritage Centre have been highlighted in bold.

#### IV. Draft decision

#### Draft Decision 7 EXT.COM 14

The World Heritage Committee,

- 1. <u>Notes</u> with appreciation that the World Heritage Emblem has successfully been registered under Article 6ter of the Paris Convention for the Protection of Industrial Property;
- 2. <u>Recalls</u> the segment entitled "Responsibilities of States Parties" of the Guidelines and Principles for the Use of the World Heritage Emblem as follows:

States Parties to the Convention should take all possible measures to prevent the use of the Emblem in their respective countries by any group or for any purpose not explicitly recognized by the Committee. States Parties are encouraged to make full use of national legislation including Trade Mark Laws;

3. <u>Takes note</u> of the Annual Report on the use of the World Heritage Emblem.

#### GENERAL INFORMATION ON ARTICLE 6ter OF THE PARIS CONVENTION

- 1. Article 6ter of the Paris Convention for the Protection of Industrial Property of 1883 (1967 Stockholm Act) was introduced into the Paris Convention by the Revision Conference of the Hague in 1925. It underwent some minor modifications, as to form, at the Revision Conference of London in 1934, and was more thoroughly revised by the Revision Conference of Lisbon in 1958.
- 2. The purpose of Article 6ter is to protect armorial bearings, flags and other State emblems of the States party to the Paris Convention as well as official signs and hallmarks indicating control and warranty adopted by them.
- 3. This protection was extended to armorial bearings, flags, other emblems, abbreviations and names of international intergovernmental organizations by the Revision Conference of Lisbon in 1958.
- 4. Any emblem or other official sign mentioned in paragraphs 2 and 3 above for which a State party to the Paris Convention wishes to obtain protection has to be communicated to the International Bureau of WIPO, which will then transmit the communication to the other States party to the Paris Convention. Nevertheless, such a communication is not obligatory in respect of flags of States.
- 5. Any States receiving the communication of an emblem or other official sign may, within a period of twelve months from the receipt of that communication, transmit its objections, if any, through the intermediary of the International Bureau, to the State or international intergovernmental organization at the request of which the communication was made.
- 6. The protection offered by Article 6ter to any emblem or other official signs mentioned in paragraphs 2 and 3 above, communicated as indicated in paragraph 4, and which has not been the subject of an objection as indicated in paragraph 5, is not of a general nature. The purpose of Article 6ter is only to prohibit the registration and use of trademarks which are identical to, or present a certain similarity with the above-mentioned emblems or official signs.
- 7. Article 6ter is only applicable to trademarks and does not oblige States party to the Paris Convention to refuse or to invalidate the registration, and to prohibit use of State emblems or other official signs as a service mark or as an element of a service mark. States are nevertheless free to do so, and under Article 16 of the Trademark Law Treaty (TLT), member States of that Treaty are obliged to extend protection to service marks.
- 8. The list of the items which can be the subject of a communication under Article 6ter of the Paris Convention, at the request of a State party to that Convention comprises: armorial bearings, flags and other State emblems, as

- well as official signs and hallmarks indicating control and warranty adopted by the State itself. The expression "other State emblems" is rather vague. It is generally understood as referring to any emblems constituting the symbol of the sovereignty of a State. A State emblem frequently contains heraldic elements, such as a lion, an eagle, the sun.
- 9. It is to be noted that the intention of the Revision Conference of the Hague, in 1925, was to include in the protection of State emblems the escutcheons of reigning Houses, as well as emblems of States included in a Federative State which is party to the Paris Convention. However, it was not intended to include emblems of lower public bodies.
- 10. The purpose of official signs and hallmarks indicating control and warranty is to certify that a State or an organization duly appointed by a State to that effect has checked that certain goods meet specific standards or have a given level of quality. Official signs and hallmarks indicating control and warranty exist in several States with respect to precious metals or products such as butter, cheese, meat, electrical equipment, etc. In principle, official signs and hallmarks indicating control and warranty may also apply to services, for instance those relating to education, tourism, etc.
- 11. The protection as an official sign indicating control and warranty is more limited than a protection as a State emblem. Article 6*ter*(2) provides that such protection "shall apply solely in cases where the marks in which they are incorporated are intended to be used on goods of the same or similar kind." Under Article 16 of the TLT, this provision extends to services.
- 12. The protection afforded by Article 6ter was extended by the Revision Conference of Lisbon in 1958, not only to armorial bearings, flags and other emblems, but also to names, and abbreviations of such names of intergovernmental organizations of which one or more States party to the Paris Convention are members. However, the protection under Article 6ter did not extend to armorial bearings, flags, other emblems, but also to names, and abbreviations of such names of intergovernmental organizations which are already the subject of international agreements in force, intended to ensure their protection, such as the Geneva Convention for the amelioration of the condition of the wounded and sick in armed forces, of August 12, 1946, Article 44 of which protects the emblems of the Red Cross on a white ground, the words "Red Cross" or Geneva Cross, and analogous emblems."
- 13. States party to the Paris Convention are free not to grant protection to armorial bearings, flags, other emblems, abbreviations and names of international intergovernmental organizations to the prejudice of the owners of rights acquired in good faith before the entry into force, in that State, of the Paris Convention.
- 14. States party to the Paris Convention are also free not to grant protection where the use or registration of a trademark against which the protection is invoked does not suggest a connection with the intergovernmental organization concerned, or where such use or registration is probably not of such a nature

- to mislead the public as to the existence of a connection between the user and the organization.
- 15. A distinction has to be made between, on the one hand, flags of States and, on the other hand, State emblems other than flags, official signs and hallmarks, and emblems, including flags, names and abbreviations of intergovernmental organizations. In the case of the first category, the protection under this provision will apply only to marks registered after November 6, 1925, that is, the date of the signature of the text of the Convention as revised at The Hague. In the case of the second category, the protection will apply only to marks registered more than two months after receipt of the communication made by the International Bureau of WIPO.
- 16. A general exception is made in cases of bad faith, where the member States even have the right to annul marks incorporating State emblems, signs and hallmarks, which were registered before November 6, 1925. Bad faith will probably be held to exist if the trademark has been registered in the knowledge that it incorporated the emblem, sign or hallmark concerned.

The International Bureau of the World Intellectual Property Organization (WIPO) presents its compliments to the Ministry of Foreign Affairs and has the honor to communicate herewith, pursuant to Article 6ter(3)(b) of the Paris Convention for the Protection of Industrial Property, as revised at Lisbon on October 31, 1958 (Lisbon Act), and at Stockholm on July 14, 1967 (Stockholm Act), a reproduction of the "Convention Concerning the Protection of the World Cultural and Natural Heritage," for which protection is requested under the said Article 6ter.

This communication is being sent to all member countries of the Paris Union for the Protection of Industrial Property, including those which are not yet bound by the Lisbon or Stockholm Acts. It is understood that only the countries bound by the latter two Acts are obliged, under the Paris Convention, to afford protection to armorial bearings, flags and other emblems, abbreviations and names of intergovernmental organizations. However, member countries of the Paris Union not bound by those Acts may be in a position, in this particular case, to afford the same protection, or may be willing to do so, in accordance with their national legislation and independently of any treaty obligation.

As regards the countries party to the Paris Convention that are Members of the World Trade Organization (WTO), the present communication also constitutes the communication under the Agreement on Trade-Related Aspects of Intellectual Property Rights (TRIPS Agreement) referred to in Article 3(1) of the Agreement Between WIPO and the WTO of December 22, 1995. It is recalled that the countries bound, under the TRIPS Agreement, to comply with the provisions of Article 6ter of the Paris Convention (Stockholm Act of 1967) are obliged to afford protection to armorial bearings, flags and other emblems, abbreviations and names of intergovernmental organizations, whether or not they are bound by Articles 1 to 12 of the Stockholm Act of 1967 of the Paris Convention.
