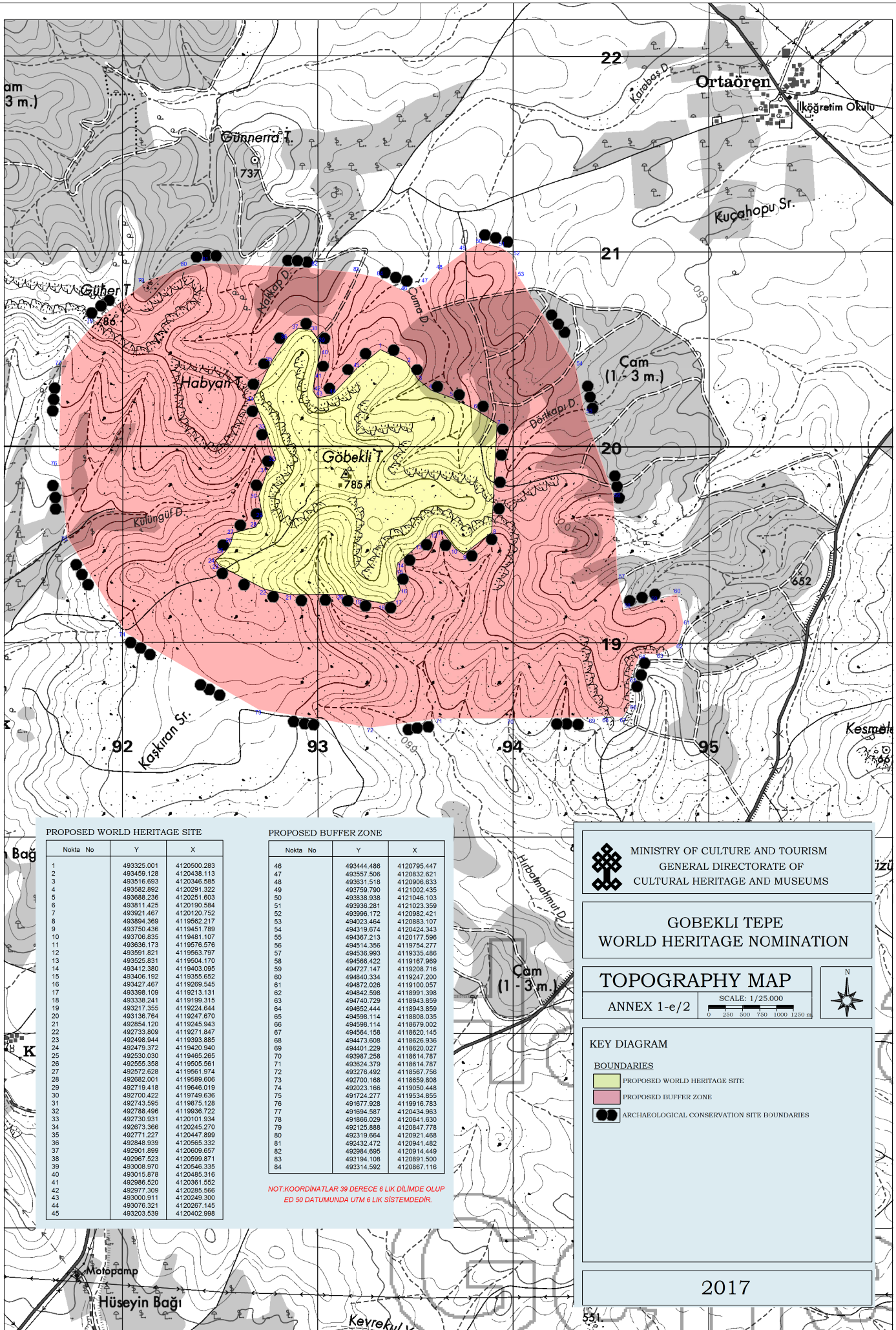


KEY DIAGRAM

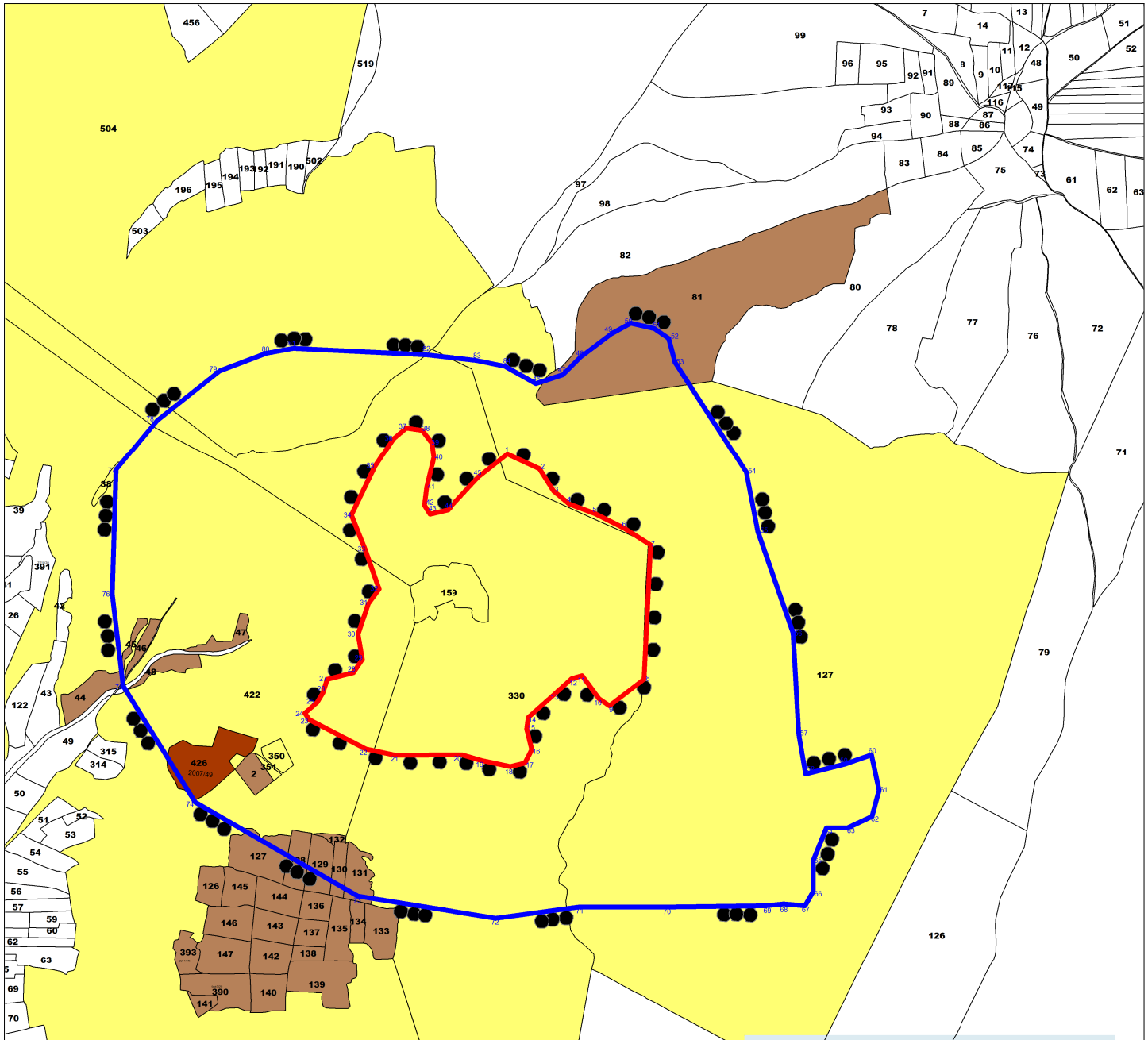

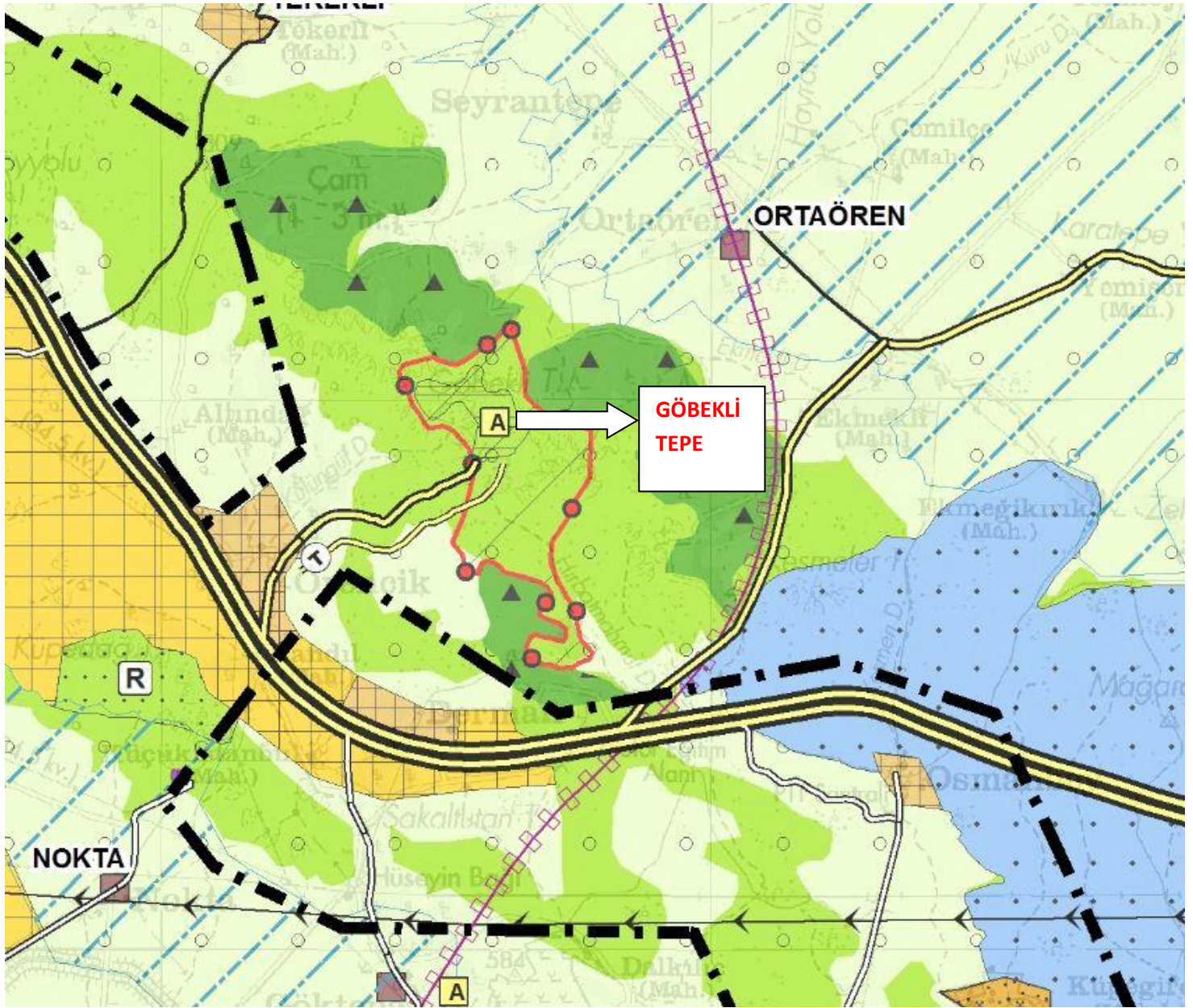
Ownership Map of Göbekli Tepe
