#### **KÁTIA BOGÉA**

*President of the National Historic and Artistic Heritage Institute (IPHAN)*

President of IPHAN. Graduated as an historian from the Federal University of Maranhão with a postgraduate degree in Brazilian and regional historiography from the University of São Paulo, Mrs. Kátia Bogéa has been working exclusively since 1979 with cultural heritage activities. She joined the National Historic and Artistic Heritage Institute (IPHAN) as an intern in 1980, at the then recently created office in the state of Maranhão, where she dedicated her professional career to the research of local heritage and to the preservation and protection of the Historic Center of São Luis and Alcântara. As an IPHAN civil servant, she has carried out research for the protection of several Brazilian heritage properties. Throughout her career, Mrs. Bogéa has been part of a team that carried out the National Inventory of Moveable Heritage and Artwork in 45 municipalities in the state of Maranhão. From 2003 to 2015, she held the position of Superintendent of IPHAN in Maranhão, managing a variety of tangible and intangible heritage properties and manifestations, including the Historic Centre of São Luis, inscribed on the World Heritage List in 1997. In June 2016, Mrs. Bogéa was nominated chairperson of IPHAN and has been in charge of the development and coordination of public policies related to heritage preservation and conservation in Brazil. In this capacity, Mrs. Bogéa has strengthened partnerships with UNESCO, national and international development agencies and municipalities all over the country. At the World Heritage Committee, she intends to act as a spokesperson for other developing countries, advocating for the improvement of cultural heritage management practices and methods.

#### **BRAULIO FERREIRA DE SOUZA DIAS**

*Associate professor of ecology at the University of Brasília*

Associate professor of ecology at the University of Brasília since 1982, where he lectures and supervises MSc and PhD students. He was Research Leader and Division Chief of the Ecological Research Station of the Brazilian Institute of Geography and Statistics (IBGE), where he worked from 1978 till 2011. He has previously held various positions in the Ministry of the Environment since 1991, including Research Director of the Brazilian Institute of the Environment and Renewable Natural Resources (IBAMA), Director for Biodiversity Conservation at the Ministry of the Environment and lastly National Secretary for Biodiversity and Forests in Brazil's Ministry of the Environment from September 2010 till February 2012. From February 2012 till February 2017 he was the Executive Secretary of the UN Convention on Biological Diversity. Outside of the government he has been a member and president of the NGO Pro-Nature Foundation (FUNATURA) and has coordinated the establishment of the Brazilian Fund for Biodiversity - FUNBIO, where he later represented the Ministry of the Environment in its governing council. A graduate of the University of Brasilia (Bachelor in Biological Science) with a PhD in Zoology from Edinburgh University (1981), Braulio has published extensively and has been an active member of several national committees and councils dealing with biodiversity, most notably the Brazilian National Biodiversity Committee

(CONABIO) which he coordinated between 2003 and 2011, the Brazilian National Council for Genetic Resources Administration (CGEN), which he established and coordinated in 2002 and again in 2010 and 2011, the Brazilian National Technical Committee for Biosafety (CTNBio), where he represented the Ministry of the Environment from 1999 to 2001, and a member of the Governing Council of the National Environment Fund (FNMA). Since 1994 and till 2011 he has coordinated the Brazilian National Biodiversity Program, the National Biodiversity Project I and II (with GEF/World Bank support), the Brazilian National Biodiversity Strategy Project (with GEF/UNDP support), and the elaboration of the first four Brazilian National Biological Diversity Reports to the CBD. Braulio has been strongly involved with the Convention on Biological Diversity (CBD) since its negotiations. Between 1994 and 2011 he was the Brazilian National Focal Point for the Subsidiary Body for Scientific, Technical and Technological Advice (SBSTTA), having been a member of its Steering Bureau from 1994 to 1996. From 1996 till 2011 was also the Brazilian National Focal Point for the Clearing-House Mechanism (CHM) of the CBD. He has taken active leadership in the development of CBD's Clearing-House Mechanism, the Agricultural Biological Diversity Work Program, the International Initiative for the Conservation and Sustainable Use of Pollinators, the Global Strategy for Plant Conservation, the Global Framework of Targets and Indicators for 2010, the Business and the 2010 Biodiversity Challenge initiative and the Biodiversity for Food and Nutrition initiative. He has been a member of several Liaison Groups and Ad Hoc Technical Expert Groups established by the CBD Secretariat on biodiversity indicators, on forest biodiversity and on climate change and biodiversity relationships. He has also been involved in other global biodiversity initiatives such as the Global Biodiversity Assessment (GBA/UNEP), as a member of its Editorial Committee, a member of the Advisory Committee of the DIVERSITAS Program, a vice-president of the International Union of Biological Sciences (IUBS) and a member of the Scientific and Technical Advisory Panel (STAP/UNEP) of the Global Environment Facility (GEF).

### **MARCELO BRITO**

***Director of the Cooperation and Promotion Department - IPHAN***

Architect and urban planner graduated from the Federal University of Pernambuco, Mr. Marcelo Brito is a specialist in public management, heritage restoration and cultural cooperation. He holds a PhD degree in urban management from the Polytechnic University of Catalonia and has postdoctoral research carried out at Universidad Complutense de Madrid, where he developed a project on "Heritage, Tourism and Development". He began his professional life in Olinda, Pernambuco, at the Foundation Center for the Preservation of Historical Sites in Olinda (FCPSHO), participating in the formulation of the Olinda Pilot Project aimed at restoring and revitalizing its historic sites. Working at the National Historic and Artistic Heritage Institute (IPHAN) since 1987, he has held several technical and managerial functions in the field of preservation of Brazilian cultural heritage. Among them, he has acted as Planning Advisor, as IPHAN Superintendent for the Midwest Region, as the National Coordinator of the Urbis Program in the Intangible Heritage Department and as International Relations Advisor. In 2016, Mr. Brito was appointed Director for Cooperation and Promotion, leading the department responsible for the national and international cooperation and promotion of IPHAN. He has been working on strengthening actions for conservation, development and promotion of cultural heritage, as well as expanding the educational and public awareness actions related to Brazilian cultural heritage.

**ADAM JAYME MUNIZ**

*Director for International Affairs, Ministry of Culture*

Mr. Adam Jayme Muniz is a Brazilian diplomat currently heading the International Affairs Department in the Ministry of Culture. He holds a bachelor's degree in International Relations from the University of Brasilia (2004) and a master's degree in Diplomacy from the Rio Branco Institute(2007), the Brazilian diplomatic academy. He started his career abroad as Deputy Permanent Representative of Brazil to the United Nations Environment Programme in Nairobi, where he worked on international environmental governance reform and biodiversity-related conventions synergies. From 2010 to 2014, he held the position of Desk Officer for Culture at the Permanent Delegation of Brazil to UNESCO in Paris. In this period, he was a member of the World Heritage Committee, the Intangible Cultural Heritage Committee and the Diversity of Cultural Expressions Committee. He took part of in various international expert and statutory meetings worldwide, having contributed to the reflection on the future and the effective implementation of the UNESCO Cultural Conventions. He was also involved with the inscription of four Brazilian properties on World Heritage List, as well as six Brazilian elements on the Intangible Cultural Heritage Convention's Lists. In his most recent posting overseas, Mr. Muniz was Cultural Attaché of Brazil in Beirut. Born and raised in Brasilia, he speaks Portuguese, English, French, Spanish and has some knowledge of Arabic. If elected to the Committee, he intends to collaboratively improve the implementation of natural and cultural heritage conservation strategies in the developing countries.

Mr. Leonardo Martins Prudente holds a bachelor's degree in International Relations from the University of Brasilia (2002), a postgraduate degree in Human Development from the Pontifical Catholic University of Minas Gerais (2007), a postgraduate degree in Social Protection from the Pontifical Catholic University of Chile (2014) and a master's degree in Administration from University of Brasilia (2013).
