b	as well as <b>on actions that are foreseen for the future</b> , to preserve the values described in the statement of significance under item II.2.	<p><b>The monument's painting were cleaned and restored in the 1970's by a Spanish team of professionals, This resulted in the recovery of this important artistic site which had fallen into a state of oblivion due to the effects of smoke and dirt which had accumulated on its surface. Following these works, an excavation and urgent architectural restoration program was carried out solving some of the monument's most serious problems. Unfortunately, not all of the works foreseen could be completed, nor could the restoration of the paintings be finished.</b></p> <p><b>In 1996, a new team of Spanish technicians had initiated a new phase of restoration. Several problems currently affect the paintings: ageing of some of the products used in the previous restoration, the accumulation of new dirt, the detachment of the mortar at the base of the wall, serious problems due to humidity, the filtration of salts, graffiti, soil produced by birds and insects, etc. The work carried out to date has allowed for the evaluation of the requirements as well as intervention procedures, and it is hoped that it will be continued in the future, It has also been foreseen that certain aspects of architectural restoration be developed, such as the repositioning of the exterior plastering of the vaults, the replacement of windows and doors, the substitution of the banister used to protect the paintings, which currently does not prevent visitors from touching the wall, etc.</b></p>	000
