The draft of a new Law on National Heritage Conservation which should replace the existing Act No. 20 of 1987 Coll. has been finalized by the Czech Ministry of Culture. This proposal takes in account the World Heritage and defines principles and mechanisms in relation to it.

On 20 July 2011 the government of the Czech Republic approved the "Concept of monument care in the Czech Republic for 2011-2016". The concept is based on a joint general conceptual material of the resort called "State Culture Policy", and it also follows up on conceptual materials about protection of other elements of cultural heritage, i.e. the "Concept of more effective care of movable cultural heritage in the Czech Republic for 2010-2014", which was acknowledged by the government of the Czech Republic on 1 December 2010, and the "Concept of more effective care of traditional folk culture in the Czech Republic for 2011 – 2015", which was approved by the government of the Czech Republic on 5 January 2011.

The material is divided into two main parts. Firstly, it analyzes outputs of monument care in the previous years and in the second part it proposes relevant precautions. The proposal part stresses mainly the necessity for legislative changes in the monument care domain, putting great emphasis on improving the descriptive qualities of the Central Register of Cultural Monuments established by the law and simplifying and improving the quality of performance of the public administration in monument care sector. The concept reflects the current trends of electronization of state administration and digitization of analogue data, including documentation registers.

The whole territory of the estate was declared a conservation zone by the Ministry of Culture by Decree No. 484/1992 Coll., on the declaration of the Lednice-Valtice area in south Moravia the conservation zone and the conditions were provided for for ensuring the protection and care for the monuments value of the zone.

The National Natural Conservation Area the Ponds of Lednice declared according to law No. 114/1992 Coll., on the protection of the nature and landscape. The declaration was performed by the Decree of MŠVU No. 49.004/52 (January 9, 1953), reviewed by Decree of the Ministry of Culture of the Czech Republic ref.No.14.200 / 88 (November 29, 1998)

The Regulation of the District National Committee in Břeclav of September 27, 1990 and the Regulation of the Ministry of the Environment of the Czech Republic No. 395/1992 Coll., of June 11, 1992 on the establishment of the national natural monument Pastvisko u Lednice

The Decision of the District National Committee in Břeclav of October 4, 1961 ref.No. škol.-457/2-1961 and Decree of the Ministry of the Environment of the Czech Republic No. 395/1992 Coll., of June 11, 1992 on the establishment of the National Natural Conservation Area Slanisko u Nesytu The Decree of the Ministry of Culture of ČSR ref.No. 5790 of March 19, 1976 on the establishment of the protected landscape area Pálava and UNESCO Decree of June 16, 1986 on the establishment of the Biospheric Conservation Area Pálava

The National Natural Conservation Area the Ponds of Lednice is included into the List of Internationally Significant Wetlands within the framework of the Convention on Wetlands of International Significance, first of all, as biotopes of water birds (the Ramsar Convention) according to Collection of laws No. 396/1990 Announcement of the Federal Ministry of Foreign Affairs according to the international convention. The protocol has been valid since July 2, 1990.

Approved development plans:

Development plan of Lednice of February 15,1996; the changes and amendments were approved on December 4, 1997

Development plan of Valtice of November 26, 1997; the changes and amendments were approved in 2000 and in 2005.

Development plan if Úvaly of June 25, 1998; the change was approved in 2005.

The development plan of the large territorial whole of the district of Břeclav was approved in 1998.

### Comment

MaB (Man and the Biosphere), an intergovernmental programme carried out under the auspices of UNESCO, provided a basis for the establishment of the Lower Morava Biosphere Reserve in 2003 in line with the Seville Strategy. By the Ministry of Culture of the Czech Republic No. 16417 /87 -VI / 1 of 21 December 1987 was declared a Břeclav-Pohansko Archaeological Reserve.

Although all the most important elements that are necessary to express the outstanding universal value of the property are situated within its boundaries, it is necessary to protect the key places of the vistas outside its boundaries. For this reason and because of the distance of the town of Břeclav and other villages, a delimitation of a buffer zone could be proposed in the future to prevent the degradation of visual integrity of the property.

Significant monuments made accessible for the public, the chateau of Lednice with the park and the chateau of Valtice with the park, are the property of the state, under the management of the National Institute for the Protection and Conservation of Monuments and Sites, the territorial professional place of work in Brno. Other salets are under the management of the Masaryk Agricultural and Forestry University, the Faculty of Gardening in Lednice. A number of other buildings and areas are in the ownership of private subjects.

Responsible for the protection of the natural values is the Management of the Protected Landscape Area and of the

#### Biospheric Conservation Area Pálava.

According to law No. 20/87 Coll., on the state monuments care and the relevant regulations, charged with the performance of the state monuments care is the Municipal Authority in Břeclav.
