Sehr geehrte Damen und Herren!

Auf diesem Wege wird im Hinblick auf den Beschluss 43 Com 7A.45 des Welterbekomitees (Baku 2019) der "Desired State of Conservation Report" für die Weltkulturerbestätte "Historisches Zentrum Wien" übermittelt. Bezug genommen wird auf jene Themen, die kompetenzmäßig die Stadt bzw. das Land Wien betreffen.

Vor dem Hintergrund der Entscheidungen des Welterbekomitees (Bonn 2015, Istanbul 2016, Krakau 2017, Bahrain 2018, Baku 2019) wurden auf Initiative der Stadt Wien Gespräche mit dem Eigentümer und Projektentwickler der Liegenschaft Heumarkt-Eislaufverein geführt.

Ausgangssituation für diese Gespräche ist, dass mit dem Beschluss des Flächenwidmungs- und Bebauungsplans durch den Wiener Gemeinderat (parlamentarische Versammlung der Stadt Wien) im Juni 2017 zunächst eine verordnungsrechtliche Basis für jenes Projekt hergestellt wurde, welches Gegenstand der Begutachtung der Joint High Level Unesco World Centre Icomos Advisory Mission (November 2018) und des Heritage Impact Assessment (Februar 2019) war. Von dieser Rechtsgrundlage ausgehend ist es dem Eigentümer möglich, um eine Baubewilligung für das oben genannte Projekt anzusuchen. Es sei darauf hingewiesen, dass derzeit auf einer rechtlich übergeordneten Instanz geprüft wird, ob unter Umständen eine Bewilligungsverfahren vorausgehende Prüfung (Umweltverträglichkeitsprüfung-UVP) erforderlich ist.

Ergebnis der Gespräche zwischen der Stadt Wien und dem Eigentümer ist, dass es nun seitens des Eigentümers die Zusage gibt, eine alternative Systemlösung auszuarbeiten. Dies unter der Voraussetzung, dass die UNESCO und ICOMOS der inhaltlichen Richtung der Bemühungen für einen alternativen Lösungsansatz grundsätzlich zustimmen.

Diese alternative Systemlösung sieht folgende wesentliche Änderungen gegenüber dem zuvor zitierten Ursprungsprojekt vor:



- Der Hochhausturm von 66,3 Meter soll im Sinne der Entscheidungen des Welterbekomitees NICHT umgesetzt werden. Der Hochhausturm war bekanntlich der primäre Grund, dass die Welterbestätte in der 41. Sitzung des Komitees (Juli 2017, Krakau) als gefährdete Welterbestätte gelistet wurde.
- Für das Hotel- und Kongressgebäude, welches das bestehende Gebäude aus den 1960er Jahren ersetzen soll, wird eine Erhöhung gegenüber dem derzeit bestehenden Gebäude nicht ausgeschlossen. Hierbei gilt es sämtliche technische Aufbauten (Aufzugsschächte, Stiegenhäuser, Be- und Entlüftungsanlagen, etc.) in die Gebäudestruktur integriert werden würden. Damit soll eine einheitliche, harmonische Silhouette der Dachlandschaft und eine wesentliche Verbesserung gegenüber dem jetzigen Zustand (niedrigeres Gebäude, jedoch mit zahlreichen Aufbauten) garantiert werden.
- Der Eislaufplatz bleibt in diesem Alternativprojekt in seinem vollen Umfang erhalten. Ebenso werden die Maßnahmen zur Aufwertung der öffentlichen Räume so wie im ursprünglichen Projekt großteils umgesetzt.
- Im Sinne der Sustainable Development Goals (SDGs) der Vereinten Nationen (UN) soll in der Detailplanung der Focus auf die Ausführung eines "Green Buildings" gelegt werden.

Im Zuge von bilateralen Gesprächen zwischen Herrn Landtagspräsidenten Ernst Woller als politischer Vertreter des Wiener Bürgermeisters und Vizebürgermeisterin mit VertreterInnen des UNESCO-Welterbezentrums und ICOMOS International zeigte sich in einer ersten Reaktion, dass vor allem der Verzicht auf die Realisierung des 66,3 Meter hohen Hochhauses - eine wesentliche Forderung von UNESCO und ICOMOS - als positive Entwicklung gesehen wird.

Eine konkrete Positionierung von UNESCO und ICOMOS im Vorfeld zur finalen Entscheidung durch das Welterbekomitee in dessen 44. Sitzung in China im Juli 2020 zu diesen Überlegungen ist von großer Bedeutung.

Auf Basis einer positiven Entscheidung seitens der UNESCO und ICOMOS zu dieser Kompromisslösung kann ein Alternativprojekt ausgearbeitet und die notwendigen Verfahrensschritte gesetzt werden.

Basierend auf den Entscheidungen des Welterbekomitees wurde außerdem mit der Entwicklung des Managementplans für die Welterbestätte begonnen. Die konkret in den Komiteeentscheidungen angeführten Empfehlungen sind Gegenstand der fachlichen und politischen Diskussion und werden nach Möglichkeit in den Managementplan integriert. In den Entwicklungsprozess sind neben ICOMOS Österreich, der State Party weitere internationale ExpertInnen in Fragen des Welterbemanagements und VertreterInnen der Zivilgesellschaft eingebunden. Selbstredend ist beabsichtigt, in weiterer Folge das Welterbezentrum und ICOMOS International einzubinden. Der



Managementplan selbst soll nach Fertigstellung zur politischen Beschlussfassung dem Wiener Gemeinderat vorgelegt werden.

Abschließend ist festzuhalten, dass mit den zuvor angeführten Bemühungen unterstrichen werden soll, wie bedeutend es für Wien ist, von der Liste der gefährdeten Welterbestätte genommen zu werden. Denn die Stadt Wien ist sich der Verantwortung für den sorgsamen Umgang mit der Weltkulturerbestätte "Historisches Zentrum von Wien" im Sinne der Welterbekonvention bewusst.

Dear Madam, Dear Sir,

With a view to Decision 43 Com 7A.45 of the World Heritage Committee (Baku 2019), the "Desired State of Conservation Report" for the World Heritage property "Historic Centre of Vienna" is submitted together with the present letter. It makes reference to the issues lying within the respective areas of competence of the City of Vienna and the Federal Province of Vienna.

Against the background of the decisions of the World Heritage Committee (Bonn 2015, Istanbul 2016, Krakow 2017, Bahrain 2018, Baku 2019), talks were conducted with the owner and project developer for the Heumarkt-Vienna Ice-Skating Club property on an initiative of the City of Vienna.

The talks started from the fact that the adoption of the zoning and urban development plan by the Vienna City Council (the parliamentary assembly of the City of Vienna) in June 2017 created a preliminary regulatory basis for the project which had been the object of inspection by the Joint High Level UNESCO World Heritage Centre/ICOMOS Advisory Mission (November 2018) and the Heritage Impact Assessment (February 2019). Starting from this legal basis, the owner is entitled to apply for a building permit for the abovementioned project. It should be noted that an evaluation by a superordinate legal body is currently being conducted to establish whether another assessment (environmental impact assessment – EIA) might be necessary.

The talks conducted between the City of Vienna and the owner resulted in a commitment on the part of the owner to develop an alternative systemic solution on the condition that UNESCO and



ICOMOS principally agree to the fundamental orientation of the efforts for an alternative solution proposal.

This alternative systemic solution provides for the following significant modifications as compared to the abovementioned original project:

- In accordance with the decisions of the World Heritage Committee, the **high-rise** with a height of 66.3 metres is **NOT** to be built. As is generally known, the high-rise was the primary reason for the World Heritage property being listed as a World Heritage property in danger on the occasion of the 41st session of the Committee (July 2017, Krakow).
- With regard to the planned hotel and convention centre building, which is to replace the
 existing edifice dating from the 1960s, an increase in height as compared to the current
 building is not excluded, in which case all technical installations (lift shafts, stairwells,
 ventilation and air-conditioning systems, etc.) would be integrated into the building
 structure. This is to ensure a uniform, harmonious rooftop silhouette as well as a significant
 improvement over the status quo (lower building, but with numerous rooftop
 superstructures).
- In this alternative project, the ice-skating rink will be fully preserved. Likewise, the measures
 for upgrading the public spaces will be largely implemented as provided for in the original
 project.
- In accordance with the Sustainable Development Goals (SDGs) of the United Nations (UN), the detailed planning will focus on the creation of a "green building".

In the course of bilateral talks between Mr. Ernst Woller, First President of the Vienna Provincial Parliament, as the political representative of the Mayor of Vienna as well as the Deputy Mayor of Vienna with representatives of the UNESCO World Heritage Centre and ICOMOS International, a first reaction showed that above all the decision not to build the 66.3-metre high-rise – a key demand of UNESCO and ICOMOS – is regarded as a positive development.

A concrete position of UNESCO and ICOMOS in the run-up to the final decision by the World Heritage Committee at its 44^{th} session to be held in China in July 2020 regarding these considerations is of great importance.

On the basis of a positive decision by UNESCO and ICOMOS regarding this compromise solution, it will be possible to develop an alternative project and take the necessary procedural steps.

Based on the decisions of the World Heritage Committee, the development of a management plan for the World Heritage property was moreover initiated. The concrete recommendations specified in



the Committee decisions are the subject of technical and political discussions and will be integrated into the management plan as far as possible. In addition to ICOMOS Austria and the State Party, the development process involves further international experts in the field of World Heritage management as well as representatives of civil society. It goes without saying that it is planned to involve the World Heritage Committee and ICOMOS International in due course. After completion, the management plan is to be submitted to the Vienna City Council for a political decision procedure.

Finally, it should be noted that the measures specified above are to emphasise the great importance attached by Vienna to being struck from the List of World Heritage in Danger. The City of Vienna is in fact highly aware of its responsibility for dealing with the World Heritage property "Historic Centre of Vienna" with care and in accordance with the tenets of the World Heritage Convention.

Executive Summary

Austria welcomes and fully supports the Decision by the World Heritage Committee adopted at its 43rd session 2019. We are happy to report about a constant progress in the implementation of measures to meet the requests and recommendations stated by the World Heritage Committee and its Advisory Bodies.

The without a doubt most important progress is that, according to information by the City of Vienna, the projected residential tower on the Heumarkt – Ice Skating Club – Vienna Concert Hall area shall not be realised. Therewith the strongest visual threat for the overall appearance of the World Heritage property can be avoided. As reported by the City of Vienna, "the high-rise with a height of 66, 3 meters is NOT to be built. As is generally known, the high-rise was the primary reason for the World Heritage property being listed as a World Heritage property in danger [...] With regard to the planned hotel and convention centre building, which is to replace the edifice dating from the 1960s, an increase in height as compared to the current building is not excluded." The final construction volume currently is object to negotiations and investigation. A visual study shall assess the final design and provide an analysis of the impact on the World Heritage property compared to the current project and against the backdrop of the results of the HIA and the Mission Report 2019. The process takes place in close consultation with representatives of UNESCO, the World Heritage Centre and ICOMOS International.

Further to this, the work on the requested new Management Plan is an ongoing process and an additional Heritage Impact Assessment shall review the development in Schwarzenberg Garden. The results of the latter shall be available by the end of 2020 at the latest. The Management Plan is scheduled for 2021.

An enhanced protection of World Heritage not only in Vienna but in all of Austria shall be guaranteed by new measures and actions established in the Government Programme. This program was released on occasion of the coalition agreement of the newly appointed federal government in January 2020. The anchoring of listed properties of the UNESCO World Heritage in the Austrian legal system, sustainable protection and preservation of cultural heritage and the commitment to the UNESCO Convention on Cultural Diversity and the safeguarding of Intangible Cultural Heritage are major focus areas in the Federal Cultural Policy in the next five years.

Finally, we wish to announce that a draft for a Desired State of Conservation at present is work in progress. We will provide the World Heritage Centre with the results as soon as possible.

- 1. Having examined Document WHC/19/43.COM/7A.Add,
- 2. Recalling Decision 42 COM 7A.5, adopted at its 42nd session (Manama, 2018);
- 3. <u>Welcomes</u> the three-stage process implemented by the State Party with the City of Vienna and <u>notes</u> the commitment of the State Party and of the city of Vienna to ensure the conservation of the Outstanding Universal Value (OUV) of the property, and consequently <u>urges</u> all parties to support and pursue:
 - 1. The proposed two year moratorium on all planning measures which may jeopardize the OUV of the property, especially the Heumarkt Neu project,
 - Actions to address the findings and recommendations of the Heritage Impact
 Assessment (HIA) for the Heumarkt Neu project, including negotiations with the
 developer to identify and implement mitigation measures which avoid adverse
 heritage impact,

Encourages the State Party to support and facilitate appropriate measures to manage and conserve the historic roof constructions in the Historic Centre of Vienna as an important attribute of the property, through appropriate extensions to the roof cadastre, a moratorium on rooftop conversions until appropriate tools and approvals processes are in place, and also requests that any such changes be referred to the World Heritage Centre for review by the Advisory Bodies in accordance with Paragraph 172 of the Operational Guidelines, prior to adoption and implementation;

Austria welcomes and fully supports the Decision by the World Heritage Committee as it proposes a reasonable timeframe to develop and implement measures to meet the most urgent recommendations stated in the Decision and by the 2018 Advisory Mission. Corrective measures and requested actions responding to the recommendations listed in para 1 to 3 as well as in sub items 1 to 6 / para 3 are already work in progress. Some of the action points will be completed in 2021, the timeframe determined for the elaboration of an alternative design for the "Heumarkt Neu" project.

Further to this important progress, there will be additional measures and regulations that shall not only enhance the safeguarding of the World Heritage property "Historic Centre of Vienna", but aim for an overall improvement in dealing with World Heritage in Austria. In reaction to the experience with the World Heritage Site "Historic Centre of Vienna" and to the findings of the above mentioned three-stage-process, the Austrian Federal Government pays special attention to a sustainable legislative reinforcement of Cultural Heritage in general and of UNESCO World Heritage in particular. The Government Programme³ released on occasion of the coalition agreement of the newly appointed Federal Government in January 2020 (Austrian People's Party and Green Party), includes the goal "Strengthening Austria's Art and Culture and making it more visible in the world". Specific measures to pursue this goal are:

- Development of an arts and culture strategy
- Legal anchoring of cultural heritage as an asset worthy of protection
- Sustainable protection and preservation of cultural heritage
- Commitment to the UNESCO Convention on Cultural Diversity and the Safeguarding of Intangible Cultural Heritage
- Anchoring of listed properties of the UNESCO World Heritage in the Austrian legal system
- Continuous development of the Federal Monuments Authority, strengthen its independence, align it to international standards and continue the reform process.

These goals and measures constitute a major working field in the framework of the Federal Arts and Culture Policies and shall be prepared and put into practice during the cycle of the current legislators' term. The main competence for the implementation of the Federal Arts and Culture Policies – and thus for the implementation of the World Heritage Convention - starting with 29th January 2020 lies in the hands of the State Secretary specifically assigned for this task within the Ministry for Arts, Culture, Civil Service and Sport.

Para 4

In response to this concern expressed by the World Heritage Committee, the City of Vienna started a broadly conceived process for the elaboration of a new Management Plan. With official note from 20th December 2019, the Manager of the World Heritage property reported the following: "Based on the decisions of the World Heritage Committee, the development of a management plan for the World Heritage property was initiated. The concrete recommendations specified in the Committee decisions are the subject of technical discussions and will be integrated into the management plan as far as possible. In addition to ICOMOS Austria and the State Party⁴, the development involves further international experts in the field of World Heritage management as well as representatives of civil society. It goes without saying that it is planned to involve the World Heritage Committee and ICOMOS International in due course. After completion, the management plan is to be submitted to the Vienna City council for a political decision procedure"⁵.

The elaboration of the Management plan currently is work in progress. The World Heritage Centre and ICOMOS International will be informed about the fundamental steps of the whole process. The final document shall be submitted to the World Heritage Centre after adoption by the Vienna City Council.

The City of Vienna noted that, "the measures specified are to emphasise the great importance attached by Vienna to being removed from the List of World Heritage in Danger. The City of Vienna is in fact highly aware of its responsibility for dealing with the World Heritage property 'Historic Centre of Vienna' with care and in accordance with the tenets of the World Heritage Convention." ⁶

Para 5

A draft for a Desired State of Conservation of the property at present is elaborated in cooperation between the City of Vienna, the Federal Ministry for Arts, Culture, Civil Service

and Sport, the Federal Monuments Authority, independent experts from the team working on the management plan, the Austrian UNESCO Commission, ICOMOS and the World Heritage Centre. The results of the Three-Stage-Process and the findings of the Missions 2012, 2015 and 2019 together with the related Committee Decisions shall form the basis for the elaboration of the DSOC and the (partly already set about) related corrective measures to attain it. Starting point for any consideration shall remain the State of Conservation as defined at the time of inscription against the backdrop of the developments that caused conflicts with the world heritage status as well as of the ones, which improved the condition of the property. The draft shall be submitted to the World Heritage Centre as soon as possible.

Para 6

In response to the request by the World Heritage Committee, the Austrian Federal Monuments Authority, in cooperation with the City of Vienna, will extend the Roof Cadastre. The addendum shall enclose iron-construction-works and pay particular attention to the area of the "Ringstraße". The findings of the Roof Cadastre in its entirety shall also form part of the future management system to be implemented according to the new management plan.

The schedule for the completion of the addendum to the Roof Cadastre shall be defined in the course of the first half of the year 2020. The Austrian Federal Monuments Authority currently prepares the existing Roof Cadastre for publication to make it available not only for the local experts and authorities but also for a wider public.

Para 7

The **Wien Museum** closed for the public from February 2020 onwards. Currently preparation work for restauration and transformation take place. During archaeological surveys of the area in December 2019, parts of the historic basements of the 1:1 façade mock-up by Otto Wagner in 1909 were excavated.

The basement of a former shopping hall was already excavated in October 2019. The halls were demolished back in 1934.

An interdisciplinary experts-team from the Technical University Vienna and the University for Applied Art accompanies the survey. The archaeological finds bring about a comprehensive overview of the history of the area and form a solid scientific basis for the future design of the space in front of the Wien Museum as well as for the reshaping of the building itself.

Since January 2020, the museum is cleared from interior that is not part of the historic, protected furnishing. All parts and objects that are protected by law will be kept in place or stored and replaced. The old control centre, that cannot be used in the future, found a new home in the Federal Technical Museum Vienna. The complete process takes place under the supervision by the Federal Monuments Authority. The Wien Museum informs the public about the ongoing process via its website that is always kept up to date.

The final plans and designs for the reshaping of the Wien Museum are currently under elaboration and will be submitted to the World Heritage Centre as soon as possible.

At present, no definite plans exist for the development of the **Winterthur Building.** The cubic capacity and height-restriction as assessed by the Advisory Mission 2019 remain in place.

The "Belvedere Stöckl" (now "Stöckl im Park") opened for the public in December 2019. A HIA will review the actual impact of the project on the historic garden and the consequences for the overall World Heritage property. The HIA shall also encompass the development of the conservation works of the Schwarzenberg Palace and the development of its auxiliary buildings. The HIA will be carried out by order of the Federal Ministry for Art, Culture, Civil Service and Sports. Basis for the Terms of Reference are the results and recommendations of the report by the Advisory Mission 2019. The HIA shall be completed end of 2020 at the latest. It will be submitted to the World Heritage Centre and ICOMOS International for review and for presentation on the website of the World Heritage Centre.

Concluding we wish to thank the representatives of UNESCO, the World Heritage Centre, ICOMOS International and all the experts accompanying the current workflow for their support and advice. We hope to successfully continue the way towards the re-establishment of a State of Conservation that meets all needs of the World Heritage property.
