SUMMARY

This document contains a non-exhaustive overview of the results of activities undertaken by the World Heritage Centre and the results achieved in implementing the Decisions and Strategic Objectives of the World Heritage Committee since its 33rd session (Seville, 2009), and in particular on results of activities not otherwise covered in the working and information documents prepared for this session. Further details about all World Heritage Centre activities are available from the Secretariat.

I. <u>Results-based Report of the activities undertaken by the World Heritage</u> <u>Centre</u>

- 1. Following Decision **33 COM 5** (Seville, 2009), the Report of the Secretariat on its activities undertaken in the previous year in the regions, and in the field of communication, education and partnerships is results-based and put in a table format for easy reference. The overview presented therein is non-exhaustive, as a number of activities, the results of which are to be expected in the long term rather than immediately, are not included. Thematic programmes and initiatives are presented in document *WHC-10/34.COM/5F*.
- 2. The 33rd ordinary session of the World Heritage Committee was organized in Seville, Spain, from 22 to 30 June 2009.
- 3. An information meeting for the preparation of the 34th session is to be held on 14 June 2010 at UNESCO Headquarters, Paris.
- 4. The written Summary Records of the 33rd ordinary session will be distributed for review by Committee members prior to the 34th session. They will be accompanied by an audio verbatim recording version.

A. Results of the Implementation of the Convention

- 5. Following the ratification by Equatorial Guinea on 10 March 2010, the total number of States Parties to the *Convention* has increased to 187.
- 6. Thirteen new properties (11 cultural and 2 natural with one transboundary [the Wadden Sea submitted by Germany and the Netherlands]) were inscribed on the World Heritage List at the 33rd session of the World Heritage Committee (Seville, 2009), (including three from non-represented countries, two from under-represented regions and 4 from under-represented typologies). UNESCO's World Heritage List now numbers a total of 890 properties (689 cultural, 176 natural and 25 mixed properties) located in 148 States Parties.
- Extensions added onto properties already inscribed on the World Heritage List are the following: From the Great Saltworks of Salins-les-Bains to the Royal Saltworks of Arc-et-Senans, the production of open-pan salt (France), Levoča, Spišský Hrad and the Associated Cultural Monuments (Slovakia) and Tubbataha Reefs Natural Park (Philippines).
- 8. Three States Parties with no properties on the World Heritage List had their first property inscribed at the 33rd session: Burkina Faso, Cape Verde and Kyrgyzstan.
- 9. A total of 177 State of Conservation Reports, including 30 of properties on the List of World Heritage in Danger, were examined by the 33rd session of the Committee.
- 10. The number of properties currently inscribed on the List of World Heritage in Danger is 31 (15 cultural and 16 natural).

- 11. The Committee will examine 42 nominations for inscription on the World Heritage List during this session: 32 cultural properties, 8 natural and 2 mixed properties including three transnational sites, and ten extensions to properties already listed.
- 12. Since the 33rd session of the Committee, 32 States Parties have submitted new Tentative Lists or modified existing Lists. The number of new properties added to the Tentative Lists is 92.
- 13. National capacities for the management and conservation of properties have been strengthened through various conservation and training activities in Asia, Africa and the Caribbean, also involving women.
- 14. The World Heritage Centre has concluded 9 partnership agreements with the private sector, while another 5 are under discussion.
- 15. Cooperation with the six biodiversity related Conventions continued through the mechanism of the Biodiversity Liaison Group, a meeting of which was attended by the World Heritage Centre (9 April 2009, UNESCO Paris). The Centre is also working with the Natural Sciences Sector of UNESCO.
- 16. The World Heritage Centre participated at the fourth ordinary session of the Intergovernmental Committee of the Convention for the Safeguarding of the Intangible Cultural Heritage (28 September 2 October 2009) in Abu Dhabi, United Arab Emirates as well as at the Meeting of the Parties to the Second Protocol to the Hague Convention (23 25 November 2010, UNESCO Paris). Two meetings with the Secretariat of the Convention for the Protection of Underwater Heritage, 2001, were held on the issue of marine sites. (October 2009 and March 2010).

B. Additional requests by the World Heritage Committee

- 17. In its Decision 33 COM 5A, the World Heritage Committee requested the World Heritage Centre, in future reports on activities undertaken, to further strengthen the information and analysis available to States Parties by:
 - a) Retaining the current format to report activities and including an update on progress with implementing the Committee's decisions,
 - b) Describing the criteria by which the World Heritage Centre makes decisions as to which activities under the *Convention* it undertakes,
 - c) And including, on a discretionary basis, analysis of strategic issues and new directions;

Concerning point a), the World Heritage Centre is pleased to announce that all decisions taken by the Committee since the inception of the *Convention* are now registered in the database of decisions at the following web address: <u>http://whc.unesco.org/en/decisions</u>

Based on this tremendous effort, a tracking table of decisions (except decisions on nominations and state of conservation) adopted by the Committee at its 33rd

Concerning point b), the World Heritage Centre's activities are only motivated by Committee's decisions. Nevertheless some activities can be delayed in their implementation due to lack of financial and human resources.

Concerning point c) related to strategic issues, they are articulated around topics chosen within the framework of the forthcoming 40th anniversary and the reflection on the future of the *Convention*. These topics were deepened on the occasion of the different expert meetings organized lately:

- International Workshop on Advancing Sustainable Tourism at Natural and Cultural Heritage Sites, 26-29 September 2009, Mogao Caves, China;
- International Expert meeting on the inclusion of the Historic Urban Landscape, 7-11 December 2009, Rio de Janeiro, Brazil;
- International Expert meeting on serial nominations and properties, 25-27 February 2010, Ittingen, Switzerland;
- International "Experts meeting on the relationship between the World Heritage Convention, conservation and sustainable development", 29-31 March 2010, Paraty, Brazil;
- Expert meeting on "Upstream Processes to Nominations: Creative Approaches in the Nomination Process", 27-29 April 2010, Phuket, Thailand.

C. Audit of the World Heritage Centre

18. An audit of the World Heritage Centre was carried out in December 2009 by the UNESCO External Auditors within the framework of their 2009 programme. It covered the organization of the World Heritage Centre, its financial and human resources, its financial situation and the execution of its missions to implement the *World Heritage Convention* from 2007 to 2009. The audit included interviews with several Ambassadors, Permanent Delegates to UNESCO from States Parties on all five continents which are members of the World Heritage Committee or have been in recent years.
