SUMMARY

Decision **34 COM 5G** requests the World Heritage Centre to provide an annual report on the use of the World Heritage Emblem granted by the World Heritage Centre. This report, covering the period June 2010 – February 2011, is presented in the table provided in this document.

Report on the use of the World Heritage Emblem granted by the World Heritage Centre (April 2010 – February 2011)

The World Heritage Centre receives an average of 2-3 logo requests per week which sums up to more than 100 per year. Following the nature of the requests they are either handled directly by the World Heritage Centre, or forwarded to the Sector for External Relations and Public Information (ERI), National Commissions, other sectors, etc. The requests handled directly by the World Heritage Centre are:

- a) Requests from National Commissions, institutions, programmes, etc. asking for World Heritage Centre support for an activity or material (see table below).
- b) Requests from World Heritage sites for the specific World Heritage site logo to be included in their support materials and/or site specific events. From June 2010 to February 2011 the World Heritage Centre has created specific logos, sent them to the authorities and validated the supports where the logos are included **for 53 World Heritage sites**.

All requests granted and documented in this report require prior approvals of the countries concerned. Logo use granted directly by the National Commissions or the National focal points for the World Heritage Emblem are not included in the report (including all above mentioned site-specific requests which transit through the World Heritage Centre). This report does not reflect either the use of the UNESCO and/or WH logos in the context of contractual or partnership agreements as these uses are reflected in the partnership inventory (see WHC-11/35.COM/INF.5A).
