### I. Report by ICCROM on its World Heritage Activities 2010-2011

### **INTRODUCTION**

1. The following is a summary final report of activities prepared by ICCROM for the World Heritage Committee. It outlines major activities carried out in each area of service, in the period 1 January − 31 December 2010. ICCROM support to the Committee, during the period of this report, has been provided principally by Joseph King (ICCROM World Heritage Coordinator), Gamini Wijesuriya (Deputy World Heritage Coordinator), Zaki Aslan, Daijiro Kitagawa, Baba Keita, Valerie Magar and Elena Incerti Medici all under the direction of ICCROM Director-General, Mounir Bouchenaki. ICCROM professional staff, knowledgeable of regional issues, and members of the ICCROM network also contribute to support these activities. Unless otherwise indicated, the costs for items listed below are funded under the ICCROM Service Contract #4500096636 with the World Heritage Centre. Professional and administrative costs above the amount covered in the contract are borne by ICCROM. ICCROM estimates that the organization contributed approximately €130,000 in staff time to World Heritage activities above the amount for professional fees and administrative services provided in its World Heritage contract.

# INVOLVEMENT IN REVIEW OF REQUESTS FOR INTERNATIONAL ASSISTANCE AND RELATED MATTERS

4. From January to December 2010, ICCROM was invited to review 34 requests for international assistance. These reviews have been carried out by ICCROM staff knowledgeable in project areas, and ICCROM partners and network members. # Publication of the first Volume in the World Heritage Resource Manuals Series, Managing Disaster Risks for World Heritage

7. As part of the partnership with the World Heritage Centre and other Advisory Bodies, the first publication within the framework of the new series of World Heritage Manuals, *Managing Disaster Risks for World Heritage*, was published. ICCROM was the lead author on this publication. The publication date was 1 July 2010.

### **Workshop on Urban Conservation for World Heritage Properties**

8. From 22 – 29 April 2010 a Workshop on Urban Conservation for World Heritage Properties was held in Rome for 26 participants from 25 countries in all 5 UNESCO regions. The workshop was held within the framework of ICCROM's Built Heritage Course, with five additional participants invited to present cases studies related to specific World Heritage Urban sites. The workshop included lectures, discussions, a site visit to the World Heritage Property of Assisi, and group work on the five case study sites of Lamu, Kenya, Georgetown, Malaysia, Istanbul, Turkey, Zabid, Yemen, and Valparaiso, Chile.

12. ICCROM hosted a drafting group meeting to discuss the ongoing revision of the Global Training Strategy. Participants included representatives of the World Heritage Centre, Advisory Bodies, and the Swiss Government.

# Meeting on Category 2 Centres, UNESCO Chairs, and Other networks, Manama, Bahrain, 19 – 20 December 2010

13. ICCROM took part in a meeting of Category 2 Centres, UNESCO Chairs, and other capacity building networks. At the meeting, ICCROM presented a draft of the revised World Heritage Capacity Building Strategy for discussion and comment by the capacity building stakeholders present at the meeting. ICCROM was represented at the meeting my Mounir Bouchenaki and Joseph King. (Costs for this activity were covered through other sources.)

# Cooperation with the World Heritage Institute for Training and Research – Asia and Pacific – WHITR-AP (UNESCO Category 2 Centre)

14. In 2010, ICCROM collaborated with WHITR-AP on a Training Course on Management Planning for Cultural Heritage which took place in Shanghai, China from 13 – 24 September 2010. (Costs for this activity were covered through other sources.)

### **Cooperation with the Africa World Heritage Fund (UNESCO Category 2 Centre)**

15. From 15 – 19 November, ICCROM participated in the 2nd African World Heritage Fund World Heritage Nominations Training Programme. Gamini Wijesuriya represented ICCROM. (Costs for this activity were covered through other sources.)

### Cooperation with the World Heritage at Work Masters Programme (Torino, Italy)

16. In 2010, Joseph King lectured at the World Heritage at Work Masters Programme on the themes of "Introduction to the World Heritage Convention", "The International Context for Conservation", "Outstanding Universal Value", "Values, Significance, Authenticity, and Integrity", and "Post-Inscription Processes", Torino, Italy, 9 – 10 November 2010. (Costs for this activity were covered through other sources.)

# Cooperation with the Cultural Heritage Protection Cooperation, Asia/Pacific Cultural Centre for UNESCO (ACCU Nara Office)

17. In 2010, ICCROM cooperated with the ACCU Nara Office on the Training Course, Cultural Heritage Protection in the Asia /Pacific Region: Research, Analysis and Preservation of Archaeological Sites and Remains, from 7 September – 7 October 2010. ICCROM was represented by Gamini Wijesuriya from 7 – 10 September. ICCROM also participated in an international conference at the ACCU Nara from 27 – 30 January on the topic of Human Resources Development for Cultural Heritage Protection. ICCROM was represented at this conference by Mounir Bouchenaki. (Costs for this activity were covered through other sources.)

# Collaboration with the Government of Switzerland and IUCN on a Capacity Building Programme for World Heritage

18. Through a generous contribution of the Government of Switzerland, ICCROM and IUCN in collaboration with ICOMOS and the World Heritage Centre have undertaken activities within the first year of a three year programme on capacity building. The programme foresees six workshops in various regions of the world, a workshop on sustainable tourism, advice and evaluation of existing training programmes, publication and translation of key materials related to World Heritage, and the ongoing development of the World Heritage Capacity Building Strategy. In 2010, this programme carried out its first training activity in San Jose, Costa Rica from 1 – 10 May for the training of cultural and natural heritage experts in all aspects of World Heritage processes. In addition, the ongoing revision of the Global Training Strategy has been carried out in the framework of this programme. (Costs for this activity were covered through other sources.)

# COLLABORATION WITH THE WORLD HERITAGE CENTRE AND/OR STATES PARTIES FOR THE BENEFIT OF WORLD HERITAGE PROPERTIES (Travel and DSA for the following activities were covered through other sources.)

### II. Report by ICOMOS on its World Heritage Activities 2009-2010

# Thirty-fourth session of the World Heritage Committee (Brasilia, 25 July-3 August 2010)

- 21. The International Council on Monuments and Sites was represented at the 34th session of the World Heritage Committee (Brasilia, 25 July-3 August 2010). Its work at this session concerned the following:
  - The presentation of the evaluations of the Advisory Body for the nomination for inscription of cultural and mixed properties, extensions and requests for minor revisions:
  - 2. The presentation of statements of outstanding universal value notably those originating from the Arab States region;
  - 3. The presentation of monitoring reports on the state of conservation of properties inscribed on the World Heritge List, including reactive monitoring mission reports and the reflection on trends in the monitoring of the state of conservation. Furthermore, the Advisory Body responded to requests for information and/or technical advice from representatives of the World Heritage Committee or States Parties;
  - 4. The presentation of a thematic study, « Heritage sites of Astronomy and Archeoastronomy in the context of the UNESCO World Heritage Convention », in the Document Guidance on the Heritage Impact Assessments for Cultural World Heritage properties and Examination of Working Methods and Procedures of ICOMOS for the evaluation of cultural and mixed properties;
  - 5. Contribution to debates on agenda items concerning procedures and themes such as the revision of the *Guidelines for the Implementation of the Wortld Heritage Convention*, the reinforced monitoring mechanism, historic urban landscapes, proposals for serial transborder nominations for inscription, the Future of the World Heritage Convention;
  - 6. Contribution to the orientation session of the World Heritage Committee, 25 July 2010.

The International Council on Monuments and Sites was also called upon to participate in working group discussions that were held in concurrence with the plenary session, to meet with delegations of States Parties for the organization of future evaluation and monitoring missions as well as working with the World Heritage Centre and the other advisory bodies to facilitate the work of the World Heritage Committee.

#### Contractual aspects

22. Contract, No 4500111014, was signed on 30 July 2010 for an amount of 556535.00 Euros for the activities of the advisory body to the World Heritage Committee between July 2010 and February 2011.

A contract was also established in December 2009 concerning the preparation of a thematic study « Early Human Expansion and Innovation in the Pacific » and another in June 2010, for the preparation of a typology analysis on properties related to the Silk Roads.

#### **Evaluation of nominations for inscription to the World Heritage List**

23. For the 2011 cycle, beginning in March 2010 until June 2011, ICOMOS was called upon to evaluate 29 new cultural and mixed properties proposed for inscription, including one nomination for reinscription of a natural property based on cutural criteria.

Three of these concern nominations of mixed properties and one, the transborder nomination by two countries. The requests for nomination originate from 29 States Parties to the World Heritage Convention.

Expert missions were organized between July-October 2010 for these 29 properties which were sent to ICOMOS in March 2010, rigourously following the principles and procedures set outt in the *Guidelines for the Implementation of the World Heritage Convention*, in particular Section III.E and Annex 6.

For the evaluations, the ICOMOS International Scientific Committees were consulted and the National Committees were involved. Moreover, individual experts are consulted to provide an viewpoint regarding the outstanding universal value of all the properties concerned, their authenticity and integrity and their protection and management.

Written evaluations have been prepared and examined by the ICOMOS World Heritage Commission during a four-day meeting held from 2 to 5 December 2010. Additional documentation was requested from several States Parties before 31 January 2011. InMarch 2011, evaluation texts, approved by the Panel in December will be amended to take into account this additional documentation during the second meeting of the Commission. The evaluations shall be presented at the 35th session of the World Heritage Committee (Paris Headquarters, 19-29 June 2011).

ICOMOS also worked in cooperation with IUCN concerning the mixed properties and cultural landscapes, first and foremost participating in a teleconference with the Panel of the Advisory Body and in consultations regarding the natural elements of the cutural landscapes.

In February 2010, ICOMOS received the files of five properties referred back at earlier sessions of the World Heritage Committee and eleven requests for minor revisions for evaluation. These properties shall be examined in March 2011 at the second meeting of the ICOMOS World Heritage Commission and the evaluations shall be presented at the 35th session of the World Heritage Committee (Paris Headquarters, 19-29 June 2011).

In the framework of the project "Up-stream Processes", ICOMOS carried out research concerning properties identified following criteria established by the information meeting of November 2010 to elaborate a list of pilot projects. This research enabled the establishment of a list of pilot projects in consultation with the World Heritage Centre.

In March 2011, ICOMOS shall receive new nominations for inscription to be presented at the 36th session of the World Heritage Committee.

#### **Retrospective Statements of Outstanding Universal Value**

24. Revision work for the retrospective statements of outstanding universal value of World Heritage properties is associated with the second cycle of the periodic report and its regional timetable. In the second half of 2010, the Advisory Body examined 26 retrospective statements of outstanding universal value for the region of Africa which were dispatched to the World Heritage Centre in February-March 2011. As agreed upon with the World Heritage Centre, it also accorded priority to retropsective statements of the Arrab States that States

Parties had not submitted in 2010 and those of sites inscribed on the List of World Heritage in Danger. Work on the retrospective statements of other regions should be carried out in accordance with the timetable of the periodic report , as decided by the World Heritage Committee. In context, in March 2011, work on the 122 retrospective statements of the Asia-Pacific region should commence. The possibility of availability of extrabudgetary funds was broached by the World Heritage Centre for the Latin American and Caribbean region (81 statements). Confirmation would be useful so that the Advisory Body could take into account this additional task in its work timetable for 2011.

### Reports on the state of conservation of World Heritage properties

25. The World Heritage Centre regularly and throughout the year consults the Advisory Body on problems or threats that weigh on properties inscribed on the World Heritage List or on the Tentative Lists of the States Parties. Additional research was carried out, notably through the ICOMOS networks, documents studied abd written reports transmitted to the World Heritage Centre. These reports (desk reviews) concerned Vézelay, the Loire Valley, Le Havre (France), Tikal (Guatemala), Kathmandu (Nepal), Brussels (Belgium), Avila, Ségovia (Spain), Liverpool, (United Kingdom), Tallinn (Estonia), Jesuit Block and Estancias of Cordoba (Argentina), Wouda (Netherlands). Other reports are under preparation.

To date, ICOMOS has carried out 22 reactive monitoring missions requested by the World Heritge Committee at its 34th session. They concern joint missions with UNESCO. A few missions foreseen for before end 2010 were postponed until March and April 2011.

Furthermore, in reponse to a request from UNESCO, the Advisory Body participated in an advisory mission to Pompéi financed by the State Party.

On 1 February 2011, ICOMOS began report writing on 55 projects on the state of conservation of cultural and mixed properties and shall review the drafts of 58 projects to be presented at the 35th session of the World Heritage Committee.

### **Periodic Reports**

26. The International Council on Monuments and Sites participated in several regional meetings of the second cycle of periodic reporting for the Asia-Pacific region, the Africa region and Europe region. These meetings provided the opportunity to present the key concepts of the World Heritage Convention, the format of the questionnaire, to organise workshops attended by the managers of the properties and to respond to their professional and technical queries, as well as to questions regarding the retrospective statements of outstanding universal value. The clsoing meeting of the periodic report for Africa (Dôme de Vredefort, South Africa, 14-17 February 2011) enabled the Advisory Body to present an analysis of the data gathered during that exercise.

#### **Evaluation of international assistance requests**

27. ICOMOS examined 38 requests for international assistance (technical, preparatory, emergency, training) that had been submitted for technical evaluation and comment since June 2010. These assistance requests were studied and examined by the Panel on 15 September 2010 and on 17 January 2011. In the framework of this exercise, the Advisory Body responded to the requests of the States Partes regarding the availability of experts for the implementation of activities.

### Global Strategy and Thematic Studies

Preparation of documents and thematic studies:

29. The thematic study « Early Human Expansion and Innovation in the Pacific » was printed in December 2010 and made available to the World Heritage Centre. This is the second thematic study concerning the Pacific region and an additional step in the identification and long-term protection of significant sites and cultural landscapes in the region. It provides a global view of the first colonisation of the Pacific by man with the objective of providing comparative data to facilitate the selection of cultural properties for nomination to the World Heritage List.

The study on the theme « Silk Roads » which began last June proposes an anlysis of known sites along the silk roads as a basis for future comparative analyses, by comparing the proposed sites with similar sites along the silk roads. This study covers data from the States Parties.

The Advisory Body has begun work on a new thematic study "Water and Heritage". A progress report on this study shall be presented to the 35th session of the World Heritage Committee at UNESCO, Paris, in June 2011.

The thematic study « Rock Art in Central Asia » has been completed and is available as a bilingual publication, in Russian and English.

The Advisory Body is working in consultation with IUCN on a guide for the preparation of the desired state of conservation of properties inscribed on the List of World Heritage in Danger.

### Global Strategy training:

30. ICOMOS participated in global strategy training meetings organised by ICCROM. The last one was held in Rome from 8 to 11 December 2010 and prepared the World Heritage Capacity Building Strategy (2011) which shall be presented to the 35th session of the World Heritage Committee.

ICOMOS and ICCROM covered the cultural heritage component together with the participation of IUCN for the training workshop for a group of professionals aimed at technical assistance in support of the World Heritage Convention in Africa. This workshop, organized in Porto Novo in Benin (29 November-3 December 2010) with support from Switzerland, brought together professionals who work with the advisory bodies in their evaluation of the nominations for inscription and the monitoring of the state of conservation.

#### Thematic meetings:

31. ICOMOS was represented at several meetings relating to the development of the Global Strategy and, more generally to other aspectsof the World Heritage Convention. Among others, it was represented at the Working Group on the Revision of the *Operational Guidelines*, the Meeting on Up-stream Processes, the meeting on the Working Methods of the World Heritage Committee in Bahrain, and the joint meeting of the Category II Centres.

33. ICOMOS participated in the Advisory Body meetings (IUCN, ICCROM and ICOMOS) with the UNESCO World Heritage Centre, held on 16 and 17 September 2010 at IUCN Headquarters in Gland (Switzerland) and on 17-19 January 2011 at UNESCO Headquarters, Paris.

The programme includes a priority for work on World Heritage within Africa. Partnership within the World Heritage Agenda for Nature is being provided by the State Party of Switzerland, Korean Cultural Ministry, African World Heritage Fund and a number of other partners. IUCN would be pleased to provide information on this work, and any aspect of its global and regional programmes as required, and during the course of the 35th Session of the World Heritage Committee.
