The Kingston Action Plan

Recalling the spirit and the objectives of the 1972 World Heritage Convention,

Recalling the recommendations and decisions made at subsequent World Heritage Committee Sessions and regional meetings undertaken through the Global Strategy the related activities developed in the Caribbean,

Considering the commitment of and increasing amount of regional Governments to prepare and nominate sites with outstanding cultural and natural heritage values for inscription on the World Heritage List,

We, the participants* of the UNESCO Caribbean Training Course in the Preparation of Nomination Dossiers for World Heritage held in Kingston, Jamaica from 5-15 June 2012, with the support of the World Heritage Centre's Japan Funds-in-Trust project on "Capacity Building to Support the Conservation of World Heritage Sites and Enhance Sustainable Development of Local Communities in Small Island Developing States (SIDS)", and in line with the Caribbean Capacity Building Programme (CCBP), in respect of the follow-up training course being proposed for 2013, and of further steps aimed to strengthen the application of the World Heritage Convention in our Region, hereby,

Encourage UNESCO to:-

- Continue liaising with the State Parties, entities, and national offices in charge of
 cultural and natural heritage, the respective UNESCO National Commissions and the
 World Heritage Center as well as coordinating between the UNESCO Kingston and
 Havana Offices, in an effort to strengthen communication on heritage management,
 and endeavour to increase the heritage coeducation and outreach within the CCBP
 and other frameworks;
- Facilitate the planning and implementation of the follow-up training course;
- Involve representatives of IUCN and ICOMOS and other key relevant agencies in the follow-up training course;
- Circulate, for suggestions, a draft agenda for the follow-up training course, and ensure the inclusion of practical exercises, which respond to the State Parties' will, preferably regarding those sites included on their Tentative Lists;
- Follow-up systematically with the participants to ensure that the necessary steps are being taken to advance the various nomination dossiers;
- Facilitate communication among the participants and between the participants and UNESCO, with the assistance of the National Commissions;
- Recommend the inclusion of World Heritage matters and the action plan arising out

- Consider the preferred continuity of participation by attendees from this UNESCO Training Course held from 5-15 June 2012 when identifying potential participants for the follow-up training course.

Encourage State Parties to:-

- Continue prioritizing World Heritage Matters on national agendas;
- Continue promoting conserving and preserving of the cultural and natural heritage on their territories:
- Take the actions necessary for the effective implementation of the Convention in the Caribbean, refining, updating and/or elaborating Tentative Lists, facilitating the preparation of nomination dossiers, emphasizing risk preparedness, and involving local communities in heritage management;
- Support the preferred continuity of participation by attendees from this UNESCO Training Course held from 5-15 June 2012 in the follow-up training course;
- Commit to the heritage management process as reflected in the 1972 World Heritage Convention and in the Operational Guidelines for the Implementation of the Convention;
- Stimulate Antigua and Barbuda to advance the nomination of Nelson's Dockyard and submit same before February 2013;
- Stimulate Suriname to advance the nomination of Jodensavanne and Cassipora Cemetery and to submit same before February 2013;
- Stimulate Jamaica to advance the re-nomination of the Blue and John Crow Mountains and to re-submit same before February 2013;
- Prioritize inclusion of World Heritage matters at the upcoming meeting of the Regional Ministers of Culture, proposed for Suriname, from 6-7 September 2012; and
- Explore the possibility of serial and transboundary nominations between and among State Parties.

Encourage the Commonwealth of The Bahamas, the only Caribbean State Party who has not yet signed, to ratify the 1972 World Heritage Convention;
