Report on the Follow-up to Resolution 18 GA 8 on the Evaluation of the Global Strategy and PACT initiative

SUMMARY

The General Assembly, at its 17th session, requested the World Heritage Centre to submit to the General Assembly at its 18th session in 2011 the independent evaluation by UNESCO's external auditor on the implementation of the Global Strategy from its inception in 1994 to 2011 and the Partnerships for Conservation Initiative (PACT), which were provided in documents WHC-11/18.GA/8 and WHC-11/18.GA/INF.8.

By Resolution 18 GA 8 the General Assembly decided to establish an openended working group to examine the report of the External Auditor, in order to produce an implementation plan for the recommendations for consideration by the World Heritage Committee and to present a final report to the 19th session of the General Assembly. The open-ended working group met twice in May 2012 and February 2013 at UNESCO and provided detailed reports to the 36th (WHC-12/36.COM/9A) and 37th sessions (WHC-13/37.COM/INF.5D) of the World Committee. This and document provides a full report on the implementation of the recommendations of the Report of the External Auditor on the Global Strategy and the PACT initiative.

I. BACKGROUND

- 1. The General Assembly at its 17th session requested the World Heritage Centre to provide at its 18th session in 2011 "with a summary of the work undertaken in relation to the reflection on the future of the Convention, including an independent evaluation by UNESCO's external auditor on the implementation of the Global Strategy from its inception in 1994 to 2011 and the Partnerships for Conservation Initiative (PACT), based on indicators and approaches to be developed during the 34th and 35th sessions of the World Heritage Committee".
- 2. The Committee at its 35th session (UNESCO, 2011) with Decision 35 COM 9A requested the World Heritage Centre to transmit the independent evaluation by the UNESCO's External Auditor to the 18th session of the General Assembly (UNESCO, 2011) for examination. The General Assembly decided (Resolution 18 GA 8) to establish an open-ended working group including experts from the different geographic regions, whose composition would be determined by States Parties and depending significantly on extrabudgetary funds. This open-ended working group was requested to examine the report of the External Auditor, in order to produce an implementation plan for the recommendations for consideration by the World Heritage Committee and to present a final report to the 19th session of the General Assembly.
- 3. Resolution **18 GA 8** of the General Assembly invited UNESCO and the World Heritage Centre to implement the recommendations of the External Auditor concerning PACT, and notably to harmonize PACT with UNESCO's development of partnership strategies.
- 4. The General Assembly at its 18th session also invited "the World Heritage Centre, in close collaboration with the Advisory Bodies, to produce by 1 February 2012 a working document, which: a) proposes a prioritized list of recommendations in the framework of the objectives of the Strategic Action Plan, adopted in Resolution 18 GA 11, and considering Decisions 35 COM 12A to 35 COM 12E, b) indicates the financial implications, c) suggests the allocation of responsibility between States Parties, the General Assembly, the World Heritage Committee, the Advisory Bodies and the World Heritage Centre." This working document was dispatched by Circular Letters on 1 February 2012 and 24 April 2012 respectively.
- 5. The General Assembly also recommended that this open-ended working group meets "before the 36th session of the World Heritage Committee, in order to report to the Committee on the work undertaken".

II. IMPLEMENTATION OF THE GENERAL ASSEMBLY'S RESOLUTIONS

6. The open-ended working group met from 15 to 16 May 2012 at UNESCO. It elected Mr David D. Hamadziripi (Zimbabwe) as Chairperson, Ms Vera Lacoeuilhe (Saint Lucia) as Vice Chairperson and Ms Kristien Dubois (Belgium) as Rapporteur. The open-ended working group debated during 3 sessions the Implementation Plan for the recommendations of the external auditor on the Global Strategy which have been endorsed by the 18th General Assembly. The open-ended working group prepared an Implementation Plan which indicates how to implement the recommendation, by whom, by when and the costs or funding required. The group worked in order of priorities (from the highest priority to low priority), except where a clustered approach between different recommendations from different priorities was considered more useful. This methodology is reflected in the Implementation Plan, which was presented to the 36th session of the Committee. All documents of the open-ended working group, including the letters sent to all States Parties and

background information are posted on the World Heritage Centre website at http://whc.unesco.org/en/open-ended-working-group/.

- 7. The open-ended working group concluded its deliberations on the section on Global Strategy and decided to meet again prior to the 37th session of the World Heritage Committee to discuss the recommendations on the PACT Initiative.
- 8. The second meeting of the open-ended working group took place on 1 February 2013. Chaired by Mr David D. Hamadziripi (Zimbabwe) and with Ms Kristien Dubois (Belgium) as Rapporteur, the Working Group adopted an implementation plan for the recommendations of the External Auditor on the PACT Initiative.
- 9. Following Resolution 18 GA 8 of the General Assembly the World Heritage Centre's PACT work was harmonized with UNESCO's development of partnership strategies, notably the endorsement by the 190th session of the Executive Board of the umbrella statement of the "Policy Framework for Strategic Partnership: a comprehensive partnership strategy" and the accompanying "separate strategies for engagement with individual categories of partners".
- 10. Moreover, following Decision **36 COM 5A**, the Centre presented a revised PACT strategy to the 37th session of the Committee, taking into account the results of the evaluation of the External Auditor on the PACT Initiative, the Plan of Action proposed by the open-ended working group (OEWG) on the recommendations of the External Auditor concerning PACT and the decision adopted during the 190th Executive Board session regarding the UNESCO Framework for Strategic Partnerships. This Strategy was adoped by the 37th session of the World Heritage Committee.
- 11. The Implementation Plans for the Global Strategy (Section III) and PACT (Section IV) provided below in tabular format have been updated to include the status of implementation as of July 2013. The update of the Implementation Plan is based on the results of the process explained above in these phases:

- implementation of recommendations from the open-ended working group at the 36th session of the World Heritage Committee (see document WHC-12/36.COM/9A available at <u>http://whc.unesco.org/archive/2012/whc12-36com-9A-en.pdf</u>); The Decisions by the 36th session of the Committee (Saint Petersburg, 2012) are available at: http://whc.unesco.org/en/sessions/36COM;

- implementation of recommendations from the open-ended working group at the 37th session of the World Heritage Committee (see document WHC-13/37.COM/INF.5D available at <u>http://whc.unesco.org/archive/2013/whc13-</u> <u>37com-5Dinf-en.pdf</u>); The Decisions by the 37th session of the Committee (Phnom Penh, 2013) are available at: http://whc.unesco.org/en/sessions/37COM;

- a few recommendations have not been implemented and will go to the 38th session of the World Heritage Committee or will be further pursued by the States Parties, the Committee, the Secretariat and the Advisory Bodies as appropriate; these may also involve other bodies, such as the cooperation with other international Conventions;

The General Assembly,

- 1. <u>Having examined</u> Document WHC-13/19.GA/9,
- <u>Recalling</u> Decisions 35 COM 9A and 36 COM 9A adopted by the World Heritage Committee at its 35th (UNESCO, 2011) and 36th (Saint Petersburg, 2012) sessions respectively and Resolution 18 GA 8 of the 18th session of the General Assembly (UNESCO, 2011),
- 3. <u>Appreciates</u> the work of the open-ended working group on the Implementation Plan for the recommendations of the External Auditor on the Global Strategy and the PACT Initiative carried out in 2012 and 2013 and endorses its recommendations;
- <u>Notes</u> the implementation of a number of recommendations as indicated in the updated implementation plan and <u>further notes</u> that the World Heritage Committee at its 37th session decided not to implement requests concerning conflicts of interest related to its Rules of Procedures;
- 5. <u>Urges</u> the World Heritage Committee to continue implementing any pending requests in relation to its mandate;
- 6. <u>Welcomes</u> the efforts to link the follow-up to the Implementation Plan for the recommendations of the External Auditor on the Global Strategy and the PACT Initiative with the implementation on the Strategic Action Plan for the World Heritage Convention;
