

# State Party's Report on the State of Conservation of Historic Bridgetown and its Garrison

#### <u>Historic Bridgetown and its Garrison (Barbados) (C1376)</u>

In accordance with WHC-12/36. COM/7B and the Decision of the WHC 36 COM7B.95. The Government of Barbados submits its 2<sup>nd</sup> State of Conservation Report on the abovenamed property in compliance with the provisions of the decision adopted by the World Heritage Committee at its 36<sup>th</sup> session in St. Petersburg, June, 2012.

# 1.Response from the State Party to the World Heritage Committee's Decision are indicated paragraph by paragraph:

- 1. Having examined Document WHC-12/36.COM/7B,
- 2. Recalling Decision **35 COM 8B.42**, adopted at its 35th session (UNESCO, 2011)

#### **State Party GOB Response:**

These are so noted.

3. <u>Notes</u> that a programme for traditional building conservation is being planned; and <u>encourages</u> the State Party to ensure that this is directed by experts trained in traditional building conservation and that there is involvement from local tertiary institutions through the development of a national programme in collaboration with local or regional universities and technical institutions;

#### **State Party GOB Response:**

The Government of Barbados has conducted preliminary investigations as to the potential for the establishment of the traditional building conservation programme.

The Ministry of Culture, Sports and Youth had the opportunity to hold informal discussions with the US Parks and Service who had offered to provide training for the staff of the Ministry of Transport and Works and the National Conservation Commission on the rnaintenance of public spaces within the Property.

In February 2013, The Ministry of Culture, Sports and Youth convened a meeting to discuss the development of a basic course in Building Conservation and Traditional Craftsmanship. In attendance were representatives of tertiary level institutions and vocational institutions such as the Samuel Jackman Prescod Polytechnic, Barbados

Community College and the Vocational Training Board. Members of the architectural fraternity were in attendance as well as representatives from the Ministry of Housing and the Ministry's Consultant Conservator. Coming out of the meetings it was agreed that one of the first actions would be to develop a database of skilled persons in the areas of restoration in wood and stone on the island. A copy of the note of the meeting is attached as **Appendix 1.** 

4. Requests the State Party to provide further details of both programmes, including timelines and to submit this information to the World Heritage Centre;

#### **State Party GOB Response:**

A further outcome of the above-mentioned consultations included the, proposal for an introductory course in Conservation aimed at teachers who teach Carpentry, Masonry, Civil and Building Engineering and Architecture at the Samuel Jackman Prescod Polytechnic, Barbados Community College and the Vocational Training Board was developed and submitted to the World Heritage Centre for International Assistance in October 2013. It proposed a six (6) week course to commence in July 2014, and will expose approximately 16 teachers, *inter alia*, to: the proper handling of objects, use of materials and basic conservation theory and will include site visits to historic buildings within "Historic Bridgetown and its Garrison". The programme will be delivered by a number of competent professionals in the fields of Culture, Heritage and Conservation from the University of the West Indies and the Ministry's Consultant Conservator, who will be contracted to manage the programme. The expected outcomes of this training are:

- To train a core of teachers in basic conservation techniques and the maintenance of historic buildings;
- To increase awareness of the Outstanding Universal Value of the built heritage within the Property;
- To increase the knowledge of teachers in the use of materials to be used in the conservation process of historic properties and best practices in the management of historic properties;
- To make participants more aware of the importance of conservation of the built heritage as a marker of identity and employment potential;
- To develop a framework developed for further training.

The Ministry of Culture, Sports and Youth has developed a proposal entitled "Chattel House Restoration" which will seek to support the sustainability of the Outstanding Universal Value of Historic Bridgetown and its Garrison through the preservation of the traditional wooden Chattel House by restoring a group of those that lie within Historic Bridgetown and its Garrison. These houses were part of the land tenure system implemented after Apprenticeship in 1838 and were the homes of impoverished plantation workers. Many have been lost as a result of social mobility, lack of funds, lack of awareness and a lack of maintenance skills. Restoration of these houses over a period of five years will be done in collaboration with stakeholders and the business community. The project will be linked to the planned Conservation Programme and will serve as a teaching tool for students in tertiary institutions. The anticipated time frame for this activity is for commencement in 2015.

5. <u>Acknowledges</u> the intention of the State Party to appoint consultants to undertake a comprehensive technical assessment of twenty-one specified listed buildings, and <u>also encourages</u> the State Party to consider enlarging its scope to include non listed buildings within the property;

## State Party GOB Response:

The Town and Country Development Planning Office (TCDPO) in Barbados is responsible for ensuring the orderly and progressive development of land in both urban and rural areas, primarily through the provisions of The Town and Country Planning Act Cap 240, The Town and Country Planning Development Order 1972, as well as The Physical Development Plan Amended (2003). Under Section 29 of the Act, the Minister, through the Chief Town Planner is responsible for the compilation and maintenance of the "List of Buildings of Special Architectural or Historic Interest" (List of Listed Buildings) for the entire island. The List of said buildings is included in the Management Plan for Historic Bridgetown and its Garrison.

#### Technical Assessment of Specific Listed Buildings

The Government of Barbados (through the TCDPO) entered into a Memorandum of Understanding with the identified qualified consultant following submissions of proposals in July 2013, review of proposals and finalization of negotiations in October, 2013. The process of selection, scope of service, duration and services required are identified in detail in the Draft MOU attached at **Appendix 2**. In executing a comprehensive technical assessment of selected Listed Buildings within the World Heritage Property, the key objectives of the consultancy were articulated as follows:

- 1. To provide detailed multi-media information to support the maintenance of the List of Listed Buildings;
- 2. To support the development planning process with respect to listed buildings located within the world heritage property; and
- 3. To contribute to the sustainable management of the World Heritage Property.

Land owners and Stakeholders were informed of the commencement of this exercise through public service announcements and distribution of an information brochure, as well as the dissemination of correspondence to all landowner during the period prior to exercise. Phase One of this project has been completed with the measuring and documenting of eighteen (18) of the specified listed buildings. On satisfactory completion of this phase, the same consulting firm was subsequently appointed to carry out Phase Two of the Measuring and Documenting of Listed Buildings. This phase commenced in November 2013 and a further twenty (20) listed buildings have been identified to be measured and documented. Phase Two is scheduled to be completed in March 2014. (List of Buildings specified is indicated at **Appendix 3** of this Report).

The State Party continues to progress with the implementation of the Measuring and Documenting of Listed Buildings within the property and it is proposed that Phase Three of this activity should commence in September 2014.

## Enlarging the Scope of the Technical Assessment to include non-listed buildings

As part of the sustainable approach being taken to the management of the Property, it is necessary to undertake a comprehensive, technical assessment of the listed buildings contained therein to facilitate future planning and conservation measures affecting the Property. Of the 1,566 individually delineated properties within the Property, over 115 include listed buildings. As a result of a recent review of the List of Listed Buildings by the Chief Town Planner a recommendation has been made to amend the List to include the following additional 4 (four) structures within the Property. These include:

- a. Chamberlain Bridge
- b. St. Matthias Church
- c. St. Patrick's Roman Catholic Cathedral
- d. Woodside, Bay Street

While this initiative to enlarge the Scope of the Technical Assessment has not yet materialized, the above additions to the List once approved will have the potential effect of enlarging the Scope of the technical assessment since it is the intent of the Administration to achieve the detailed document of all Listed Buildings. It is anticipated that this process of enlargement will likely commence within the period 2014-2015.

6. <u>Also notes</u> that there is no confirmation that the Management Plan has been officially adopted or implemented, nor whether the necessary funding for its implementation has been put in place, and <u>also requests</u> the State Party to provide confirmation of these;

#### **State Party GOB Response:**

## Adoption and Implementation of Management Plan for the Property:

Decision 36 COM 7B.95 also noted that ... "there is no confirmation that the Management Plan has been officially adopted or implemented.....". The Cabinet of Barbados adopted the Management Plan in June 2011 (copy of the Cabinet decision is hereby attached at **Appendix 4**. Further reference is also made to the fact that correspondence to this effect was delivered by the Delegation of Barbados to the Director of the World Heritage Centre

during the course of the 36<sup>th</sup> Session of the World Heritage Committee in June 2012, however, it was indicated that this could not be taken into account at that time.

Following the inscription of Historic Bridgetown and its Garrison as a World Heritage Property on June 25, 2011, the Management Plan adopted by Cabinet called for the establishment of a national committee to manage and monitor the process. The Property is therefore managed by the Barbados World Heritage Committee (BWHC) which had in fact been established in July 01, 2010 under the chairmanship of the Chief Town Planner, (TCDPO).

During the period under review the Barbados World Heritage Committee met at regular intervals to report on, monitor and evaluate the progress made on the implementation of the Management Plan. A series of action plans had been developed under key thematic sectors for the purpose of creating a comprehensive enabling environment for the long-term sustainable management of the Property and the buffer zone as a World Heritage Property. The action plans are being spearheaded mainly by the members of the BWHC in conjunction with other key stakeholders. The plans under implementation are as follows:

- Action Plan for Protecting, Preserving and Enhancing Heritage
- Action Plan for Education, Capacity Building and Research
- Action Plan for Traffic Management
- Action Plan for Tourism Management
- Action Plan for Public Awareness
- Action Plan for Cultural and Heritage Interpretation
- Action Plan for Risk Management

The Committee is required to report to Cabinet on an annual basis regarding its progress in the execution of its responsibilities.

The Management Plan is used as a reference point on a regular basis when development proposals are submitted for sites within the property. Some of the policies outlined in National Physical Development Plan for the settlement and management of land use in Barbados has been incorporated where appropriate into the Management Plan. Therefore

land use related decisions are made and guided by strong principles of urban planning and to ensure that the Outstanding Universal Value of the property is not threatened nor diminished.

#### Confirmation of Funding for the Implementation of the Management Plan.

Financial support for the implementation of the Management Plan is facilitated at the national level through annual budgets provided in the annual Estimates of Expenditure. For the period 2011-2013, each Ministry and department that is a member of the Barbados World Heritage Committee, as well as other departments and NGOs with some measure of responsibility for the Property would have been provided with funding in the yearly estimates to implement the various components of the Management Plan. Through this budgetary process, funding was provided to the various agencies to maintain staffing, to conduct public education and awareness programmes, for conservation matters and to carry out required maintenance to buildings, monuments, gardens and public spaces with regard to enhancement, cleaning and the general maintenance of the Property.

It should be noted however that the BWHC has observed with concern the significant proportion of Listed Buildings within the Property which require serious levels of renovation, conservation or restoration. Action is required in order to ensure the maintenance of authenticity and integrity of the Property, and to bring them back into a reasonable standard capable of sustainable re-use. No specific provisions have as yet been put in place by Government to address these needs, as distinct from the individual commitments of Corporate or individual landowners.

However, the State Party has determined that as an important first step to planning a building restoration programme it provides funding for the Measuring and Documenting of Listed Buildings within the property through the provision of US\$100,000 in its Annual Estimates of Expenditure (2014-2015). A programme has been developed to request the support of private commercial entities owning Listed Buildings within the Property through voluntary financial contributions for the technical assessment of their own buildings.

In addition, The Cabinet of Barbados, on the recommendation of the Minister of Culture, Sports and Youth has appointed a Task Force for the Restoration of Barbados' Built Heritage to assist the Government of Barbados with identifying funding options and sources of funding for the restoration of the built heritage. The Task Force, styled "Team Restoration", makes recommendations to the Ministry of Culture, Sports and Youth on strategies for raising funds for the restoration of the built heritage in Barbados, with priority being given to those structures located within "Historic Bridgetown and its Garrison". The Task Force also liaises with private sector organizations and individuals to encourage them to make technical and/or financial contributions to these restoration projects. The Task Force and the Ministry of Culture, Sports and Youth are in the process of drafting terms of reference for the establishment of a Foundation that would be responsible for the funds that are raised.

7. <u>Further requests</u> the State Party to submit to the World Heritage Centre, by **February 1**, **2014**, an updated report on the state of conservation of the property and the implementation of the above, for examination by the World Heritage Committee at its 38th session in 2014.

#### **State Party GOB Response:**

The updated report above on the State of Conservation of the Property is submitted in compliance with this item.

# **2.Current Conservation Issues**

Approximately 100 planning applications for the erection, additions, renovations or subdivision within the property were submitted during the period under review. These applications were subjected to the evaluation process as set out at pages 79, 80 and 122 of the Management Plan under the supervision of the Chief Town Planner. The following major projects have been completed or are under review.

<u>Constitution River Development</u>: The State Party has undertaken a major initiative to assist in the revitalisation of Bridgetown. The State Party secured funding from the Caribbean Development Bank in the sum of US \$6.8 million to carry out major works to the Constitution River and to provide an urban garden which will function as a 'green lung' and

recreational area for the City. Phase three of the Constitution River project is proposed to commence during the current calendar year. The estimated cost is US \$8.4 million. This work falls under the supervision of the Barbados Tourism Investment Inc.

Revitalization of Bridgetown: The Barbados Chamber of Commerce and Industry, which is a member of the Barbados World Heritage Committee has secured grant funding in the amount of \$US150,000 from the Inter-American Development Bank to carry out a feasibility study to assist that agency with the advancement of its "Revitalisation of Bridgetown" programme.

<u>Church Village Re-development</u>: This site which lies on the eastern edge of Bridgetown has been re-developed at a cost of approximately US \$4.2 million to create a public space with an amphitheatre. The redevelopment was themed on the history which characterised the site.

<u>Church Village Archaeological Assessment</u>: Following the clearance of early – mid 20<sup>th</sup> century building stock at the site of Church Village, St. Michael within the Property, the Barbados Museum & Historical Society (BMHS) was commissioned by Barbados Tourism Investment Inc. to conduct an archaeological assessment at the site of this 19th century urban village.

The excavation was conducted between May to August 2012, prior to planning development as indicated above, with provision for an accompanying watching brief to be instituted during excavations and installation of the proposed gardens and landscape features. The site had in the past undergone significant development in the 1980s with the construction of a ten-storey building and attendant car park and ancillary buildings. The Town and Country Development Planning Office regulates development in the area. There are no scheduled monuments in the development area. The excavation was concerned with establishing the extent of the village environs; locating the main areas of habitation and recording the size of the housing units; and recovering any material culture that allows for an insight into the lifeways of the persons who lived there. Such a record allows insight into urban life not previously undertaken in Barbados.

A programme in public sensitization was developed by the Ministry of Culture, Sports and Youth in collaboration with UWI, the BMHS and the Ministry of Education under the theme "Heritage for Leadership" which trained principals to become champions and guardians of Barbados' educational heritage and to instill pride in schools about Barbadian heritage and guidance for students to enter heritage trades and professions. In 2013, the Ministry of Culture, Sports and Youth continued to focus on sensitization of schools and included a Conservation component in it's "heritage in the Classroom" project. In this programme the Principals of Government and private primary schools were sensitized about Historic Bridgetown and its Garrison and the importance of the Conservation in maintaining the integrity and authenticity of the built heritage. A copy of the report is attached as **Appendix 5**.

The Town Planning legislation is to be amended to include the World Heritage property to strengthen the protection for development within the property and the adjoining urban conservation areas. The proposed amendment to the legislation is scheduled to be discussed by the Cabinet Committee for Governance during the first quarter of the calendar year. Importantly, the amended legislation will significantly increase the penalty for the demolition or alteration to a listed building without the requisite planning permission.

The Ministry of Culture, Sports and Youth has coordinated the establishment of a local chapter of ICOMOS which comprises many of the key stakeholders in the heritage sector.

# 3. <u>Major restorations, alterations and/or new construction/s envisaged within the potential area (core zone (property) and buffer zone).</u>

# **Core Zone (Property)**

Empire Theatre: An application has been submitted to the Town and Country Development Planning Office seeking planning permission for the restoration of the Empire Theatre located in Bridgetown. The proposal seeks to restore the building and utilise it as a theatre and craft brewery. In 2013, the Cabinet of Barbados awarded a private company a contract

to restore the Empire Theatre for this purpose. The parties concerned will seek the guidance of the Barbados World Heritage Committee, The Task Force for Restoration of Built Heritage and the Barbados National Trust to ensure that the restoration of the structure is historically accurate and conservation appropriate to maintain the authenticity and integrity of the Property and that the Outstanding Universal Value of the property is not threatened nor diminished.

Night Lighting at Garrison Savannah: The Garrison Savannah has been the home of horse racing for in excess of two hundred years. The Barbados Turf Club, the current administrators of horse racing in Barbados submitted an application to erect light poles on the Savannah in order to facilitate the introduction of night racing. The application is under assessment and the Heritage Impact Assessment undertaken for this project is under review.

<u>Marina Development</u>: A proposal for a marina and land based tourism development in Carlisle Bay and along the Bay Street Corridor is currently under review. The planning agency is awaiting the submission of a Heritage Impact Assessment.

<u>Public Market and Bus Terminal</u>: An application has been submitted to the Town and Country Development Planning Office for the development of a public market and bus terminal within the city's core. The proposal is being assessed and will be subject to all necessary due diligence to ensure that the redevelopment has-no negative impact on the authenticity and integrity of the Property.

#### **Buffer Zone**

Bridgetown Port Development: The Bridgetown Port is located along the westernmost boundary of the buffer zone and functions as the lone commercial and cruise port for the State Party. In an effort to further enhance economic growth and the quality of life of its citizens, the State Party will be undertaking the comprehensive re-development of the port linkage area as envisaged by the Physical Development Plan Amended (2003).

The planning application is under review and all environmental studies have been conducted.

The State Party will ensure that no decision is made that might have a negative impact on the authenticity and integrity as well as the Outstanding Universal Value of the property.

# NOTE OF MEETING TO DISCUSS CAPACITY BUILDING IN CONSERVATION AND PRESERVATION HELD FEBRUARY 12, 2013 IN THE CONFERENCE ROOM OF THE DIVISION OF CULTURE AND SPORTS

1. Ms. Johnson informed that the meeting had been convened to bring stakeholders together to brainstorm about the development of a formal maintenance and conservation programme to help preserve the built heritage, particularly in Historic Bridgetown and its Garrison. She added that this objective was in keeping with the directives of the World Heritage Centre and was needed since Barbados was not in the practice of doing maintenance on its buildings and as a result had lost many of its iconic buildings.

#### **Issues discussed and Decisions Taken:**

#### **Report on Measuring and Documentation**

- 2. Ms. Pilgrim was asked to provide a brief report of the work being undertaken by Mr. Michael Lashley who was contracted to measure and document 18 listed buildings. Ms. Pilgrim outlined that the objective was to create a catalogue of the 18 buildings that would report on their condition along with their social and architectural histories. It would contain an engineer's report and recommendations from the architect on how the buildings could be used in the future. The 18 buildings would include:
  - a) Parliament Building
  - b) Old Eye Ward
  - c) Old Supreme Court
  - d) Martineau House
  - e) Jazz Club
  - f) Round House
  - g) Queen Park House
  - h) The Carnegie Building (the public Library)
  - i) St. Mary's Church
  - j) Paul's Church
  - k) Block B and C of the Garrison
- 3. Mr. Jardine queried if the final document would be made available to the public and Ms. Johnson responded that she would make that recommendation to the Barbados World Heritage Committee.

#### A Programme in Conservation

- 4. Ms. Johnson spoke about the shortage of trained conservators in Barbados in the areas of stone, metal, paper and wood. She noted Ms. Parris' presence who is trained in metal conservation. She informed that there is no programme in stone conservation but that the National Art Gallery has a conservation and maintenance programme for national statues and paintings and went on to explain that conservators are brought into Barbados from Puerto Rico to carry out work on a regular basis.
- 5. It was generally agreed that a formal programme in conservation and maintenance is needed.

- 6. Mr. Jardine stated that Government needs to show commitment to the maintenance of historic buildings and recommended that a unit be established to deal solely with these buildings.
- 7. The representatives from SJPP, BCC, TVET and BVTB indicated that there is scope for the inclusion of some aspect of conservation into their various programmes. Ms. Browne indicated that BCC has an architectural programme and was of the opinion that the inclusion of some element of conservation would give students more hands-on training, forcing them to investigate; and this hopefully would lead to more of them becoming interested in conservation.
- 8. It was recommended that a lab would be required to examine the various building materials. Ms. Browne indicated that BCC conducts similar exercises in one of its courses. She recommended that a project could be developed in collaboration with the Division of Culture and Sports in which final year students could assist in the restoration of a building.
- 9. Ms. Parris stated that ideally what is needed is a facility where parts of or an entire building could be investigated and preserved. Mr. Cadogan stated that there may be space at the SJPP for the creation of a lab for students but advised that appropriate funding would be required.
- 10. The representatives from BVTB and the SJPP indicated that many of the basic skills were taught at their institutions but in terms of specialised skills in conservation and preservation, a curriculum would have to be developed and expertise sought to train their instructors.
- 11. It was noted that there is a dearth of skills in line plaster, rubble stone, iron monger, fretwork and antique furniture restoration.
- 12. Mr. Walcott from BVTB stated that his agency would be open to having students work alongside these craftmen as part of a job attachment programme.

# **Involvement of the Community**

13. It was agreed by all attendees that the involvement of the community was one of the most necessary steps especially as it relates to getting Barbadians to "own" the property and to accept and share their history. Ms. Pilgrim added that people need to see the benefit of having the inscription and added that ways needed to be found to outline the monetary and prestige benefits. Ms. Johnson informed of the proposed programmes to be undertaken to address this issue.

#### Creation of a Database

14. It was decided that a database of expertise available in the island should be compiled so that the practitioners will be known and their skills utilised to aid with the development of training courses at institutions across the island. Mr. Cadogan spoke of

the possibility of having these craftmen address the students at SJPP in a workshop setting. Mr. Jardine stated that this interaction would be essential so that the local peculiarities and knowledge of our architectural heritage could be passed down to the younger generation. It was suggested that an apprenticeship system could be established.

- 15. The attendees were asked by Ms. Johnson to submit the names of any craft persons they knew who could be included in the database.
- 16. Mr. Smith raised the issue of the availability of building plans for the old buildings and stated that these would go a long way towards marrying old construction styles with present day ones.
- 17. It was agreed that there needed to be a distinction between preservation, restoration and adaptive reuse.
- 18. Ms Parris recommended that there was a need to address the issue of Preventative Conservation.

#### **Action to Be Taken**

- 1. The persons attending the meeting were asked to submit names of craft persons to be added to the database.
- 2. Culture to confirm a date for a presentation at the students at BCC and SJPP.
- 3. Database to be compiled of craft persons in the related fields.

#### WHEREAS

1. The Government of Barbados and Michael C. #### **SCOPE OF SERVICE**

- 9.2 Verify the locations of the selected Listed Buildings within the inscribed Property.
- 9.3 Execute background research on the selected properties including but not limited to historical information, ownership, address and contact details of owners, land area and plot coverage.
- 9.4 Carry out consultations with the property owners of the selected listed buildings.
- 9.5 Provide a comprehensive, technical assessment of the special architectural and or historical features (internal and external) of the selected listed buildings which are located within the inscribed site. With regards to each of the structures, the technical assessment is to include but not be limited to:
  - a. At least four (4) photographs illustrating the external appearance (front, sides and rear) of the properties;

- b. Property measurement and drafting inclusive of site, floor and elevation plans;
- c. Analysis of the site and property (including an assessment of the features and architectural details based on historical, architectural and planning characteristics, principles and standards) as well as the state of conservation of the property (enhanced by additional photographs as necessary); and
- d. General recommendations regarding future conservation or restorative work.
- 10. The consultant confirms availability of proposed key staff.
- 11. Michael C. Lashley Architects Limited will provide all the services set out in the Terms of Reference.

#### **DURATION OF CONSULTANCY**

12. The entire consultancy is expected to be completed within six (6) months.

#### SERVICES PROVIDED BY GOVERNMENT

- 13. For the purposes of the Consultancy, the TCDPO shall provide the following:

#### AVAILABILITY OF CONSULTANTS

15. In the event that any of the technical personnel proposed for the consultancy has to be substituted for any reason; the name, qualification and experience of any replacement must be submitted to and agreed by the Government prior to the replacement taking up the substituted staffing position. Substitute staff must be of equal or higher qualification and experience to be considered as an acceptable replacement.

#### REPORTS AND DELIVERABLES

# An Inception Report and Initial Work Plan

- 16. This report is due within five (5) working days as agreed in the Memorandum of Understanding and should provide a calendar of activities undertaken since the project commencement date and a detailed work programme and schedule of activities to be undertaken for the duration of the project. The work plan will specify the methodologies to be employed in pursuit of satisfying the various objectives and the expected output from each activity, noting the need to be GIS compatible where appropriate; and outline limitations to the conduct of the Consultancy and any risks to the delivery of outputs/deliverables.
- 16.1 A digital copy and three (3) hard copies (formatted in Microsoft Word) of the Draft Inception Report should be submitted.
- 16.2 The Consultant shall prepare and submit to the TCDPO for review, comment and approval a Final Inception Report incorporating comments from the TCDPO on the Draft Inception Report. The final Inception Report should be submitted within three (3) working days of the receipt of comments from TCDPO

or any extension of time to the consultant as determined by the Chief Town Planner.

- 16.3 A digital copy and three (3) hard copies (formatted in Microsoft Word) of the Final Inception Report should be submitted.
- 16.4 Michael C. Lashley Architects Limited will submit for review, comments and approval a **Mid-term Technical Report** to the Employer within **six** (6) weeks of the date of the commencement of the project, or of the receipt of approval of the Final Inception Report including:
  - a) A Background Report of the completed document review process incorporating a comprehensive assessment of key information contained in the documents which have been reviewed.
  - b) An assessment of the research methodologies employed and the consultative process undertaken with property owners;
  - c) A summary presentation and analysis of the data collected to date together with all relevant technical information and appendices;
  - d) A status of the consultancy and an indication of the outstanding activities.
- 16.5 One (1) electronic and three (3) hard copies of the Mid-Term Technical Report should be submitted based on the agreed presentation format outlined in the approved Final Inception Report.
- 16.6 Michael C. Lashley Architects Limited will submit the **Draft Final Technical Assessment Report** within **five (5) months** after the date of contract signature. The Consultant shall submit the draft final report in text format. The report should comprehensively address all the terms of reference of the study and should be fully formatted and illustrated. They should present detailed findings, conclusions and recommendations and should be prepared and presented to the same standard expected of a final document.
- 16.7 One (1) electronic and three (3) hard copies of the Draft Final Technical Assessment Report should be submitted based on the agreed presentation format, noting the need for Geographical Information System (GIS) compatibility.

16.8 Michael C Lashley Architects Limited will submit the **Final Report** in both text and digital formats, incorporating comments, observations and recommendations made by the Chief Town Planner, the Prime Minister's Office and other government agencies on the **draft final report**, within ten (10) working days of the date of receipt of the comments and approval by the TCDPO.

The report shall also provide inter alia:

- a. A comprehensive, multi-media, technical assessment of the selected listed buildings within the inscribed Property.
- b. A critical review of the process undertaken to execute the scope of works and achieve the deliverables and results; and
- c. An identification of key lessons learned and recommendations.
- 16.9 One (1) electronic and three (3) hard copies of the **Final Technical** Assessment Report shall be submitted based on the agreed presentation format, noting the need for GIS compatibility.
- 17. The Town Country Development Planning Office shall respond to all reports submitted by the Consultant no later than three (3) weeks after receipt of same.
- 18. In all cases one (1) electronic and three (3) copies of each report should be submitted based on the agreed presentation format, noting the need for Geographical Information System (GIS) compatibility.

19. The payment of fees shall be based on deliverables as follows:

#### **OWNERSHIP OF MATERIALS**

21. All materials billed for by the Consultant will become the property of the Government of Barbados and shall not be reproduced without the expressed written permission of the Town and Country Development Planning Office.

#### **CONFIDENTIALITY**

22. The Consultant is bound to treat all information made privy to it as a result of this consultancy with strict confidentiality and such information must not be divulged to any third party.

# **DISTRIBUTION OF REPORTS**

23. In all cases, one (1) digital and three (3) hard copies of each report shall be submitted to the Chief Town Planner.

## **TERMINATION**

24. The parties have agreed that either party may terminate this Memorandum of Understanding upon written notice to the other party. Specifically, the

Memorandum of Understanding may be terminated prior to the execution of a formal contract prepared by the Solicitor General in cases where there is evidence that:

- (a) the Consultant fails to perform any of its obligations under this agreement, including the carrying out of the Services, provided that such notice of termination (i) shall specify the nature of the failure, and (ii) shall request the Consultant to remedy such failure within a period not exceeding thirty (30) days after receipt by the Consultant of such notice of termination; and
- (b) the Consultant fails to sign an implementation agreement.

25. In the event that this MOU is terminated in accordance with paragraph 24 above, the Consultant shall be paid for any reasonable cost incurred in accordance with the MOU as agreed between the parties.

#### **GOVERNING LAW**

26. This MOU shall be governed by the Laws of Barbados and litigated in the Law Courts of Barbados.

#### 1. Introduction

- 1.1. The requirement of this consultancy consists of the carrying out of a comprehensive technical assessment of an agreed group of Listed Properties within the Historic Bridgetown and Its Garrison World Heritage Property. The purpose of this Inception Report as outlined in the Terms of Reference is to:
  - 1.1.1. Clearly detail the methodology, approaches and timelines associated with this consultancy paying particular attention to the efficient management of the process and presentation format for key deliverables, noting the need for outputs to be Geographical Information System (GIS) compatible; and
  - 1.1.2. Outline limitations to the conduct of the consultancy and any risks to the delivery of outputs/deliverables.
- 1.2. The methodology we propose is as follows:
  - 1.2.1. Visually verify the locations of the selected Listed Buildings within the inscribed Property and initiate external photography immediately. This will be implemented jointly by technical staff of the architects and engineers and the historical researcher(s).
  - 1.2.2. Initiate internal photography where access may be obtained informally (e.g., by permission of the occupant of a commercial building generally accessible to the public).
  - 1.2.3. Initiate a search for contact information of each current property owner or manager.
  - 1.2.4. Upon confirmation that the Town and Country Development Planning Office has contacted the appropriate agencies and private owners to introduce the Consultant, initiate a search for site and building plans by requesting of the said

### 6. Limitations to the Consultancy

6.1. The major limitation identified to date which would hinder timely and thorough assessment of the properties selected is identification of the owners and permission of to enter, photograph, measure (if required) and inspect the privately owned properties. We look forward to the assistance of Government to facilitate this process within the prescribed time period.

#### 7. Activities to date

7.1. Consultant Team Planning Meeting

The Team met on Friday, 18<sup>th</sup> October for the purpose of prioritizing the work to be undertaken in preparation for the Mid-Term Report. The following steps were agreed:

- 7.1.1. The Team will meet next week for a survey tour to locate, give cursory external inspection, and make preliminary work assignments for all of the properties.
- 7.1.2. Based upon the anticipated ease of access for closer inspection and available historical documents, the properties will be addressed in the following order:
  - 7.1.2.1. Churches
  - 7.1.2.2. Military Properties
  - 7.1.2.3. Garrison-area properties
  - 7.1.2.4. All others (to be prioritized at a later date)

#### 7.2. Survey Tour

On Monday, 21<sup>st</sup> October, the Consultant Team completed a survey tour of nine Bridgetown properties including:

- 7.2.1. St Patrick's Roman Catholic Church We were able to tour the sanctuary, observe recent renovation/repair work, take photographs and outline elements of the required Engineer's Assessment.
- 7.2.2. Nidhe Israel Jewish Museum During a brief look at the grounds we learned that the Museum will not be open until December.
- 7.2.3. Calvary Moravian Church We were able to tour the sanctuary, take photographs, observe repairs/renovations and outline elements of the required Engineer's Assessment.

- 7.2.4. James Street Methodist Church We were admitted to the sanctuary, took photographs and noted structural elements to be studied.
- 7.2.5. Mustor's Restaurant It was observed that little remains of what appears to have been a private residence. With little observed architectural significance the building's history is expected to be central to our assessment.
- 7.2.6. Old Spirit Bond We were able to enter the building as it currently houses a public cultural exhibit. While it is known that some of the original brickwork has been preserved, we saw that the renovations have added new brickwork over a large portion of the building and a very modern interior.
- 7.2.7. New York Club Exterior photographs were taken.
- 7.2.8. Castro's Bar This was only briefly observed. A second visit will be planned.
- 7.2.9. Grasmere This walled property permitted limited observation. However, Dr. Bannister's extensive collection of sculptures from recycled materials was in evidence.
- 7.2.10. A second tour is planned for later in the week to the remaining non-military sites.

# COMMENTS FROM THE CABINET PAPER "STATUS REPORT ON THE MANAGEMENT PLAN FOR HISTORIC BRIDGETOWN AND ITS GARRISON AS A WORLD HERITAGE SITE"

### (M.P. 141/2-3-2/4 Vol. 1) DATED 2011-06-20

On June 20, 2011, the Ministry of Family, Culture, Sports and Youth submitted to the Cabinet of Barbados a Cabinet Paper seeking the approval of the Management Plan for "Historic Bridgetown and its Garrison".

- 2. The Management Plan was developed by the Ministry of Family, Culture, Sports and Youth and the Barbados World Heritage Committee after wide consultations with key stakeholders, many of whom have interests in, and some measure of responsibility for the maintenance and management of the site. These consultations afforded the Committee the opportunity to identify the most effective strategies for:
  - ensuring the protection and preservation of the Outstanding Universal Value of the Site;
  - ensuring that the Site is managed in such a way as to provide the desired balance between sustainability and economic development, i.e., developing the recreational assets and tourism potential of the Site in order to contribute to the diversification of the economy, while at the same time managing its integrity and Outstanding Universal Value; and
  - effectively coordinating and documenting activities, strategies and plans relating to the care, maintenance, management, celebration and development of the Site.
- 3. Among the agencies consulted were:
  - The Barbados Fire Service
  - Sanitation Service Authority

- Barbados Defence Force
- National Conservation Commission
- 4. This Management Plan is particularly significant for a number of reasons:
  - a) it represents a paradigm shift from the traditional notions of preserving cultural heritage in the Caribbean that typically focuses solely on built heritage;
  - b) it addresses the need to preserve our intangible heritage such as oral traditions, rituals, language, dance, music, literature and the visual arts;
  - c) it sets out the vision and objectives for the development of cultural services and productions across the Site;
  - d) it supports the vision expressed in a number of local policies aimed at making Barbados a competitive and attractive place to work, play and conduct business. Such policies include those reflected in the 2008 Manifesto of the Democratic Labour Party, National Cultural Policy, the National Strategic Plan and the draft Master Plan of the Barbados Tourism Authority.
- 5. The Management plan contains seven (7) action plans that encompass existing plans and strategies, and which deal with:

### i. Protecting, Preserving and Enhancing Heritage

This will be carried out primarily by the Town and Country Development Planning Office in consultation with other regulatory agencies and stakeholders and the public. It will involve updating current legislation, mapping and integrating the Property boundary and buffer zone of the nominated Property into the Geographical Information System (GIS) platform, mapping sites of archaeological significance,

embarking on the development of a new system of categorization for Listed Buildings based on a review and adaptation of international best practices, conducting an inventory of monuments and sites of archaeological and artistic interest, enhancing the Development Control Process through the enactment of specific legislation relating to cultural heritage conservation areas and the World Heritage Site. In addition it involves the enactment of the Preservation of Antiquities and Relics Bill, coordination of the implementation of the terms and conditions of International Conventions for the Protection and Preservation of Cultural Heritage and related activities.

### ii. Education, Capacity Building and Research

This plan seeks to develop and build a series of learning programmes for primary, secondary, tertiary and vocational students and to provide certification in a series of heritage related programmes at the secondary and tertiary levels. It will seek to improve the skills of persons working within the various Ministries and agencies who have responsibility for the Site. Specific attention will be paid to building capacity within the fields of conservation and research.

### iii. Transportation

This Plan will be executed by the Ministry of Transport and Works in conjunction with the Transport Authority. It is aimed at improving accessibility to the boundary and managing the traffic flow within the Site. Primarily, it will involve the continued implementation of the Bridgetown Traffic Plan and the Transportation Management Plan and enhanced by plans of the Transport Board.

### iv. Tourism Management

This will be coordinated and executed by the Ministry of Tourism and the Barbados Tourism Authority in collaboration with the Barbados Museum and Historical Society and other relevant agencies. It will evolve around the objectives of the draft Tourism Master Plan and will seek to:

- provide a clear demonstration of the relationship between tourism and cultural heritage;
- increase awareness of tourism stakeholders of the relationship between the designated site and the tourism industry; and
- highlight the potential for increased revenue to accrue to tourism businesses located within and in the vicinity of the designated Site.

### v. <u>Public Awareness</u>

This plan outlines a series of activities aimed at inculcating respect and appreciation for Barbados' cultural heritage. It will address some of the major threats to the Site including littering, vandalism, neglect and illegal destruction of historic properties, and will seek to encourage Barbadians to protect and preserve their cultural heritage for future generations. It will target communities and such special interest groups as the youth, property owners within the site, engineers, architects and developers.

### vi. Cultural and Heritage Interpretation

The Cultural and Heritage Interpretation Plan outlines a series of events aimed at celebrating the cultural heritage of the Site in such activities as open air theatre, street performances, tours and museums exhibits. It will serve as a means of revitalising cultural activities within the Site and will contribute to the effort to save one of Barbados' most cherished cultural artform, the Barbados Landship.

### vii. Risk Management

The risk preparedness plan outlines the various strategies currently used by the various agencies responsible for Risk Management in Barbados. It addresses some of the missing gaps in the island's Risk Management Plan and seeks to build a

cohesive and comprehensive framework in preventing, mitigating risks and in the recovery and restoration of properties and contents after a disaster.

### Implementation of the Management Plan

- 6. The management of "Historic Bridgetown and its Garrison" will be undertaken in two phases, concentrating on the collection of baseline data and the establishment of key mechanisms within the first two (2) years, followed by further consolidation of the activities and strategic roles of critical agencies over the remaining three (3) years. Both phases will be based on the execution of a wide range of strategies using a multi-sectoral, participatory framework aimed at preserving, protecting and enhancing the Outstanding Universal Value of the Property, for the enjoyment of future generations of Barbadians and the world.
- 7. The current state of preservation throughout the Property is characterized by varying degrees of neglect and decay which have led to the loss of several structures. Moreover, there are a number of other critical issues which need to be addressed, including:
  - limited access to capital and incentives to encourage regeneration;
  - a paucity of knowledge and skills in the art of preservation and conservation;
  - the need for enhanced public awareness and education (to engender appreciation of the Property);
  - the creation of a sustainable tourism balance, and
  - the current traffic congestion levels within the boundaries of the Property.
- 8. On June 30, 2011, The Cabinet of Barbados approved the Management Plan for Historic Bridgetown and its Garrison. Attached is a copy of the Cabinet Decision







### Side Walk Exhibition and Arts Market




A section of the crowd at Movie Night in Independence Square


#### Changing of the Sentry

#### 1. JUSTIFICATION OF THE PROJECT

Historic Bridgetown and its Garrison in Barbados was inscribed on the UNESCO World Heritage List on June 25, 2011. This prestigious inscription attests to UNESCO recognition of the Outstanding Universal Value of the property and of the country's commitment to the protection of the Island's heritage.

As one of the earliest established towns with a fortified port in the Caribbean network of military and maritime-mercantile outposts of the British Atlantic, Historic Bridgetown and its Garrison was the focus of trade-based English expansion in the Americas. By the 17th century, the fortified port town was able to establish its importance in the British Atlantic trade and became an entrepôt for goods, especially sugar, and enslaved persons destined for Barbados and the rest of the Americas.

Gaining the inscription has placed the management and preservation of the heritage assets within this valued property on the priority list of the Government of Barbados and the Barbados World Heritage Committee. The situation is even more of a priority in light of the fact that The World Heritage Centre in its 2012 report to Barbados has indicated that the State Party needed to institute training in Conservation.

The property itself contains a wide array of historic structures with a variety of ownership styles and uses: residential, businesses, churches and administration buildings that date back to the 1700s. Due to a lack of funds and a national maintenance plan, damaged caused by natural and man-made factor over the year, many of these buildings are in a state of des pair or have been lost. This is emphasised in the Management Plan for the property which states that "the current state of preservation throughout the Property is characterized by varying degrees of neglect and decay of structures which have led to the loss of many properties. Moreover, limited access to a paucity of knowledge and skills in the art of preservation and conservation is an issue that confronts the Site and needs to be addressed". Another critical factor is the lack of awareness and apathy towards historic properties that is prevalent in many sectors of the society.

Whereas there are numerous tradesmen working in wood and masonry in the island, there is a dearth of skilled professionals such as wood turners. The lack of masons skilled in limestone has meant that there has been no transfer of skills to assist in the maintenance programmes. Therefore, many of these stone structures are in varying degrees of neglect and abandonment because of a lack of knowledge on how to adequately maintain and preserve them. Additionally, the most critical need apart from funding is capacity building to develop a core of persons trained in the maintenance and conservation of wood and stone structures.

There are tertiary level and vocational institutions on the island that offer courses in various aspects of building maintenance. However none of them focuses on the area of conservation. It should further be noted that at present there is an acute shortage of trained Conservators in Barbados and indeed the region and government have been forced to contract conservators, at considerable costs.



# REPORT TO THE BARBADOS WORLD HERITAGE COMMITTEE "World Heritage in the Classroom" Workshops

As part of the fulfillment of the World Heritage (WH) Management Plan's (2011-2016) Action Plan for Public Education, the Ministry of Culture, Sports and Culture in collaboration with the Department of History and Philosophy planned and executed a Workshop, entitled "Heritage in the Classrooms" to sensitize Principals of twenty five (25) private and public primary schools in the island about the recent inscription of Historic Bridgetown and its Garrison as a UNESCO World Heritage site (2011). The Public Education Sub-Committee of the Barbados World Heritage Committee (BWHC) consists of members from the Ministry of Education; the Ministry of Culture; the Department of History and Philosophy and the Barbados Museum and Historical Society (BMHS).

The first phase of the workshop took place in February 02 and 03, 16-17, 21-22 and 28-29, 2012 at the Ministry of Education, Science and Innovation. Eighty (80) social studies teachers from public and private, primary and secondary schools in the island attended a two-day workshop entitled, "World Heritage in the Classroom". These teachers teach a range of subjects including, geography, history and social studies. One of the recommendations put forward by the teachers was for a similar exercise to be held for the Principals.

The second phase of "Heritage in the Classroom" which targeted the Principals began with an Opening Ceremony at which the Chief Education Officer in the Ministry of Education, Science, Technology and Innovation Mr. Laurie King, the Permanent Secretary in the Ministry of Culture, Sports and Youth Mrs. Ruth Blackman and Dr. Henderson Carter for the University of the West Indies made remarks.

The aim of the workshop was to sensitise the Principals about heritage, culture and specifically Barbados' first world heritage property. Armed with this knowledge, it will assist them to offer support to the programmes being undertaken by their teachers in the schools.

#### **WORKSHOPS**

On Day I of the workshop, the teachers heard various presentations which explained the Outstanding Universal Value of the property in terms of the site's political, commercial, military and cultural significance.

On Day 2, teachers met at the Ministry of Education and were taken by coach on a tour of the Property led by Dr. Watson. Each group spent almost one hour in the Cheapside area listening to how it developed from the site of the first English settlement to its evolution as a marketplace for enslaved Africans who brought their goods to sell in the "Shambles" market and a space where the urban free coloured population lived and worked.

The Principals were also taken on a tour of St. Mary's Church and its burial ground where they were shown the tombs, headstones and monuments for several notable Barbadians including, Samuel Jackman Prescod (first 'coloured' Member of Parliament); Amaryllis Collymore (free coloured ancestress of Frank Collymore, a cultural icon); tomb of the Barclay family (founding family of Sierra Leone) and Ernest Deighton Mottley (first mayor of Bridgetown). The Church's outstanding Georgian architecture was discussed, as well as its establishment on one of the oldest Anglican consecrated grounds in the English Americas (it is the site of the original St. Michael's parish Church).





The Principals were taken on a guided tour of the Museum of Parliament and National Heroes Gallery at the Public Buildings, which is one of the newest museums in Barbados. Mr. Best, the Site Manager, led the teachers on a tour of the museum highlighting significant exhibits and explaining the historical development of social democracy in Barbados. Many of the teachers, particularly those at the primary school

level, have never been to the Museum of Parliament and said that they would consider taking their students to visit.






At the Garrison, the Principals were told about the significance of landscape history in understanding the strategic location of the Garrison for protecting Carlisle Bay and the unique architecture of the Garrison.

After the tour ended the group returned to the Ministry of Education for a de-briefing session. The participants submitted personal reflections about the tour and how they could use field trips in teaching. They then completed a group assignment, developing a teaching strategy/unit/lesson plan; student research project; and personal research project based on Historic Bridgetown and its Garrison.

Overall, the "World Heritage in the Classroom" workshops were an overwhelming success, especially as they seemed to develop an enthusiasm for teaching and learning history. Participants were asked to fill out an anonymous evaluation of the workshop and most agreed that it was a useful exercise that was well organized and facilitated. Participants particularly enjoyed learning more about the urban enslaved experience and the cultural development of the site.





Feedback from these sessions was generally positive; the participants asked insightful questions willingly participated in discussions. They also provided some insight into the types of materials and resources that were required for teaching history as well as the areas of the syllabus that could include content about World Heritage.
