SUMMARY

The 30th anniversary of the adoption by the General Conference of UNESCO of the *Convention concerning the protection of the world cultural and natural heritage* on 16 November 1972 presents an ideal opportunity for the international community involved in cultural and natural heritage conservation to reflect on achievements to date and to examine the main issues, constraints and opportunities in the implementation of the *World Heritage Convention*.

The purpose of this document, presented in three parts, is to provide the Bureau with a full progress report on the activities organized by UNESCO or its partners to mark this anniversary.

Part III: Proposal to publish a book to mark the 30th anniversary of the World Heritage Convention

Action required:

1. The Bureau is requested to examine the progress report contained herein and to take note of the proposed actions;

2. The Bureau may wish to discuss the options outlined regarding the opening of the 26th session of the World Heritage Committee, dedicated to marking the 30th anniversary of the Convention, and provide further guidance to the Secretariat as to how the opening session in Budapest on 24 June 2002 may be structured.

PART I: Events co-organized by UNESCO

26th SESSION OF THE WORLD HERITAGE COMMITTEE Budapest, (Hungary) 24-29 June 2002

Opening celebration 24 June

The twenty-sixth session of the World Heritage Committee in Budapest constitutes a unique opportunity to celebrate the 30^{th} anniversary of the *Convention*. In view of the time constraints arising as a result of the new calendar for Committee sessions, ideas for the opening morning of the session, 24 June 2002, dedicated to marking the 30^{th} anniversary of the World Heritage Convention were considered by representatives of the Bureau of the World Heritage Committee at the 15 January meeting referred to on page 2 of this document. The following three options were discussed:

- 1. Former Chairpersons of the World Heritage Committee, representing different academic disciplines, could be invited to make brief presentations reflecting on their experiences. Time constraints meant that this would need to be limited to perhaps 4 or 5 speakers.
- 2. A renowned outside speaker, perhaps an international statesperson, could be invited to give a keynote address looking at the Convention from the outside. This could be complemented by one or two shorter addresses from figures involved in the implementation of the Convention itself.
- 3. A third approach, merging the first two, could take the form of a keynote address by a leading figure followed by a response from a former Chairperson of the World Heritage Committee. Suggestions for keynote speakers included: A development bank representative, or the head of an international heritage foundation.

Support was expressed for each of these options, with preference for the third. It was agreed that in view of the long lead-time needed to invite speakers to make presentations, an early decision on the format for this opening session would be required. To this end, the Director of the Centre invited participants to send written comments or further suggestions about this session to the World Heritage Centre. This invitation was extended to all members of the World Heritage Committee in a letter from the Director of the World Heritage Centre dated 16 January.

Consideration also needed to be given to the precise form of the proposed **Budapest Declaration** on World Heritage, a draft of which is presented in WHC-02/CONF.201/9.

WORLD HERITAGE: SHARED LEGACY, COMMON RESPONSIBILITY

International Congress Of Experts Venice (Italy), 14-16 November 2002

Focus of the Congress:

The aim of the Congress is to involve participants from intergovernmental, national, regional and local authorities, from foundations, international non-governmental organizations and the private sector in discussing ways of strengthening the World Heritage conservation process. It may be seen as a test of the viability of the partnership idea discussed in preliminary form by the World Heritage Committee in Helsinki. The programme for the event, which draws on the discussions at the meetings on 15 and 18 January referred to below, is attached as Annex 1.

Information about the Congress:

A brochure announcing the Congress along with a letter inviting suggestions about possible expert participants will be sent out to the Permanent Delegations of UNESCO Member States, National Commissions and Observer missions. The brochure will separately be distributed to World Heritage experts identified through discussion with the Advisory bodies to the Committee and the UNESCO Secretariat. Space constraints at the venue for the Congress, the Cini Foundation on the Island of San Giorgio Maggiore, Venice, mean that participation must be limited to around 500 people. A system for managing responses is in preparation.

The Congress will also be announced in the World Heritage Newsletter, the World Heritage Review and on the World Heritage website. Following a competitive tendering exercise, a dedicated website is being prepared. This will be launched at the beginning of April, with preliminary information about the workshops and plenary sessions, logistical information and links to related events. Further information will be added incrementally in the run up to, period of and beyond the Congress. This may include detailed agendas, interviews with speakers and participants, the text of presentations, and reports on the workshops and plenary sessions.

Progress report on meetings held:

Following discussions during the twenty-fifth session of the World Heritage Committee in Helsinki, a briefing session for representatives of the Bureau about the preparations for the International Congress of World Heritage Experts in Venice was held at the World Heritage Centre on 15 January. A meeting of the Steering Committee for the event was held at UNESCO Headquarters on 18 January, at which representatives of the Bureau were present. Notes of both of these meetings were circulated to members of the World Heritage Committee on 16 January and 14 February respectively.

Logistical arrangements:

Following a competitive tendering exercise, a local events management company, "Citta d'Acqua" has been appointed to manage the logistical aspects of the Congress. They will work in close cooperation with the World Heritage Centre. The Centre will endeavour to facilitate the participation of experts from Less Developed Countries and is establishing criteria for assessing applications for such assistance. However, funds are limited and the Bureau may wish to consider how the participation of such experts might be further facilitated.

Patrons:

A small number of high profile intellectuals, entrepreneurs and international figures, representing all regions of the world, have been invited by the Director-General to become patrons for the International Congress of Experts. They have been invited to act in a personal capacity, although they all have a track record of involvement in cultural or natural heritage matters or associations with UNESCO and its spheres of activity. Their role will be to act as advocates both for the Congress and for World Heritage and to lend their names to Congress literature. The patrons will not hold meetings but will be invited to attend the Congress. The full list of patrons will be circulated to the World Heritage Committee once finalised.

THE VIRTUAL CONGRESS ON WORLD HERITAGE MANAGEMENT

Internet-based event 15-17 October 2002

New information technology (NIT), which can facilitate the visualization of natural and cultural properties and of conservation skills and methods, has proven to be an excellent tool in the didactic presentation of conservation objectives.

In co-operation with the ISRSP (International Society for Remote Sensing and Photogrammetry – a network of companies, research institutions, professionals) and the VSMM (Virtual System Multimedia – a network of universities and research institutes for new technologies) this project will organize a series of seminars to discuss the application of these technologies for World Heritage sites. These seminars are tentatively planned for Alexandria (Egypt), Beijing (China), Lome (Togo), and Paris (France) on 15-17 October 2002 and Strasbourg (France) on 5-8 November 2002. Through the "call for projects" to be launched via the VSMM and ISRSP networks, over 50 projects on new technology applications for archaeological, architectural and urban conservation and natural heritage conservation in World Heritage sites will be gathered. These seminars will make use of the internet as much as possible in order to disseminate information as well as to promote an interactive dialogue with on-line participants.

Expected outputs from the Congress will include, for example, an internet site that compiles the best NIT applications (including Geographical Information Systems and examples of the use of satellite images for World Heritage sites) and the proceedings of the seminars.

USE OF SPACE TECHNOLOGY TO MONITOR WORLD HERITAGE SITES

International Space University Strasbourg (France), 5-8 November 2002

An international Conference will be organised by EURISY, the International Space University (ISU), the European Space Agency, NASA and UNESCO's World Heritage Centre at ISU in the World Heritage city of Strasbourg. The aim of this conference, commemorating the 30th anniversary of the UNESCO *World Heritage Convention* and also 30 years of civilian remote sensing satellites, Progress report on 30th anniversary events and activities WHC-02/CONF.201/10, p.3

is to bring together space experts and international experts who contribute towards the conservation efforts of national heritage and World Heritage. The opportunity will also be taken to look at the possible and potential educational opportunities that may derive from the resulting database.

A CELEBRATION OF THE 30TH ANNIVERSARY OF THE WORLD HERITAGE CONVENTION

Potsdam (Germany), 6-8 June 2002

A two and a half day meeting will be organized by the German National Commission for UNESCO and the Foundation for Prussian Palaces and Gardens in Berlin and Brandenburg, in co-operation with the City of Potsdam, the Association of World Heritage Sites and the Masters Programme "World Heritage Studies" of Technical University Cottbus. The meeting will reflect on a number of technical and ethical themes, including World Heritage as a Forum for Intercultural Dialogue.

THE POLITICS OF WORLD HERITAGE: INTERNATIONAL CONFERENCE

International Institute for Culture, Tourism and Development, University of North London (United Kingdom), 3 and 4 September 2002

This conference, designed to coincide with the 30th anniversary of the *Convention*, aims to evaluate existing heritage conservation and tourism policy-making in relation to World Heritage sites and to contribute to the on-going debate about the designation, management and meaning of World Heritage in the 21st century.

REGIONAL SEMINAR TO CELEBRATE THE 30TH ANNIVERSARY OF THE WORLD HERITAGE CONVENTION

Harvard University Graduate School of Design (United States of America), 5 -7 December 2002

This seminar, organized by the Center for Urban Development Studies of Harvard University, will provide an opportunity to examine a certain number of case-studies on the management of World Heritage sites, notably concerning the properties situated in the United States of America and Canada.

OTHER EVENTS AND ACTIVITIES (Details To Be Confirmed)

In addition to events directly related to the *World Heritage Convention*, a number of international events related to cultural and natural heritage conservation will take place throughout the year. <u>PART III: Proposal to publish a book to mark the 30th anniversary of the World Heritage</u> <u>Convention</u>

Provisional title: 30 years of the World Heritage Convention, 1972-2002

As a result of discussions about 30th anniversary activities with the Advisory Bodies to the World Heritage Committee, a proposal to publish a reference book to mark the 30th anniversary of the Convention emerged. The aims of the book would be:

- 1. To analyse the *World Heritage Convention* and World Heritage policies from a range of perspectives.
- 2. To document and evaluate the impact of the *World Heritage Convention* on conservation on the 30th anniversary of its adoption.

The publication would comprise three sections. An introductory overview could include contributions by the World Heritage Committee in the form of articles by the 2002 Chairpersons, and incorporate a synthesis of the results of the opening of 26th session of the Committee as well as the Budapest Declaration. This would be followed by a thematic assessment of the *Convention*, opening with an article by Leon Pressouyre, the author of a 1992 monograph on the *Convention*, and followed by 6 expert commentaries, of approximately 10 pages each, examining the *World Heritage Convention* from one of the following themes: legal, economic, entrepreneurial, public awareness, anthropological and environmental. Preliminary approaches have been made to a number of potential authors including Lourdes Arizpe, Francesco Francioni and Jeff Sayer. The final part of the book, to be authored by the Advisory Bodies to the World Heritage Committee, ICCROM, ICOMOS and IUCN, and by site managers, would document and assess the coverage of the *Convention* and its impact on site conservation. Maps, photographs and brief descriptions of the sites currently inscribed on the World Heritage List, would accompany this text.

The book, to be funded through extra-budgetary sources, could be published in soft cover and distributed to the main World Heritage actors – States Parties, non-governmental organizations, academic libraries and development organizations. Consideration could also be given to the scope for commercialising this publication in collaboration with UNESCO's Publishing Office.

WORLD HERITAGE Shared Legacy, Common Responsibility

An International Congress of Experts organized by UNESCO and the Italian Government on the occasion of the 30th anniversary of the World Heritage Convention

This is a Draft proposal. It does not engage UNESCO, or other institutions, organizations and individuals mentioned in the text.

INTRODUCTION

The *Convention Concerning the Protection of the World Cultural and Natural Heritage* was adopted by the General Conference of UNESCO at its seventeenth session in Paris on 16 November 1972. Ratified to date by 167 States Parties, it has become the most important international legal instrument for the protection of heritage. 721 cultural and natural sites have so far been inscribed on the World Heritage List, in recognition of their outstanding universal value.

To mark the 30th anniversary of the *Convention*, UNESCO and the Government of Italy are organizing an International Congress¹ of Experts to reflect on some of the main issues, achievements and challenges of the World Heritage mission. International experts will gather to discuss the evolution of the *World Heritage Convention* and consider its role for the future. Participation in this Congress will be sought from Government officials, experts and site managers as well as International Foundation representatives, donors and private sector representatives, with the aim of strengthening partnerships for the conservation of natural and cultural heritage worldwide in the decades to come.

The objectives for the Congress are two-fold:

- 1. To discuss the successes and limitations of the World Heritage Convention with respect to:
 - The protection of natural and cultural heritage worldwide;
 - The development of appropriate national and international heritage protection legislation and practices;
 - Capacity-building at local and regional levels for the management of World Heritage sites;
 - The mobilisation of resources for World Heritage protection.
- 2. To discuss the future direction of the *World Heritage Convention* by:
 - Identifying opportunities and mobilising support in favour of specific action programmes related to heritage conservation;
 - Creating synergies between World Heritage stakeholders and encouraging the development of targeted partnerships ensuring increased site protection and presentation.

CONGRESS CHARACTERISTICS

Venue

The proposed venue of the Conference is the Giorgio Cini Foundation on the island of San Giorgio in Venice (Italy), as confirmed by the Italian Government.

Duration

The Congress will last two-and-a-half days (14-16 November 2002). All the sessions will be plenary. A number of conference workshops will be organized in the preceding days (11-12 November) in different cities.

Participants

It is estimated that around 500 participants will attend the Congress. The main categories of participants will be:

- Representatives of Governmental and Intergovernmental bodies involved in conservation of cultural and natural heritage;
- Representatives of Private Institutions and Foundations engaged directly or indirectly in conservation projects;
- Representatives of NGOs;
- Experts and professionals;
- Journalists and media.

Travel and accommodation

Information on travel and accommodation will be provided to participants at a later stage. A reservation service is being organized locally.

Field trips

A number of field trips and guided tours will be organized for the participants and accompanying persons.

Exhibitions

Exhibitions on specific aspects of World Heritage conservation can be organized. Proposals are welcome.

ORGANIZATION

Sponsored by:

The Congress is sponsored by UNESCO and the Italian Government.

Organized by:

The Organization of the Congress will be handled by UNESCO/WHC in collaboration with the UNESCO Office in Venice (ROSTE), the City of Venice and the Veneto Region.

A Steering Committee, composed of staff members of UNESCO, Advisory Bodies and other partner organizations, has been established. This Steering Committee will meet periodically to discuss the elaboration of the programme of the meeting and preparatory workshops as well as logistical aspects of the Congress. Meetings of this Committee will be prepared by the World Heritage Centre, acting as focal point for the organization of the Congress. Logistical aspects of the Congress will be managed by a local firm in close cooperation with the Centre.

In partnership with:

Public and private institutions involved in conservation of World Heritage will be invited to contribute to the development of the programme of the Congress and participate in Congress workshops and plenary sessions.

Supported by:

The Congress will be financed largely by the Italian Government and UNESCO. However, support is also sought from States Parties to the World Heritage Convention and from public and private institutions involved in World Heritage conservation. Partnerships with the private sector and media-related industry are also encouraged. These potential donors/sponsors will be invited to assist in organizing complementary events and promotional coverage of the Congress.

In recent years there has been increasing co-operation between local and regional governments, and other local institutions involved in World Heritage conservation, aimed at developing and implementing joint projects to address issues of concern to both stakeholders. In some cases, this has been stimulated by specific decentralised co-operation policies promoted by national governments and international development institutions. A greater and more effective involvement of local institutions requires the development of adequate financial and technical support and of a system of "best practice".
