## SUMMARY

This document, requested by the 26th session of the Committee in June 2002 (**Decision 26 COM 14.4**), presents the status of nominations submitted by States Parties to be examined by the World Heritage Committee in 2004.

The decision by the 24th session of the Committee (Cairns, 2000) to limit the number of new nominations will be reviewed by the Committee at its 27th ordinary session in Suzhou, China (29 June - 5 July 2003).

The document is divided into three parts:

Decision required:

The Committee is requested to examine this document and the draft decision in Part III.

## I. BACKGROUND

1. At its 24th session (Cairns, 2000), the World Heritage Committee decided to limit the number of new nominations it would examine to 30 "on an interim basis"<sup>1</sup>; and to examine only those nominations which were "full and complete" by the deadline of 1 February.

For this purpose, the World Heritage Centre proposed a set of guidelines to determine whether a nomination was full and complete:

"A nomination was considered to be "full and complete" if all information requested by the World Heritage Committee in the Nomination Format was submitted in the required number of copies by 1 February 2002.

A nomination was determined to be "almost complete" if the missing information could be supplied without modification to the nomination text. For example, if the only missing elements were a map or slides, or there were an insufficient number of copies, the nomination was considered "almost complete".

If the nomination required textual changes (for instance, if no justification was provided, or sections of the nomination were omitted), the nomination was considered "incomplete"."<sup>2</sup>

2. At its 26th session (June 2002), the Committee decided that the category of "almost complete" should be abolished, and that henceforth "all nominations will be accepted only if they are 'complete' as defined in the *Operational Guidelines* - at the time of the deadline" (**Decision 26 COM 14.3**).

3. A large percentage of the nominations were submitted in the last days of January 2003. To the extent possible, the World Heritage Centre worked with States Parties to make their nominations complete by 1 February 2003.

## II. STATUS REPORT ON ALL NOMINATIONS RECEIVED

4. The Committee requested the Centre "to submit at each Committee session a list of all nominations received, including the date of reception, an indication of their status 'complete' or 'incomplete', as well as the date at which they are considered as 'complete' in conformity with the *Operational Guidelines*" (Decision 26 COM 14.4). This list is presented below.

It also agreed that the 30 new nominations "will be considered together with nominations deferred, or referred, from previous meetings and changes to the boundaries of already inscribed properties" (Report of the 20th session (Cairns, 2000)), (WHC-2000/CONF.204/21). The Committee at its 25th session agreed that "transboundary nominations would not be counted within the limit of thirty nominations" (para. X.19, WHC-01/CONF.208/24).

- 5. As of 1 February 2003, the World Heritage Centre had received:
  - 46 new nominations, of which 32 were considered complete;
  - 10 proposals for extensions to inscribed sites, of which 6 were considered complete;
  - 4 nominations for sites previously deferred or referred by the Committee, of which 3 were considered complete;
  - 2 transboundary nominations, of which 1 was considered complete.
  - 5 Supplementary nominations submitted for consideration by future sessions of the Committee, of which 2 were considered complete <sup>3</sup>
  - 3 Nominations submitted after the deadline of 1 February 2003 (as of 12 March 2003)

6. The following is a full list of all nominations received between 2 February 2002 and 1 February 2003, in order by State Party.

New nominations are highlighted in **bold**,

Extensions are followed by the words "Bis" (first extension) or "Ter" (second and later extensions),

Deferred or referred nominations are given the suffix "Rev";

Transboundary nominations are indicated by "T"; and

Supplementary nominations by "S".

# **III. DRAFT DECISION**

## DRAFT 6 EXT.COM 7

The World Heritage Committee,

- 1. <u>Takes note</u> of the list of all nominations received by the World Heritage Centre between 2 February 2002 and 1 February 2003 as presented in document WHC-03/6 EXT.COM/7;
- 2. <u>Decides</u> that the 32 new nominations determined by the World Heritage Centre to be complete by 1 February 2003 be transmitted to the Advisory Bodies for evaluation;
- 3. <u>Requests</u> the World Heritage Centre to assist States Parties with incomplete nominations to make them complete for submission in future years.
- 4. <u>Requests</u> the World Heritage Centre to further develop, for inclusion in the revised Operational Guidelines (see decision 6 EXT. COM 5), an accurate description of the process and guidelines to be used by the World Heritage Centre to determine whether a nomination is complete. This revision should build upon text proposed in Paragraph II.E.1 and Annex VI of the 3rd draft annotated revised Operational Guidelines presented in document WHC-03/6 EXT.COM/INF.5B.
