In accordance with the recommendation of the 39th Session of the World Heritage Committee in Bonn, 28 June – 8 July 2015 No. **39 COM 7B.Add:** Paragraph 9, the State Party wishes to report on the State of Conservation of the Lorentz National Park.

Executive Summary

In response to the recommendation of the 39th Session of the World Heritage Committee in Bonn, 28 June – 8 July 2015, particularly the recommendation related to the World Heritage Properties in Indonesia on Agenda item 7B.12: Lorentz National Park and also the recommendations of the March 2014 mission, the Government of Indonesia, together with relevant stakeholders, has implemented several activities for the protection and preservation of the Lorentz National Park.

Our commitment to follow up the recommendation of the World Heritage Committee on Lorentz National Park has been reflected through a series of the following measures:

- 1. Prepared the document of the Management Plan for management of the Lorentz National Park as well as the document of the Environmental Impact Assessment (EIA) for the impact of the road construction in the Lorentz National Park;
- 2. Reviewed of the zonation plans;
- 3. Conducted several researches, observations, and studies to analyze the causes of the Nothofagus dieback;
- 4. Increased the preventive activities, such as conducting routine patrol, dissemination, and "save wildlife" campaign.
- 5. The Coordinating Ministry for Human Development and Culture, together with the relevant ministries, conducted a coordinating meeting with Provincial and 10 Local Governments in Papua on 30 August 2016 to discuss concerted efforts to conserve the Lorentz National Park and to implement the decision of 39 WHC.

All activities done by the Government of Indonesia in the management of national parks is intended to preserve the criteria of the Outstanding Universal Values of the Lorentz National Park.
