

Lviv: The Ensemble of the Historic Centre (Ukraine) (C 865 bis)

I. Answers of the City of Lviv to the UNESCO World Heritage Committee Decision (by points)

Resolution: 39COM 7B.84, accepted on the UNESCO 39th session (Bonn, Germany, 28.06-08.07.2015).

- 1. Having examined Document WHC-15/39.COM/7B,
- 2. Recalling Decision 37 COM 7B.113 adopted at the 37th session (Phnom Penh, 2013),
- 3. Welcomes the efforts made by the State Party to improve the protection of all components of the property and its buffer zone and requests it to sustain these efforts and to secure the necessary resources and to adopt regulatory regimes thus ensuring that no inappropriate developments or deterioration of the heritage buildings which could constitute a threat to the property and its buffer zone, will take place;

The Lviv City Council confirms the implementation and support of the Integrated Development Concept for the Historical City of Lviv as well as planned implementation of measures for conservation of cultural heritage sites in accordance with the affirmed "Program for the Social-Economic Development of Lviv in 2014-2016".

4. Also requests the State Party to finalize, as soon as possible, the Management Plan for the property, including details of the protective measures provided in its regulatory regimes, and to submit it to the World Heritage Centre, for review by the Advisory Bodies;

Management and preservation of the object are implemented basing on the Strategic Plan for Development of Lviv (2011-2025), Integrated Development Concept for the Historical City of Lviv (2011-2020), according to the Development Budget of Lviv for every certain year.

Within 2015-2016 the implementation of "The Program for Social-Economic and Cultural Development od Lviv for 2014-2016" is being continued in Lviv. This Program is approved by the resolution of Lviv City Council nr. 3199 as of 10.04.2014 and contains the list of required conservation activities for the city's cultural heritage sites preservation. During planning and development of the new counstruction/reconstruction projects the archaeological research and supervision are obligatory.

The conservation of architectural monuments is held basing on the project and estimation documents after their approval procedure and granting of all the permission documents according to the legislation of Ukraine.

New construction within the buffer zone of the Historical Center Ensemble is held basing on the project documentation developed with consideration of historical and city building justification and the territory detailed planning project (zoning). Historical and city building justification defines the parameters of new construction and its influence on the city silhouette as well as the universal value of the UNESCO World Heritage object. In 2015 the historic-architectural basic plan for the UNESCO World Heritage site entitled "Lviv: Ensemble of the Historical Center." was developed and added to the plan of the object management. (the document is attached in digital version)

5. Notes the number of proposed projects and reiterates its request to the State Party to submit to the World Heritage Centre, in conformity with Paragraph 172 of the Operational Guidelines, details of all major developments and conservation works

within the property and its buffer zone, with appropriate Heritage Impact Assessments (HIAs), for review by the Advisory Bodies;

Concerning the provided information about the potential planned significant conservation projects and/or new construction projects within the protected (buffer) area, we kindly inform that according to the result of analysis by UNESCO WHC's for following projects: "Restoration and Conservation of the Golden Rose "Turei Zahav" Synagogue Ruins" and "Area Ordering Between Buildings of 35 Staroyevreyska Str. and 3 Arsenalska Str." a positive conclusion was received. The mentioned above projects have been successfully implemented.

Concerning the progress in conservation of wall polychromy by Jan Henryk Rosen in the Armenian Cathedral of Holy Mary's Assumption in 7, Virmenska Str. we kindly inform that the mentioned works are being accomplished gradually by a joint group of conservators from Poland and Ukraine since 2007 and do not provide any construction changes or intrusions. The works include conservation only. Financing is made by the Ministry for Culture of Poland, the works technology is approved by the joint monitoring committee which continues to control the progress.

Thanks to the Polish Ministry of Culture financing the research and strenghtening of wall paintings in Jesuite Church of St. Peter and Paul in 11, Teatralna Str. and conservation of St. Christopher Column in the Armenian Cathedral courtyard in 7, Virmenska Str. The works technology is approved by Joint Monitoring Committee and provides strictly conservation works.

6. Also notes the ICOMOS technical review of the regeneration programme of the ancient Jewish quarter and invites the State Party to implement ICOMOS recommendations and, more particularly, to develop a detailed urban master plan and a conservation plan of the Jewish quarter;

In 2015-2016 the "Restoration and Conservation of the Turei Zahav (Golden Rose) Synagogue Ruins" project was implemented. The first stage of "Synagogues Square" project which was a winner of International Architectural Contest for ordering of Jewish Cultural Heritaage Sites in Lviv was finished. The "Synagogues Square" project was implemented for the funds from Lviv City Budget, Centre for Urban History of Central and Eastrn Europe, German Organization for International Cooperation (GIZ GmbH and charities. The project was positively estimated by the Expert of ICOMOS International Council on Monuments and Sites, supported by the Community of Lviv Jewish Descendants in Israel, by members of the "Association for preservation of Jewish Heritage and Monuments in Lviv". (pictures 19-24).

The project implementation was accompanied by a number of **public activities**: photo exhibition of an american professor Jason Francisco entitled "Synagogues Space: Jewish History, Common Heritage and Responsibility" (July, 2015), significant educational project "**Jewish Days in City Hall: Jewish History, Common Heritage and Responsibility**" (June 2015, August 2016), where researchers and practicians from Ukraine, Poland, The United States of America have narrated about the history and culture of the Jewish people in Lviv, Galicia and in general in Eastern Europe (pictures attached).

Besides in 2016 the conservation of the former Jewish hospital (currently – the municipal hospital) dome in 8 Rappoporta Str. in Lviv was started. Conservation works are planned to be over in 2017. Pictures 25, 26.

7. Further requests the State Party to submit to the World Heritage Centre, by 1 December 2016, an updated report, including a 1-page executive summary, on the state of conservation of the property and the implementation of the above.

Within the measures directed to preservation of the outstanding universal values, integrity and authenticity of "Lviv - Ensemble of Historical Centre" UNESCO world

heritage site in accordance with the state regulations regarding renovation and conservation of sites, within 2015-2016 the following works were accomplished in Lviv cultural heritage sites:

Conservation works:

- Building facade conservation architectural monuments on 18, Rynok sq. Pictures nr. 1,2.
- The facades conservation started on the building in 34, Krakivska Str. Pictures nr. 7, 8.
- Conservation and repairs of the facades in 36, Staroyevreyska Str. (39, Brativ Rohatyntsiv Str.). Photos nr. 9, 10.
- Conservation of the facades in 10, Lesi Ukrainky Str. Pictures nr. 11, 12.
- Conservation and repairment of the facades in 29, Fedorova Str. (photos nr. 13, 14), 5, Arsenalska Str. and 3, Arsenalska Str. (pictures nr. 15, 16).
- Conservation and power poles mounting in Svobody Ave., Picture nr. 25.
- Complex renovation of balconies and iron elements of the monument entrance gates and grates of "Dnister" Insurance Company in 20, Ruska Str. (pictures nr. 30-35).
- Conservation of stained glass in Transfiguration Church in 21, Krakivska Str. (works are in progress). Pictures 36, 37.
- The ordering of Armenian Cathedral Courtyard is accomplished. Including the St. Christopher column conservation. Pictures 38, 39.
- Repairs and conservation of the City Hall tower on 1, Rynok sq.
- Conservation of the facade in 7, Teatralna Str., (2015). Pictures nr. 61, 62.
- Church of St Peter and Paul of Jesuit order in 11, Teatralna Str., restoration of the roof over the side nave.
- Within the historical city area the conservation of 39 balconies is accomplished, works are in progress on 9 objects (26 balconies in total), out of which 5 balconies are located on the object territory. Pictures nr. 40-47, 48-52.
- Repairs and conservation of the facades and roof of the architectural monument from 17 century – "Pinsel Museum" in Lviv. Pictures nr. 3-6.
- The conservation of the "Austerity" sculpture on the architectural monument top in 15, Svobody Ave. Pictures 53-54.

The cautious renovation of the city's historical part is in progress, the qualification of conservators is raised and improved within the Ukrainian-German project "Municipal Development and Renovation of the Old Town in Lviv" in partnership between the Lviv City Council and German Organization for International Cooperation (GIZ). The following projects were held:

A number of programs of commonly financed conservation and repairs works was implemented within the Project. Their goal was to engage residents of historical buildings into the processes of historical elements preservation as well as into renovation and improvement of their living space.

In 2015-2016 the following conservation programs co-financed by the residents were implemented:

Hstorical windows and entrance gates renovation program. Within 2015-2016 32 historical gates and 228 windows were renovated, out of them 12 gates and 62 windows are located within the object territory.

Balconies renovation program: within 2015-2016 5 balconies were renovated on the object territory.

Program of stairways conservation common financing: in 2015 the complex renovation of two stairways was held, in 2015 – one object was renovated.

Within the "Common Heritage" project for the funds granted by the Ministry for Culture and National Heritage of Poland the following works in the scope of historical heritage of Lviv preservation were accomplished:

The next stage of renovation and conservation works in the Latin Cathedral of St.

Mary's Assumption on 1, Katedralna Sq.

The 9-th stage of conservation of Jan Henryk Rosen's wall polychromia in the Armenian Cathedral of St. Mary's Assumption interiors in 7, Virmenska Str. The renovation and conservation of St. Christopher column in the courtyard of the Armenian Cathedral of St. Mary's Assumption in 7, Virmenska Str.

St. Peter and Paul cathedral of Jesuit order in 11, Teatralna Str. in Lviv the next 3rd stage of conservation works preserving the wall paintings.

St. Christopher column in the Armenian Cathedral courtyard conservation accomplishment.

Public spaces:

- The reconstruction of Haidamatska Str. and part of B. Khmelnytskoho Str.
- "Reconstruction (renovation) of Svyatoho Yura Sq. with the erection of Metropolitan Sheptytskyi monument". The road previously crossing the square was closed as it used to be the most destructive element within the protection area of the architectural monument St. George's Cathedral ensemble, as it was situated directly in front of the main entrance to the Cathedral. This enabled the renovation of compositional integrity of the Cathedral ensemble and provide the return of the primary intension of St. George's Square: the mass public gatherings and holy services. As a result the new public space was created and the historical park near the square was preserved. Picture nr. 54.
- Ordering of Mytna Sq. is on its final stage. Picture nr. 63, 64.
- Within the Programme for co-financing of courtyards in residential buildings implemented by the Ukrainian-German project "Municipal Development and Renovation of Lviv Old Town": in 2015-2016 the ordering of 9 courtyards was accomplished. The objects were selected after the contest among the residents who were interested in participation and financial cooperation.

Archaeological research:

During the development of construction and reconstruction projects the archaeological research is obligatory. Besides an archaeological monitoring is made during the sites ordering, roads construction or reconstruction, engineering networks mounting, investment projects realization, which include ground works. The scheme map of Scientific Research Centre "Emergency Archaeological Service" of the National Academy of Sciences Archaeology Institute concerning the works accomplished in 2015-2016 is attached. Please see the Attachment nr.4.

II. Other issues concerning the site preservation

Measures directed to preservation and popularization of the world heritage site are as follows:

- Support and monitoring of the Integrated Concept for Central Part of Lviv Development, approved by the Lviv City Council regulation nr. 429 as of 21.04.2011 "Approving the Integrated Concept for Central Part of Lviv Development", which engages the managers of municipal structures, city councillors, architects and representatives of the "Municipal Development and Renovation of Lviv Old Town". Picture nr. 71
- Placing of bilingual information tables on cultural heritage sites containing the historical data about the world heritage sites, architectural monuments.

- Spreading of the "Guidebook for the City Decorating. Guidelines for Activities in the Historical Environment", the guidebooks for courtyards ordering,
- Annual organization of "Urban Workshop" as a platform for the discussion of important urban projects with the residents and public awareness raise. Within the Urban Workshop a number of events has been organized, in particular: Pictures contest entitled "The Way I Would Present the UNESCO World Heritage Site "Lviv The Ensemble of Historic Centre" in the Exhibition Devoted to 70th Anniversary of UNESCO Founding", educational and popularizing quests in the historic sites. Pictures 65-70.
- Annual dissemination of social messages concerning the historical monuments preservation in Lviv. During the social campaign, the series of billboards for the gistorical environment preservation were disseminated.
- The tourist load of Lviv concept development.
- In 2015 the first in Ukraine municipal bike rent was launched.
- A number of seminars concerning the green areas and plants were organized, where the best samples of world experience were presented. As a result of recommendations and discussions the "Program for the street greenery in the city" was developed, which provides the complex green areas development by the common efforts of the residents and the city authorities, including the areas within the UNESCO world heritage site.
- The 110 Anniversary of the former "Dnister" Insurance Company building in 20, Ruska Str. celebrations were held. On this occasion the guided tours in the building were organized, forged and ceramic objects were presented (crafted using the original samples), the pictures exhibition with the valuable elements description and brief historic data was held. Pictures nr. 79, 80.
- The organizing of seminar "Preservation of buildings windows authenticity: dialogues with the indifferent residents". Organization of a number of practical seminars for the conservators qualification raise. Pictures 81, 82.
- Annual days of the European heritage. In 2015 the exhibition "Secession in Lviv" dedicated to the secession architecture, in 2016 "The Gardens and Parks of Lviv". Pictures 77, 78.
- On August, 25-29, 2015 the "Days of Modernism in the City Hall: Architecture, Urban Visions, Heritage" were held within a series of educational projects.
- Within the Lviv experience spreading in the integrated urban development issue on national level on 16-17 November 2015, the 3rd Academy for integrated urban development was organized in Poltava. The main issue of the Academy in 2015 was the engagement of the urban community as a factor of city authorities success. In 2016 the 4th Academy for integrated urban development was organized in the city. Uzhgorod, which was visited by representatives of 24 historical cities of Ukraine. The title of this year's Academy was as follows: "Integrated Development of Ukraine's Cities Culture and Cultural Heritage as an Engine of the City." Photos 73-76.
- Articles in the newsletter of the UNESCO National Commission of Ukraine to the following topics: "Urban Workshop" in Lviv. Space for ideas ", "Conservation Program of of the doors and windows of historical buildings in Lviv", "Shared responsibility: how Lviv Honors the City's Jewish History."

- Participation in the International Scientific and Practial Conference "International Experience in Protection, Preservation and Popularization of the world heritage sites." (dedicated to UNESCO's 70th Anniversary). The photo exhibition of awarded pictures called "How I Would Like to Present "The UNESCO world heritage site "Lviv – the Ensemble of Historical Centre" organized within the "Urban Workshop".
- Participation in the International scientific and practical conference "International Experience in Protection and Popularisation of World Cultural Heritage Objects", where a Resolution concerning the founding of World Heritage Objects Association in Ukraine was signed.
- Workshops for training in restoration for artists of different crafts: carpenters, bricklayers, painters, plasterers, blacksmiths, architects. In particular as follows: workshops in restoration of historical painting walls and ceilings; Seminar on "Heritage and restoration and effectivity increase of historic windows"; Seminar on "Analysis of the level of salinity and desalination of natural stone" workshop for community moderators seminar "The principles of energy efficiency in historic buildings" etc.
- Launch of implementation of the project "Street for everyone participatory planning of
 the street in Lviv." The project's task is the implementation of a pilot project on
 participatory planning in one of the streets as a model for future projects. The project is
 concepted for 3 years (2015 2018). Within the framework of the project a concept of S.
 Bandera street repairs in the city of Lviv is developed.
- In April 17 to 23 under the "Right to the City" project in Lviv a Week of monuments protection, consisting of measures series aimed to setup a social dialogue and the development of effective mechanisms of monuments protection and urban renovation. Within the project a seminar on "Legal regulation of monuments." was conducted. The seminar was attended by representatives of the cultural heritage bureaus from 10 major cities in Ukraine. Photos 72,75,76.

III. Possible Planned Significant Conservation Projects and/or New Construction Projects Within the Protected Area

In order to preserve the UNESCO world heritage site the following important restoration works are planned for 2017:

- Restoration and conservation of the High Castle remnants.
- Repairs and conservation of the Dominican Cathedral with the cells premises on 1, Muzeyna Sq.
- Conservation of windows in the city hall building and in the former "Dnister" Insurance Company building in 20, Ruska Str.
- Complex conservation of the Black Building a house nr. 4 on Rynok Sq. (the project has won a grant from the USA Embassy in Ukraine).

Construction works within the project:

Broadening of pedestrian area and ordering of streets and squares in the Old Town: Staroyevreyska Str., Brativ Rohatyntsiv Str., Arsenalna Str., Arkhivna Str., Drukarska Str., Koliivschyny Sq.

Hotel construction in Virmenska and Krakivska streets crossing (the works have begun). The residential building on Lva Sq. erection (the works have begun).

The residential building on Zvenyhorodska Sq. construction (the works have begun). Investment construction projects provide the constructions in the object buffer zone. Particular ones are under construction. In 2015-2016 the projects of detailed planning (zoning) are developed and affirmed for 5 areas of the city.

RESUME

Within 2015-2016 the cautious renovation and integrated development of the city's historical part is continued. Main directions are as follows:

Cooperation of city government and community for the cautious urban renewal and common responsibility for the preservation of cultural heritage, involving residents in decisions making ("Urban Workshop" platform, "European Heritage Days");

Collaboration and financial support of the conservation works for the owners of cultural heritage objects (conservation program for windows and gates, staircases renovation program, the program for joint patios renovation, balconies conservation program);

Education and training of master conservators (seminars on conservation of metal, wood, stone);

Comprehensive conservation of the objects, the realization of small conservation measures (in 2015 the conservation works total cost was 21 514 783 UAH, as of $10.01.2016 - 8\,980\,555\,UAH$)

Ordering of public spaces and landscaping ("Synagogue Square", Mytna Square, program for development of street greening).

Preparing of comprehensive projects for cautious renovation of historical area (platform - a working group to implement the Integrated Concept for Historical Part of the City Development).

Conservation of architectural monuments basing on project design estimates, which is in progress of appropriate approval process and the issuance of permits for works in accordance with the laws of Ukraine.

Development of historical and architectural basic plan for the Ensemble of Historical Centre of Lviv as part of management plan.

New construction within the Ensemble of Historical Centre of Lviv buffer zone is based on project documentation, which is made with consideration of the historical and urban planning study and detailed planning of the project area (zoning). Historical and urban planning study defines the parameters of the new building and its impact on the city's skyline and universal value UNESCO World Heritage Site.

In 2016, the city conducted a dismantling of the last of the three towers on the territory of the St. George's Cathedral Metropolitan Gardens in accordance with the recommendations issued by the World Heritage Sites Committee.






