## 2. Institutional and operational structure of the Centre (Governing Board, Staffing, Operational funding and premises)

On February 16th 2016, the Italian Ministry of Foreign Affairs and Ministry for Culture and Tourism signed with UNESCO and the City of Turin the agreement for the establishment of the ITRECH C2 Centre.

As the Centre is still non-operational, the institutional and operational structure has not yet been completely defined.

## 3. Updates on the management of the Centre – particularly on meetings of the Governing Board and key decisions adopted

Given its non-operational status, the centre has not yet a defined management plan and no Governing Board has been formally established. Nevertheless, its founding members (in particular the University of Torino and Centro Studi Silvia Santagata-Ebla) are involved in activities related to UNESCO World Heritage research, training and networking programs.
