OPERATIONAL GUIDELINES FOR THE IMPLEMENTATION OF THE WORLD HERITAGE CONVENTION

INTRODUCTION

The cultural heritage and the natural heritage are among the price-1. less and irreplaceable possessions, not only of each nation, but of mankind as a whole. The loss, through deterioration or disappearance, of any of these most prized possessions constitutes an impoverishment of the heritage of all the peoples of the world. Parts of that heritage, because of their exceptional qualities, can be considered to be of outstanding universal value and as such worthy of special protection against the dangers which increasingly threaten them.

In an attempt to remedy this perilous situation and to ensure, as 2. far as possible, the proper identification, protection, conservation, presentation and rehabilitation of the world's irreplaceable heritage, the Member States of Unesco adopted in 1972 the Convention concerning the Protection of the World Cultural and Natural Heritage, hereinafter referred to as "the Convention". The Convention, which complements and in no way competes with heritage conservation programmes at the national level, provides for the establishment of a "World Heritage Committee" and a "World Heritage Fund". Both the Committee and the Fund have been in operation since 1976.

The World Heritage Committee, hereinafter referred to as "the 3. Committee", has three essential functions :

- to identify, on the basis of nominations submitted by (i) States Parties, cultural and natural properties of 1 outstanding universal value which are to be protected under the Convention, and to list those properties on the "World Heritage List";
- to decide which properties included in the World Heritage (ii)List are inscribed on the "List of World Heritage in Danger" (only properties which require for their conservation major operations and for which assistance has been requested under the Convention can be considered);
- to determine in what way and under what conditions the (iii) resources in the World Heritage Fund can most advantageousl; be used to assist States Farties, as far as possible, in the protection of their properties of oustanding unversal value.

4. The operational guidelines which are set out below have been prepared for the purpose of informing States Parties to the Convention and new members of the Committee of the principles which are to guide the work of the Committee in establishing the World Heritage List and in granting international assistance under the World Heritage Fund. These guidelines also provide details on other questions, mainly of a procedural nature, which relate to the implementation of the Convention.

I. ESTABLISHMENT OF THE WORLD HERITAGE LIST

A. General Principles

(v)

5. The Committee agreed that the following general principles would guide its work in establishing the World Heritage List :

- (i) The Convention provides for the protection of those cultural and natural properties deemed to be of outstanding universal value. It is not intended to provide for the protection of all properties of great interest, importance or value, but only for a select list of the most outstanding of these from an international viewpoint. The outstanding universal value of cultural and natural properties, nominated by States Parties, is determined according to two sets of criteria : one set for cultural property and another set for natural property. The criteria adopted by the Committee for this purpose are set 'out in paragraphs 15 to 18 below.
- (ii) The World Heritage List, in view of its importance for the work related to the Convention, and in particular for educational and public information purposes, is to be considered as a separate entity. The criteria for the inclusion of properties in the List have been elaborated with a view to enabling the Committee to act with full independence in evaluating solely the intrinsic merit of a property.
- (iii) The Committee considers it highly desirable for each State Party to submit, in conformity with Article 11 of the Convention, an inventory of cultural and natural properties situated in its territory and suitable for inclusion in the World Heritage List, to enable it to evaluate each property nominated to the List within the widest possible context.
- (iv) Efforts will be made to avoid any disproportion between the cultural heritage and the natural heritage properties entered on the List.
 - Cultural and natural properties are included in the World :" Heritage List according to a gradual process and no formal limit is imposed either on the total number of properties included in the List or on the number of properties any individual State can submit at successive stages for inclusion therein.
- (vi) When a property has deteriorated to the extent that it has lost those characteristics which determined its inclusion in the World Heritage List, the procedure concerning the possible deletion from the List will be applied. This procedure is set out in paragraphs 19 and 20 below.

Indications to States Parties concerning nominations to the List

6. Each State Party should, as far as possible, submit to the Committee a provisional List, which does not need to be exhaustive, of cultural and natural properties situated within its territory and which it considers suitable for inclusion in the World Heritage List. Such inventories should comprise those properties which the State intends to nominate during the following five to ten years.

7. Each State Party is also invited to nominate, as far as possible on the basis of the inventory mentioned in paragraph 6, cultural and natural properties situated within its territory which it considers to be of outstanding universal value and suitable for inclusion on the World Heritage List. The fundamental principle stipulated in the Convention is that properties nominated must be of outstanding universal value. The properties nominated therefore should be carefully selected : it is not sufficient that they be of particular value at the national level but they must also be of outstanding significance in the international context. The criteria against which the Committee will evaluate properties are set out in paragraphs 15 to 18 below.

8. Each nomination should be submitted on the appropriate form (see paragraph 21 below) and should provide all the relevant information and be supported by all the necessary documentation to demonstrate that the property nominated is truly of "outstanding universal value".

9. In nominating properties to the List, States Parties are invited to keep in mind the desirability of achieving a reasonable balance between cultural heritage and natural heritage properties included in the World Heritage List.

10. In cases where a cultural and/or natural property which fulfils the criteria adopted by the Committee extends beyond national borders, the States Parties concerned are encouraged to submit a joint nominaticn.

11. Whenever necessary for the proper conservation of a cultural or natural property nominated an adequate "buffer zone" around a property should be foreseen and should be afforded the necessary protection. A buffer zone can be defined as an area surrounding the property which has an essential influence on the physical state of the property and/or the way in which the property is perceived ; the area constituting the buffer zone should be determined in each case through technical stadies. Details on the size and characteristics of a buffer zone, as well as a map indicating its precise boundaries, should be provided in the nomination file relating to the property in question.

12. In keeping with the spirit of the Convention, States Parties should, as far as possible, endeavour to include in their submissions properties which derive their outstanding universal value from a particularly significant combination of cultural and natural features.

13. States Parties may propose in a single nomination a series of cultural properties in different geographical locations, provided that they are related because :

- (i) they belong to the same historico-cultural group or
- (ii) they are the subject of a single safeguarding project or
- (iii) they belong to the same type of property which is characteristic of the zone.

14. Where the intrinsic qualities of a natural site conducted are threatened by action of man and yet meet the ordeeria set out in

threatened by action of man and yet meet the corrective measures required paragraph 17 an action plan outlining the corrective measures required should be submitted with the nomination file. Should the corrective measures submitted by the nominating State not be taken within the time proposed by that State, the site will be considered by the Committee for delisting in accordance with the procedure adopted by the Committee.

C. Criteria for the inclusion of cultural properties in the World Heritage List

15. A monument, group of buildings or site - as defined in Article 1 of the Convention - which is nominated for inclusion in the World Heritage List will be considered to te of outstanding universal value for the purposes of the Convention when the Committee finds that it meets one or more of the following criteria and the test of authenticity. Each property nominated should therefore :

- a) (i) represent a <u>unique artistic</u> or <u>aesthetic</u> achievement, a masterpiece of the creative genius or
 - (ii) have exerted considerable influence, over a span of time or within a cultural area of the world, <u>on developments</u> in architecture, monumental sculpture, garden and larscape design, related arts, town-planning or human settlements, or
 - (iii) be unique, extremely rare, or of great antiquity or
 - (iv) be among the most characteristic elements of a type of structure, the type representing an important cultural, social, artistic, scientific, technological or industrial development or
 - (v) be a characteristic example of a significant style of architecture, method of construction or form of town-planning or traditional human sottlement that is fragile by nature or has become vulnerable under the impact of irreversible sociocultural or economic change or
 - (vi) be most importantly associated with ideas or beliefs, with events or with persons, of outstanding historical importance or significance and
 - b) meet the test of authenticity in design, materials, workmanship and setting. Authenticity does not necessary refer exclusively to the original form and structure of the property, but may also relate to subsequent modifications and additions made in the course of time which are themselves of artistic and historical value.

16. The following additional factors will be kept in mind by the Committee in deciding on the eligibility of a cultural property for inclusion in the List :

- a) The state of preservation of the property should be evaluated relatively, that is, it should be compared with that of other property of the same type dating from the same period ;
- b) Nominations of immovable property which are likely to become movable will not be considered ; and
- c) It is not sufficient for properties nominated in terms of criterion (vi) to be importantly associated with ideas, beliefs, events or persons of historic importance from the national point of view, but they must also be of outstanding significance from an international standpoint.

D. Criteria for the inclusion of natural properties in the World Heritage List

17. A natural heritage property - as defined in Article 2 of the Convention - which is submitted for inclusion in the World Heritage List will be considered to be of outstanding universal value for the purposes of the Convention when the Committee finds that it meets one or more of the following criteria and fulfils the conditions of integrity set but below. Properties nominated should therefore :

- be outstanding examples representing the major stages of the earth's evolutionary history. This category would include sites which represent the major "eras" of geological history such as "the age of reptiles" where the development of the planet's natural diversity can well be demonstrated and such as the "ice age" where early man and his environment underwent major changes; or
- (ii) be outstanding examples representing significant ongoing <u>geological processes</u>, <u>biological evolution and man's interaction with</u> <u>his natural environment</u>. As distinct from the periods of the earth's development, this focuses upon ongoing processes in the development of communities of plans and animals, landforms and marine and fesh water bodies. This category would include for example (a) as geological processes, glaciation and volcanism,
 (b) as biological evolution, examples of biomes such as tropical rainforests, deserts and tundra, (c) as interaction between man and his natural environment, terraced agricultural landscapes; or
- (iii) contain unique, rare or superlative natural phenomena, formations or features or areas of exceptional natural beauty, such as superlative examples of the most important ecosystems to man, natural features, (for instance, rivers, mountains, waterfalls), spectacles presented by great concentrations of animals, sweeping vistas covered by natural vegetation and exceptional combinations of natural and cultural elements; or
- (iv) be habitats where populations of rare or enddkered species of plants and animals still survive. This category would include those ecosystems in which concentrations of plants and animals of universal interest and significance are found.

It is recognized that individual sites may not possess the most spectreular or outstanding features as described above, but when the sites are viewed in a broader perspective with a complex of many surrounding features of significance, the entire area may qualify to demonstrate an array of characteristics of global significance.

- 18. In addition to the above criteria, the sites should also fulfil the conditions of integrity :
 - (i) The areas described in 17 (i) should contain all or most of of the key interrelated and interdependent elements in their natural relationships; for example, an "ice age" area would be expected to include the snow field, the glacier itself and samples of cutting patterns, deposition and colonization (striations, moraines, pioneer stages of plant succession, etc).
 - (ii) The areas described in 17 (ii) should have sufficient size and contain the necessary elements to demonstrate the key aspects of the process and to be self-perpetuating. For example, an area of "tropical rain forest" may be expected to include some variation in elevation above sea level, changes in topography and soi! types, river banks or Oxbow lakes,to demonstrate the diversity and complexity of the system.
 - (iii) The areas described in 17 (iii) should contain those eco-system components required for the continuity of the species or of the objects to be conserved. This will vary according to individual cases ; for example, the protected area for a waterfall would include all, or as much as possible, of the supporting upstream watershed ; or a coral reef area would be provided with control over siltation or pollution through the stream flow or ocean currents which provide its nutrients.
 - (iv) The areas described in 17 (iv) should be of sufficient size and contain the necessary habitat requirements for the survival of the species.

(v)

In cases of migratory species, seasonable sites necessary for their survival, wherever they are located, should be adequately protected. If such sites are located in other countries, the nominating State should contact those countries with a view to ensuring that the species are protected throughout their full life cycle. Agreements made in this connection, either trough adherence to international conventions or in the form of other multilateral or bilateral arrangements should be noted in the nomination.

Procedure for the eventual deletion of properties from the World heritage List

The Committee adopted the following procedure for the deletion of properties from the World Heritage List in cases :

a) where a property has deteriorated to the extent that it has lost those characteristics which determined its inclusion in the World Heritage List ; and

b) where the intrinsic qualities of a <u>natural</u> world heritage site[±] were already threatened at the time of its nomination by action or works of man and where the necessary corrective measures as outlined by the State Party at that time, have not been taken within the time proposed.

A. When a property inscribed on the World Heritage List has seriously deteriorated or, in the case of a natural site[±], when the necessary corrective measures have not been taken within the time proposed, the State Party on whose territory the property is situated should so inform the Secretariat of the Committee.

B. When the Secretariat receives such information from a source other than the State Party concerned, it will, as far as possible, verify the source and the contents of the information in consultation with the State Party concerned and request its comments. The Secretariat will inform the Chairman of the Committee of the results of its investigations and the Chairman/decides that the information is not to be acted upon, no action will be taken.

C. In all cases except those on which the Chairman decided that no further action should be taken, the S cretariat will request the competent advisory organization (s) (ICOMOS, IUCN or ICCROM) to forward comments on the information received.

D. The information received, together with the comments of the State Party and of the advisory organization (s), will be brought to the attention of the Bureau of the Committee. The Bureau may take one of the following measures :

it may decide that the property has not seriously deteriorated and that no further action should be taken ;

when the Bureau considers that the property has seriously deteriorated but not to the extent that its restoration is impossible, it may recommend to the Committee that the property be maintained on the List provided that the State Party takes the necessary measures to restore the property within a reasonable period of time. The Bureau may also recommend that technical co-operation be provided under the World Heritage Fund for work connected with the restoration of the property, if the State Party so requests.

The Committee decided to examine at a later stage the possibility of applying this rule to cultural properties.

when there is evidence that the property has deteriorated to the point where it has irretrievably lost these characteristics which determined its inclusion on the List, the Eureau may recommend that the Committee delete the property from the List; before any such recommendation is submitted to the Committee, the Secretariat will inform the State Party concerned of the Bureau's recommendation; any comments which the State Party may make with respect to the recommendation of the Bureau will be brought to the attention of the Committee, together with the Bureau's recommendation;

when the information available is not sufficient to enable the Bureau to take one of the measures described in a), b) or c) above, the Bureau may recommend to the Committee that the Secretariat be authorized to take the necessary action to ascertain, in consultation with the State Party concerned, the present condition of the property, the dangers to the pro perty and the feasibility of adequately restoring the property, and to report to the Bureau on the results of its action; such measures may include the sending of a factfinding mission or the consultation of specialists. In cases where emergency action is required, the Bureau may itself authorize the financing from the World Heritage Fund of the emergency assistance that is required.

E. The Committee will examine the recommendation of the Bureau and all the information available and will take a decision. Any such decision shall, in accordance with Article 13 (8) of the Convention, be taken by a majority of two-thirds of its members present and voting. The Committee shall not decide to delete any property unless the State Party has been consulted on the question.

F. The State Party will be informed of the Committee's decision.

G. If the Committee's decision entails any modification to the World Heritage List, this modification will be reflected in the next updated list that is published. The reasons for the deletion of any property from the List will also be given in the publication.

20. In adopting the above procedure, the Committee was particularly concerned that all possible measures should be taken to prevent the

concerned that all possible measures busile to offer technical codeletion of any property from the List and was ready to offer technical cooperation as far as possible to States Parties in this connection. Furthermore, the Committee wished to draw the attention of States Parties to the stipulations of Article 4 of the Convention which reads as follows : "Each State Party to this Convention recognizes that the duty of ensuring the identification, protection, conservation, presentation and transmission to future generations of the cultural and natural heritage referred to in Articles 1 and 2 and situated on its territory, belongs primarily to that State...*.

F. Format and content of nominations

21. The same printed form approved by the Committee, is used for the submission of nominations of cultural and natural properties. The following information and documentation is to be provided :

Justification for inclusion in the World Heritage List

All relevant information to be provided to demonstrate that the property nominated is of "outstanding universal value" in terms of the criteria adopted by the Committee. Statement is to include a comparative evaluation of properties of the same type or having similar features which are found in other countries.

22. Each nomination should be accompanied by a two-page summary which will be translated and reproduced for distribution to members of the Bureau and the Committee.

G. Procedure and calendar for the processing of nominations

23. The annual schedule set out below has been fixed for the receipt and processing of nominations to the World Heritage List. It should be emphasized, however, that the process of nominating properties to the World Heritate List is an ongoing one. Nominations to the List can be submitted at any time during the year. Those received by 1 January of a given year will be considered during that year. Those received after 1 January of a given year will be considered during the following year. 1 January

 - b) undertakes a professional evaluation of each nomination in terms of the criteria adopted by the Committee and transmits their evaluation to members
 of the Bureau of the Committee and to the Secretariat ;

The Secretariat transmits the summaries of nominations to members of the Bureau.

The Bureau examines the nominations and prepares recommenddations thereon to the Committee.

uly The summaries of nominations and the recommendations of the Bureau are transmitted to members of the Committee.

The Committee examines, on the basis of all the information submited by States Parties, those nominations which :

- a) are recommended by the Bureau for inscription on the World Heritage List ;
- b) are definitely not recommended for the List ;
 - c) raise problems of application of the criteria ;

and determines which properties are entered in the List.

It is to be noted that the Committee will not consider nominations when :

- a) the deadline for their submission has not been respected ;
- b) it has not been possible to complete their evaluation ;
- c) it is evident that the supporting documentation is incomplete or inadequate.

99 24. The normal deadlines for the submission and processing of nominations will not apply in the case of properties which fully meet the criteria for inclusion in the World Heritage List and which have suffered damage iv from disaster. Such nominations will be processed on an emergency basis.

INTERNATIONAL ASSISTANCE

Different forms of assistance available under the World Heritage Fund

1) Freparatory assistance

25.

- Assistance is available to States Parties for the preparation of :
 - a) inventories of cultural and/or natural properties suitable for inclusion in the World Heritage List ;
 - b) nominations of cultural and natural properties to the World Heritage List ; and
 - c) requests for technical co-operation, including requests relating to the organization of training courses.

This type of assistance, known as "preparatory assistance", can take the form of consultant services, equipment or, in exceptional cases, financial grants. The budgetary ceiling for each preparatory assistance project is fixed at \$15,000.

26. Requests for preparatory assistance will be forwarded by the Secretariat to the Chairman, who will decide in consultation with the Director-General on the type and extent of assistance to be granted. Request forms (reference WHC/5) can be obtained from the Secretariat.

2) Emergency assistance

27. States Parties may request emergency assistance for work in connection with cultural and natural properties included or suitable for inclusion in the World Heritage List and which are in immediate danger of total destruction or disappearance. Such assistance may be made available for the following purposes :

- a) to prepare urgent nominations of properties for the World Heritage List ;
- b) to draw up an emergency plan to safeguard properties inscribed on or nominated to the World Heritage List;
- c) to undettake emergency measures for the safeguarding of a property inscribed on or nominated to the World Heritage List.

28. Emergency assistance may be made available in the same forms as preparatory assistance. Requests will be processed in the same way as preparatory assistance requests (see paragraph 26 above). Request forms (reference WHC/5)can be obtained from the Secretariat.

3) Fellowships

29. States Parties may request fellowships for the training of specialized staff at all levels, in the field of identification, protection, conservation, presentation and rehabilitation of the cultural and natural heritage. The proposed training must be related to the implementation of the World Heritage Convention. 30. Requests for fellowships should be submitted on the standard "Application for Fellowship" form used for all fellowships adminittered by Unesco. These forms can be obtained from Unesco Nations: Coumissions, Unesco offices and offices of the United Nations Development Procumme in Member States as well as from the Secretariat. Each request should be accoupanied by a statement indicating the relationship of the proposed study plan to the implementation of the World Heritage Convention within the State Party submitting the request.

31. Fellowship requests will be transmitted by the Secretariat to the Chairman who will decide, in consultation with the Director-General, on the type ond duration of the training facilities to be granted.

32. When the fellowship has been approved a complete dossier on the candidate should be forwarded to the Secretariat. Each dossier should consist of :

Unesco certificate of language knowledge form completed by an official body (British Council, Alliance française, etc.), in triplicate,

Unesco completed report of medical examination with thorax Xray of standard size (one copy of each),

for academic studies :

- certified copies of all academic transcripts and university degrees or diplomas.
- N.B. For academic studies in the United States of America, three letters of recommendation are also required.

4) Technical co-operation

States Parties can request technical co-operation for the following purposes :

- a) work foreseen in safeguarding projects for properties included, or nominated for inclusion in the World Heritage List ; and
- b) as support for national or regional centres for the training of specialized staff in accordance with Article 23 of the Convention.

Technical co-operation may take the following forms (Article 22 of the Convention) :

- (i) studies concerning the artistic, scientific and technical problems raised by the protection, conservation, presentation and rehabilitation of the cultural and natural heritage;
 - (ii) services of experts, technicians and skilled labour ;
 - (iii) equipment which the State concerned does not possess or is not in a position to acquire ;

- (jv) low-interest or interest-free loans which might be repayable on a long-term basis ;
- the granting, in exceptional cases and for special reasons, (v)of non-repayable subsidies.
- The following information should be provided by States Parties in 35. their requests for technical co-operation :

 - a) detailed scientific and technical data concerning the work to be undertaken ;
 - b) a detailed analysis of the requirements in equipment, expendable and non-expendable supplies, specialist services, skilled and unskilled labour as well as administrative personnel, etc.,
 - the training component (in-service training as well c) as fellowships for training abroad).

Technical co-operation request forms can be obtained from the Secretariat. Requests should be forwarded to the Secretariat which 37.will submit them to the Bureau of the Committee. Requests, together with the recommendations of the Bureau, will then be examined by the Committee itself at its annual meeting.

Order of priorities for the granting of international assistance в.

Without prejudicing the provisions of the Convention, which shall always prevail, the Committee agreed on the following order of 38. priorities with respect to the of activities to be odsisted under the / type/ Convention :

- emergency measures to save property included, or nominated for inclusion, in the World Heritage List, and which is in immediate danger of deterioration or total destruction ;
- preparatory assistance for drawing up nominations to the World Heritage List and requests for technical co-operation ;

projects which are likely to have a multiplier effect ('seed money') because they :

- stimulate general interest in conservation ;
- . contribute to the advancement of scientific research ;
- contribute to the training of specialized personnel ;
- · generate contributions from other sources.

The Committee also agreed that the following factors would in principle govern its decisions in granting assistance under the 39. Convention :

- the urgency of the work and of the protective measures to be (i)taken ;
- the legislative, administrative and financial commitment of the recipient State to preserve and manage the property ; (ii)
- the cost of the project ; (iii)
- the interest for, and exemplary value of, the project in respect of scientific research and the development of economic (iv) conservation techniques ; (this would cover, for instance, the proposed use on the project of new methods and techniques in conservation, i.e. "pilot projects" carried out with the most economical means which would have an exemplary value);

the educational value both for the training of local experts and for the general public, that is, the training opportunities that would arise for local staff and the impact which the project would have on the awareness and appreciation of the general public, not only in the country in which the property is located, but on a world-wide scale;

(vi) the cultural and ecological benefits accruing from the project ; and

(vii) the consequences from the social and economic points of view.

40. Properties included in the World Heritage List are considered to be equal in value. For this reason, the criteria proposed above make no reference to the relative value of properties. A balance will be maintained between funds allocated to projects for the preservation of the cultural heritage on the one hand and projects relating to the natural heritage on the other hand.

C. Agreement to be concluded with States receiving international assistance

41. When technical co-operation on a large scale is granted to a State Party, an agreement will be concluded between the Committee and the State concerned in which will be set out :

- (a) the scope and nature of the technical co-operation granted ;
- (b) the obligations of the Government ;

(c) the facilities, privileges and immunities to be applied by the Government to the Committee and/or Unesco, to the property, funds and assets allocated to the project as well as to the officials and other persons performing services on behalf of the Committee and/or Unesco in connection with the project.

42. The text of a standard agreement has been adopted by the Committee.

43. The Committee decided to delegate authority to the Chairman to sign such agreements on its behalf. In exceptional circumstances, or when necessary for practical purposes, the Chairman may delegate authority to a member of the Secretariat whom he will designate.

D. Imprementation of projects

44. In order to ensure the efficient implementation of a project for which technical co-operation has been grated under the World
Heritage Fund, the Committee recommends that a single body - whether national, regional, local, public or private - should be entrusted with the responsibility of executing the project in the State Party concerned.

A. World Heritage Emblem

45. At its second session, the Committee adopted the World Heritage Emblem which had been prepared by Mr. Michel Olyff. This emblem symbolizes the interdependence of cultural and natural properties: the central square is a form created by man and the circle represents nature, the two being intimately linked. The emblem is round, like the world, but will at the same time it is a symbol of protection. The Committee decided that the two versions proposed by the artist (see Annex I) could be used, in any colour, depending on the use, the technical possibilities and considerations of an artisti insture.

46. Properties included in the World Heritage List should be morked with the emblem which should, however, be placed in such a way that it does not visually impair the property in question.

B. Financial regulations for the World Heritage Fund

47. The financial regulations for the Fund are set out in document WHC/7.

C. Rules of Procedure of the Committee

 48. The Rules of Procedure of the Committee, adopted by the Committee at its first session and amended at its second and third sessionsare
 to be found in document WHC/1.

D. Publication of the World Heritage List

 An up-to-date version of the World Heritage List will be published once every two years. The List of the World Heritage in Danger and the List of properties for which international assistance has been granted (which will include references to properties for which technical assistance has been granted / will be published as appendices of the List.

E. Use of the World Heritage Emblem and the name, symbol or depiction of World Heritage Sites

50. The World Heritage Emblem should not be used for any commercial purposes unless specific authorization is obtained from the Committee. The name, symbol or depiction of a World Heritage site, or of any element thereof, should not be used for commercial purposes unless written authorization has been obtained from the State concerned on the principles of using the said name, symbol or depiction, and unless the exact text or display the seen approved by that State and, as far as possible, by the national authority specifically concerned with the protection of the site. Any such utilization should be in conformity with the reasons for which the property has been placed on the World Heritage List.
