Ministry of Culture of Ukraine drafted the Law of Ukraine "On Amendments to Certain Legislative Acts of Ukraine on Protection of Cultural Heritage", which proposes to regulate the

issue of preservation the World Heritage sites and the traditional character of their environment. These requirements are proposed to extend to the properties inscribed on the Tentative List, pending a decision by the Committee for inscribing these properties on the World Heritage List or rejection of the nomination.
