The monuments are protected by the Laws "On protection and usage of the historical-cultural immovable monuments and historical environment", "On immovable monuments of history

and the culture, considered as state-owned property of Armenia and not subject to alienation" and by the regulation, "On State registration, study, protection, fortification, restoration, reconstruction and usage of the historical-cultural immovable monuments", Civil, Administrative, Land, and Criminal Codes of Armenia.
