2. Statement of Outstanding Universal Value

2.1 - Statement of Outstanding Universal Value / Statement of Significance

Statement of Significance

At the village of SGang Gwaay Ilnagaay (Nan Sdins) the remains of large cedar long houses, together with a number of carved mortuary and memorial poles, illustrate the art and way of life of the Haida. The site commemorates the living culture of the Haida, based on fishing and hunting, their relationship with the land and sea, and offers a visual key to their oral traditions. The village was occupied until shortly after 1880. What survives is unique in the world, a 19th century Haida village where the ruins of houses and memorial or mortuary poles illustrate the power and artistry of Haida society. Criterion (iii) SGang Gwaay Ilnagaay (Nan Sdins), located on SGang Gwaay (Anthony Island) in an archipelago off the west coast of British Columbia, bears unique testimony to the culture of the Haida. The art represented by the carved poles at SGang Gwaay Ilnagaay (Nan Sdins) is recognized to be among the finest examples of its type in the world.

3.17. Comments, conclusions and / or recommendations related to factors affecting the property

3.17.1 - Comments

SGang Gwaay was part of an ongoing study on erosion that began in 2006. The 2006 report noted that most of the poles at SGang Gwaay are situated five to fifteen meters from the eroding shoreline and that the site showed "tidal encroachment and localized storm erosion." Parks Canada is currently researching solutions for mitigating coastal shoreline erosion at SGang Gwaay.

4. Protection, Management and Monitoring of the Property

4.1. Boundaries and Buffer Zones

4.1.1 - Buffer zone status

There is no buffer zone, but there is a need for one

The boundaries of the World Heritage property **do not limit** the ability to maintain the property's Outstanding Universal Value but they could be improved

The property had no buffer zone at the time of its inscription on the World Heritage List

The boundaries of the World Heritage property **are not known** by the management authority or local residents / communities/landowners.

4.1.5 - Are the buffer zones of the World Heritage property known?

The property had **no buffer zone** at the time of its inscription on the World Heritage List

4.1.6 - Comments, conclusions and / or recommendations related to boundaries and buffer zones of the World Heritage property

Inconsistencies in the nomination form submitted to ICOMOS in 1980 have made it unclear whether the World Heritage property boundaries are limited only to the actual SGang Gwaay village site or if the boundary is around the entire island of SGang Gwaay . Canada will be taking advantage of the upocoming WHC Retropective Inventory project to clarify this.

4.2. Protective Measures

4.2.1 - Protective designation (legal, regulatory, contractual, planning, institutional and / or traditional)

The site is presently in public ownership and is protected and controlled by the Province of British Columbia by virtue of: (a) being a Class A Provincial Park; and (b) being Designated as a "Provincial Heritage Site" under the Heritage Conservation Act of British Columbia.

The Canada National Parks Act gives the Minister authority to enter into an agreement with the Haida Nation for the management of Gwaii Haanas National Park Reserve (GHNPR) and Haida Heritage Site (HHS). SGang Gwaay is located within Gwaii Haanas (GH) and is managed under the authority of the Gwaii Haanas Agreement (1993) signed by the Government of Canada, represented by the Minister of Environment, and Council of the Haida Nation (CHN), represented by the President of the CHN. It was witnessed by 9 Hereditary Leaders of Haida Gwaii and 9 other Haidas. The Archipelago Management Board (AMB), consists of 2 representatives each from Parks Canada and the Haida Nation. The AMB provides direction for the management of the natural and cultural heritage values of Gwaii Haanas, including SGang Gwaay.

The legal framework for the area surrounding the World Heritage property and the buffer zone provides **an adequate or better basis** for effective management and protection of the property, contributing to the maintenance of its

Outstanding Universal Value including conditions of Authenticity and / or Integrity

4.2.5 - Can the legislative framework (i.e. legislation and / or regulation) be enforced?

There is **acceptable** capacity / resources to enforce legislation and / or regulation in the World Heritage property but some deficiencies remain

4.2.6 - Comments, conclusions and / or recommendations related to protective measures

A protective zone has been created by the firm boundaries of the National Park Reserve, National Marine Conservation Area Reserve and Haida Heritage Site. This protective zone is managed through the Gwaii Haanas NPR & HHS Management Plan for the Terrestrial Area and the Gwaii Haanas NMCAR & HHS Interim Mangement Plan and Zoning Plan. Through these wider boundaries and the accompanying management plans, the site of SGang Gwaay and its OUV are adequately protected.

4.3. Management System / Management Plan

4.3.1 - Management System

There is a Management Plan for GHNPR and this includes SGang Gwaay. There is also a site plan specific to SGang Gwaay, which provides more specific management direction. The SGang Gwaay Site Plan, approved in 1998,

recommended that specific management actions be taken to minimize the impacts of visitation.

- Recommend to visitors that they use the north beach as their point of access.

- Create a loop trail to minimize overlap between different visit groups, to allow greater solitude and to provide visitors with a better perspective on the village's environment.

- Formalize the trail, harden where necessary.

- Use the beach on the southern portion of the village as a trail to minimize the impacts of foot traffic on artifacts.

- Provide shelter at the south end of the beach for gear
- storage, rather than the beach or village.

- Provide a site pamphlet to assist visitors in gaining a better understanding of the island's features.

- Install a solar composting toilet at Watchmen cabin.

- No public mooring buoys, sea floor can withstand anchoring. All 8 items have been implemented since 1998.

There are a number of innovative management practices in place to ensure the conservation of the OUV at SGang Gwaay. Gwaii Haanas National Park Reserve, which includes SGang Gwaay, is cooperatively managed by the Archipelago Management Board (comprised of equal representatives from the Government of Canada and the Council of the Haida Nation). The AMB oversees the management of the area and the participation of Haida representatives ensures that all cultural concerns for SGang Gwaay are met.

4.3.12 - Please report any significant changes in the legal status and / or contractual / traditional protective measures and management arrangements for the World Heritage property since inscription or the last Periodic report

Since the last Periodic Report the waters surrounding Gwaii Haanas, which includes SGang Gwaay have become a National Marine Conservation Area Reserve (2010). The new NMCAR designation, the Fisheries Act, and the Rock Fish Conservation Area are mechanisms to ensure that the waters and ecosystems surrounding SGang Gwaay are managed. These mechanisms enhance the OUV as it relates to the living culture of the Haida, whose living culture depends on the ocean's resource.
