3.7.1. Occasionally we have winds up to 140km/h, which cause problems in buildings, specially affecting the roofs, as well as erosion. 3.12. Termites are increasing in wood structures and heat-treated wood does not show a significant resistance to termite attacks, thus being currently substituted for other materials.

The last one, the Regional Legislative Decree Nr. 15/2004/A, submits all planning instruments to the Detail Plan of Safeguard and Valuation, under the responsibility of the City Hall. Through this instrument, each building is under direct supervision of the respective authorities, in what concerns its preservation.

In order to overcome this problem currently affecting 25% of the buildings, legislation will have to be amended and concrete measures taken to combat termite infestation.
