2.3 - Attributes expressing the Outstanding Universal Value per criterion

Criterion (i) Saint Petersburg is one of a kind, and the perfect embodiment - on a vast scale - of the European ideal of an orderly city surrounded by palaces and parks, all harmonized with the natural landscape. The city, built according to a precise plan in a very short time, was brought into being despite extremely adverse natural conditions. Criterion (ii) Saint Petersburg became the visual embodiment of the innovations of the Petrine era. It was founded as the capital of a new state and as a model city for the whole of a Russia under renewal. The normative value of the capital was increased from the beginning by the establishment of the Academy of Sciences followed by that of the Academy of Fine Arts. The urban model of Saint Petersburg was finally completed in the period of the reigns of Catherine the Second (Catherine the Great), Alexander the First, and Nicholas the First and was used during the reconstruction of Moscow (after the fire of 1812). The Saint Petersburg blueprint influenced the planning of many Russian cities (such as Odessa, Sevastopol, and others). The former capital of the Russian Empire continued to play a substantial role in the evolution of architecture in 20th century city planning. Criterion (iv) The cultural landscape of Saint Petersburg and its environs is unique. Various city design epochs and periods of artistic styles (baroque, classicism, historicism, Art Nouveau, Constructivism, neoclassicism) gave the city and its suburbs variety and diversity. Even so, the architectural appearance of the "northern capital" remains undivided. Its primary value lies within its unity of natural foundation and architectural medium. Criterion (vi) Saint Petersburg has repeatedly been tied directly and tangibly to events of international importance. The new capital of Russia, conceived as a "window to Europe", played a decisive role in the country's modernization during the 18th century and in turning it into a great European and world power. The city bore witness to and participated in both majestic and tragic events such as the 1917 February and October Revolutions and the heroic blockade of 1941-1944, in which some million human lives were lost. Having survived the unprecedented trials of the 20th century, the city continues to

be a symbol and base of Russian culture for new times, one of its centers of science, culture and education tied eternally to the names of such scholars, architects, writers, musicians, and ballet dancers as Lomonosov, Rastrelli, Pushkin, Rossi, Gogol, Dostoevsky, Tchaikovsky, Petipa, Pavlov, Mendeleev, Vavilov, Shostakovich, Ulanova, and others.

4.2. Protective Measures

4.2.1 - Protective designation (legal, regulatory, contractual, planning, institutional and / or traditional)

At federal level, the property is treated as national heritage, although there is no specific legislation for World Heritage. The Federal Law "On Cultural Heritage of the Peoples of Russian Federation" is applicable to certain individual structures within the property. The Master Plan of St. Petersburg, approved in 2005, adopted areas of protection of cultural heritage sites in accordance with the established zone mode. These include historic buildings, skyline, panoramas and views. Parameters for construction and reconstruction are regulated throughout the whole property and in the proposed buffer zone. In 2009, on the basis of the Master Plan, Land Use and Development Rules were adopted, including territorial zoning and city planning regulations which prohibit new construction in the protected areas except for the regeneration of the historical landscape. However this Plan regulates protection only on the portion of the property located within the boundaries of St. Petersburg. Other parts, located on the territory of the Leningrad district, have no protected areas.

4.2.5 - Can the legislative framework (i.e. legislation and / or regulation) be enforced?

There is **acceptable** capacity / resources to enforce legislation and / or regulation in the World Heritage property but some deficiencies remain 4.2.6 - Comments, conclusions and / or recommendations related to protective measures

4.3. Management System / Management Plan

4.3.1 - Management System

The management of the property is shared between the two Federal districts: Saint-Petersburg and the Leningrad District. They are significantly uneven as regards their staff (150 persons on one side, 18 people on the other side). This arrangement means that there is no single entity with responsibility for the World Heritage property. There is no management plan for the property, which might cover stakeholders, activities and resources.

The supervision over the status of the property is carried out by KGIOP and the Department for State Protection, Preservation and Use of the Cultural Heritage Properties of the Committee for Culture of the Government of Leningrad Region, within the limits of their authority.

A national working group has been formed in 2010 by the Committee on State Control, Use and Protection of Historical and Cultural Landmarks of St. Petersburg (KGIOP), with the objective of clarifying the components of the serial property and its boundaries.

In 2013, the World Heritage Committee approved the proposed minor boundary modification concerning the major component- the Historic Centre of Saint Petersburg (component 540-001) - of the serial nomination of the Historic Centre of Saint Petersburg and Related Groups of Monuments.

The Government of St. Petersburg has established preservation of the historic centre as a priority which prevails over the concept of compromise and so-called rational balance between preservation and development. The development of a long-term programme for the conservation and restoration of the Historic Center of St. Petersburg (2012-2018) has been started in order to provide comprehensive rehabilitation of the historic environment, taking into account social interests and interests of private investors. The Governor of St. Petersburg has engaged in a dialogue with the public city-protection movement, through the Committee on Protection of Landmarks. Representatives of social organizations and movements are members of the Council for the Conservation of Cultural Heritage of the Government of St. Petersburg.
