Currently the State Administration of Cultural Heritage is carrying out the Conservation Project and organizing to formulate the Master Plan for the Conservation of the Great Wall, which will put forth specific requirements on the property areas (protected area) and buffer zones (construction constricted area) of the Great Wall, thereby retaining the integrity and authenticity of the property.

4.2. Protective Measures

4.2.1 - Protective designation (legal, regulatory, contractual, planning, institutional and / or traditional)

The Great Wall is under the protection of THE CONSTITUTION, THE CRIMINAL LAW, THE STATE LAW FOR THE PRESERVATION OF CULTURAL RELICS, THE LAW OF ENVIRONMENTAL PROTECTION OF THE PEOPLE'S REPUBLIC OF CHINA.

Comment

Some sections of the Great Wall have been designated as the State Priority Protected Cultural Heritage Site. For example, the Shanhaiguan Pass, the Jiayuguan Pass, the Badaling etc.With the progress of the Conservation Project of the Great Wall, the identification of the Great Wall is underway and more sections will be designated as the State Priority Protected Cultural Heritage Site based on the scientific research and following the routin procedure.

4.2.2 - Is the legal framework (i.e. legislation and / or regulation) adequate for maintaining the Outstanding Universal Value including conditions of Integrity and / or Authenticity of the property?

An adequate legal framework for the maintenance of the Outstanding Universal Value including conditions of Authenticity and / or Integrity of the World Heritage property exists but there are **some deficiencies in implementation**

4.2.3 - Is the legal framework (i.e. legislation and / or regulation) adequate in the buffer zone for maintaining the Outstanding Universal Value including conditions of Integrity and / or Authenticity of the property?

The property had **no buffer zone at the time of inscription** on the World Heritage List

An **adequate** legal framework exists for the area surrounding the World Heritage property and the buffer zone, but **there are some deficiencies in its implementation** which undermine the maintenance of the Outstanding Universal Value including conditions of Authenticity and / or Integrity of the property

There is **acceptable** capacity / resources to enforce legislation and / or regulation in the World Heritage property but some deficiencies remain

All the components of the Great Wall have been declared under state or provincial protection. The Great Wall conservation Ordinance promulgated by the State Council of China in 2006 is specifically dedicated to the conservation & management of the Great Wall. The plans on the conservation of the Great Wall have played an important role in ensuring the implementation of the integrated protection and management of the World Heritage property.

At the inscription of the Great Wall on the List, there were no clear identification, boundaries and SOUV of the property. Chinese government has worked hard to protect it ever since. From 2005, State Administration of Cultural Heritage of China has carried out the Conservation Project and invested great number of money in the investigation, planning, restoration and management of it. Untill now, the investigation of the Great Wall in Ming has finished and it reaches 8851.8 km long.
