4.2. Protective Measures

The area was first given protected status by the Dutch Colonial Government in 1919, with the establishment of the Lorentz Nature Monument

In 1978 it was established as a Strict Nature Reserve (Cagar Alam) by the Indonesian Government (44/Kpts/Um/1/1978), with an area of 2,150,000 hectares. In 1991 the area was listed as one of the sites with highest priority for conservation in Indonesia's National Biodiversity Action Plan. In 1996 WWF and the provincial department

of forestry (Kanwil Kehutanan) proposed a revision of the reserve boundaries and change the status to become a National Park. The Director General for Nature Conservation and Forest Protection excepted this revision in July 1996. In March 1997 the Minister of Forestry declared the Lorentz area a National Park, that includes a western extension (Mt.Trikora, Mt.Rumphius, Lake Habbema area) and coastal waters.

An adequate legal framework for the maintenance of the Outstanding Universal Value including conditions of Authenticity and / or Integrity of the World Heritage property exists but there are **some deficiencies in implementation**

Reason for update: The Committee noted that as per the request of 25 October 1999 from the Indonesian authorities, an adjustment of approximately 150,000 hectares were made to exclude oil exploration concessions in the south-east corner of the Park. The Committee accepted this reduction in the size of the property and agreed with the new boundaries. The modified size of the site is now about 2.35 million hectares.
