THE OKAVANGO IS THE ANCESTRAL HOME OF THE SAN INDIGENOUS PEOPLES OF BOTSWANA

- •The Okavango Delta is more than the habitation of animals.
- olt is home to Indigenous and Local communities like: The Bugakhwe, The Qanikhwe, The Xeriku, Hambukusu, Wayeyi and Batawana.
- Measures should therefore be put in place to recognize this aspect

LEGISLATION IN BOTSWANA RECOGNIZING AND PROTECTING COMMUNITIES

- Constitution of Botswana
- Gives every citizen rights
- Protection from discrimination on the basis of race, ethnicity, gender etc
- However no recognition and protection as a tribe, indigenous peoples or minorities.
- Only 8 tribes recognized

LEGISLATION CONT'

- Tribal Territories Act
- Recognizes 8 tribes
- Designate tribal territories to them
- Territories named after them
- Kgosi from these tribes supreme tribal leader of the area

LEGISLATION CONTINUED

- House of Chiefs and Cultural representation
- Only 8 Tswana speaking tribes have automatic access to House of Chiefs
- Represent and custodian of culture of their tribes

LAND TENURE AND LAND USE SYSTEM IN BOTSWANA

- Masimo
- oMoraka/ Mahudiso
- Motse
- No recognition of the way of life of indigenous peoples: hunting and gathering

INTERNATIONAL INSTRUMENTS RECOGNIZING INDIGENOUS PEOPLES

- IP recognition by UNDRIP
- Article 1 (enjoyment of their human rights, including as a collective), Article 2 (free from any discrimination) Article 3 (free to determine development)
- Article 8 (the right not to be subjected to forced assimilation)
- UN EMRIP recognition of Indigenous Peoples
- Called upon World Heritage committee to review and revise its working methods to ensure that Indigenous peoples are adequately consulted.

INTERNATIONAL RECOGNITION CONTINUED

- IP recognition by UNESCO
- Unesco Policy on engagement with Indigenous Peoples
- Agenda 2030 commitment 'to leave no one behind'
- IP recognition by IUCN
- In 2016 at WCC decision by IUCN Members' Assembly to create a new category of membership for Indigenous Peoples' Organizations (IPOs)
- ✓ This decision opened the opportunity to strengthen the presence and role of IPOs in IUCN.
- Environmental, Economic and Social Policy

- ✓ The Environment and Social Safeguards Framework ESSF), esp, ESS7
- olP recognition by IFAD
- ✓IFAD engagement with Indigenous Peoples policy

- CBD art 8(j), Nagoya Protocol art 7
- olP recognition by the Paris agreement
- A human rights approach and involvement of indigenous peoples

- community mobilization
- Community consultation:
 Consultation from Government perspective
- Participation
- Decision Making Process
- Prior and Informed Consent

INVOLVEMENT OF INDIGENOUS AND LOCAL COMMUNITIES

- Meaningful consultation of indigenous and local communities through FPIC (Nagoya, Art
 7)
- Internationally recognized principle
- Free: Free from coercion or enticements
- Prior: before decision was taken
- Informed: Giving the people information about the project to make an informed decision
- Consent: to have the opportunity to say yes or No

LAND AND LAND UTILIZATION OF INDIGENOUS AND LOCAL COMMUNITIES

- Respect the traditional land utilization of indigenous peoples and Local Communities
- Protect the land rights of indigenous peoples and local communities against land grabbers

- Involve indigenous peoples and local communities as partners in conservation.
- Capacity building
- Involvement of indigenous peoples in research as co-researchers and research assistants
- Communities should derive benefits from the Okavago.
- Promotes and preserve the customs and traditions of Indigenous Peoples and local communities regarding IKS.

- Development of sustainable projects for the benefit of indigenous Peoples and local Communities.


