We would like to also state that the Directorate is focusing to improve the overall visitor experience as well as providing the additional facilities for the visitors. As a top priority, the Directorate has developed an Annual Development Scheme for the stabilization and conservation of the tomb of Jam Nizamuddin II for which the GPR study has also been completed.

As many of the interventions are in progress, the Directorate of Antiquities and Archaeology submits that a revised State of Conservation Report (as an addition to this report) may kindly be accepted by 15th of April, 2020 wherein we would be able to show our continuing progress on the stated recommendations.


