The serial property consists of 7 component parts (while the nomination dossier counts 6 serial components). Following the recommendations of ICOMOS (Interim Report from December 2020) Trnovo bridge was exempted from the then larger component 1 "Green Promenade from Trnovo Bridge along Vegova Street with the National and University Library to Congress Square with Zvezda Park" and stands as a separate component 1 "Trnovo Bridge". The previous component 1 was thus renamed "Green promenade along Vegova Street" and represents component 2, and the renumbering of component parts was carried out accordingly.

2. Description of the modification

As the newly inscribed World Heritage property consists of 7 components (see previous chapter), the set of maps in chapter 7 presents the entire series, including the components with no modification of the buffer zone but with revised numbering, a proposed minor boundary change of the property of the component 4, a proposed minor boundary modification of the selected components, and a new wider buffer zone in the city centre.

The proposed modifications follow the changes to the legal protection that entered into force in May 2020, namely the amendments and supplements to the Ordinance designating the work of Jože Plečnik in Ljubljana as a cultural monument of national importance.

The following buffer zones of the components were modified: Trnovo Bridge, Green Promenade along Vegova Street, Roman Walls in Mirje, Church of St. Michael, and Plečnik's Žale – Garden of All Saints. In addition, a new wider buffer zone of Plečnik's work in the city centre was designated.

An enlargement of the buffer zones in general includes the expansion to the immediate setting of Plečnik's interventions; they encompass the views or include other areas that are functionally important or support the property, and thus enhance the existing protection.

The proposed modifications are presented on the maps (see chapter 7) and in text in accordance with the Ordinance designating the work of the architect Jože Plečnik in Ljubljana as a cultural monument of national importance (Official Gazette of the Republic of Slovenia, Nos. 51/09, 88/14, 19/16, 76/17, 17/18 and 74/21).

DETAILED DESCRIPTIONS OF THE PROPOSED MODIFICATIONS TO THE BOUNDARIES OF THE PROPERTY AND OF THE BUFFER ZONES

Component part 1 - Trnovo Bridge

The buffer zone of the component Trnovo Bridge was defined. It consists of the existing monument Gradaščica, which complements Trnovo Bridge as a separate component of the World Heritage property. The Gradaščica area has been declared a monument of national importance.

Component part 2 - Green Promenade along Vegova Street

A minor extension of the buffer zone to the north and west; the buffer zone additionally includes a series of buildings running from and including the Ursuline Church to the Šubič Grammar School, the crossroads of Slovenska Road and Šubičeva Street in the northwest corner of Zvezda Park, and a series of buildings along the northern side of Zvezda Park from the Kazina Palace to Wolfova Street. Wolfova Street, one of the entries to Zvezda Park, is protected under the new wider buffer zone.

Component part 4 - Roman Walls in Mirje

Minor boundary modification of the buffer zone on the western extremities of the serial component of the Roman Walls in Mirje; the buffer zone is extended to the crossroads of Groharjeva and Jamova Streets. The eastern extremities of the serial component of the Roman Walls in Mirje are additionally protected under the new wider buffer zone.

Minor change of the component part: this modification rounds up the area with an additional parcel at the western corner of the Roman Walls. Additionally, adjustment of the boundary north of the pyramid follows the existing parcel.

Component part 5 - Church of St. Michael

Extension of the component's buffer zone towards the southeast. The buffer zone is extended across the road in front of the church and by parcels on the Ljubljana Marshes, which can be seen from the church as part of the vistas towards the natural hinterlands.

Component part 7 - Plečnik's Žale - Garden of All Saints

A small expansion of the buffer zone towards arterial roads in the west and southwest. The roundabouts in the west and southwest are the entry points to the buffer zone, which thus extends to the nearby parcels. The boundaries of the buffer zone are adjusted with the inclusion of the land by the petrol station in the southeast and the green areas in the residential zone by the east side.

A minor modification also involves the exclusion of the parcels of the existing active cemetery in the north, in order to align the buffer zone boundaries with the situation

on the ground.

The overall buffer zone of the complex thus forms a more coherent whole.

The new wider buffer zone in Ljubljana city centre

In order to enhance protection of the series, a new wider buffer zone of Plečnik's work in the city centre was designed, taking into account the existing boundaries of the cultural monuments of local importance proclaimed by the active municipal acts, and adopted them appropriately. Similarly, the protection regimes in this new buffer zone were defined on the basis of the existing municipal acts on designations and applicable spatial acts.

The amended Ordinance further strengthens protection of the components 1, 2, 3 and 4, as it incorporates multi-layered statutory protection regimes subject to monuments of local and national importance in a single legal act at the state level. Therefore, the effectiveness of protection of Plečnik's work, as well as existing surrounding buildings and immediate settings, and the buffer zones, is addressed.

See also the Ordinance amending the Ordinance, Article 6.

3. Justification of the modification

Revision of the existing legal protection was part of the overall nomination and evaluation process during which prospective expansions of the existing buffer zones of the selected component parts were discussed within the working group for the preparation of the nomination. After ICOMOS raised particular concerns in four locations and the issue was included in the Interim Report of 17 December 2020, a formal procedure to amend the ordinance was initiated in January 2021 by the State Party. Information on the proposed changes, including a description and maps of the proposed modification, the new wider buffer zone, as well as the status of the formal process (that was in the public consultation at the time) were included in detail in the Additional Information submitted by the State Party on 24 February 2021.

The proposed modifications are therefore reflected in the ICOMOS Evaluation Report from 18 March 2021 and form a part of the World Heritage Committees' Decision.

As the first part of paragraph 4 in the Decision 44 COM 8B.45 reads:

"[The World Heritage Committee] Recommends that the State Party give consideration to the following: a) Submitting a minor boundary modification of the extended buffer zones, when formalised, with an updated map showing the property and the buffer zones' boundaries, indicating the total area of the buffer zones in hectares; [...]"

Based on the abovementioned Committees' recommendation that followed ICOMOS advice, the State Party prepared the amended Ordinance and submits the minor boundary modification for consideration and approval.

DETAILED JUSTIFICATIONS

Component part 1 - Trnovo Bridge

Trnovo Bridge represents a separate component part and was excluded from the

previous component 1 (see chapter 1, see also Additional information, February 2021, p. 24).

The modification ensures proper preservation of views of and from the property, the preservation of its features, and the protection of its values.

Component part 2 - Green Promenade along Vegova Street

Expansion of the buffer zone ensures additional protection of vistas from and of the property, the preservation of its features, and the protection of its values.

Component part 4 - Roman Walls in Mirje

Expansion of the buffer zone ensures additional protection of vistas from and of the property, preservation of its features and protection of its values. With the expansion of the property, the Roman walls are covered in full and enjoy comprehensive protection.

Component part 5 - Church of St. Michael

Expansion of the buffer zone ensures protection of vistas of the Ljubljana marshes from the property and vistas of the property from the surrounding area, the preservation of its features, and the protection of its values.

Component part 7 - Plečnik's Žale - Garden of All Saints

Expansion and slight adjustment of the buffer zone ensures protection of vistas from and of the component part. The minor boundary modification improves the coherence of the entire site and thus facilitates the preservation of the property's features and the protection of its values.

The new wider buffer zone in Ljubljana city centre

The delineation of the new wider buffer zone further strengthens protection of the components 1, 2, 3 and 4, as it incorporates multi-layered statutory protection regimes subject to monuments of local and national importance in a single legal act at the state level. Therefore, the effectiveness of the protection of Plečnik's work, as well as the existing surrounding buildings and immediate settings, and the buffer zones, is addressed.

Minor modifications of buffer zones and a wider buffer zone in the city centre are determined for maintaining the integrity and authenticity of Plečnik's arrangements and monuments in the centre of the city. Where a negative impact on the conservation of the material condition of Plečnik's works and views of them can be observed, the protection regime shall apply, which determines the adjustment of planning and all spatial interventions in relation to the integrity of Plečnik's works, preservation of the existing unbuilt open space and of the existing heights of buildings, as well as avoidance of interventions whose volume might have negative impact on Plečnik's work.

4. Contribution to the maintenance of the Outstanding Universal Value

The proposed modifications enhance the OUV, in particular through effective protection of the context, which has previously been the subject of several ordinances at the local and state levels.

Context is an important part of Plečnik's interventions in the city, in particular in the city centre, where his works are marked by the author's highly contextual approach and together with their immediate settings and views form coherent urban ensembles. The spatial, architectural, functional, and symbolic relationship of Plečnik interventions with the pre-existing setting are thus enhanced, as they play an important role in supporting the OUV of the property. This is further supported with the continuous public use of open spaces and green areas as well as buildings, including the original design and arrangements.

The proposed modifications to the delineation therefore bring stronger legal protection of the wider area of so-called Plečnik's Ljubljana, which is characterized by Plečnik's works and arrangements as well as large-scale and small interventions in the city that still shows off the marks imprinted by the Roman period, the Middle Ages, and Baroque. The protection regime also provides comprehensive protection from interventions that could potentially endanger the integrity and authenticity of the serial property.

In response to the World Heritage Committee's recommendation, the State Party will give further consideration to further identification of the relationship between Plečnik's interventions and pre-existing buildings as spaces, to allow appropriate protection measures to be put in place. This modification is seen as a part of the mentioned process and also responds directly to the recommendation to submit a minor boundary modification when formalized (44 COM 8B.45, paragraph 4.a) and f)).

5. Implication for legal protection

The modification of the boundaries of the World Heritage Property "The Works of Jože Plečnik in Ljubljana – Human Centred Urban Design" is based on the Ordinance designating the work of the architect Jože Plečnik in Ljubljana as a cultural monument of national importance from 2009 with subsequent amendments (Official Gazette of the Republic of Slovenia, Nos. 51/09, 88/14, 19/16, 76/17, 17/18 and 74/21).

1640. ORDINANCE AMENDING THE ORDINANCE DESIGNATING THE WORK OF THE ARCHITECT JOŽE PLEČNIK IN LJUBLJANA AS A CULTURAL MONUMENT OF NATIONAL IMPORTANCE, PAGE 4502.

Pursuant to Article 13 of the Cultural Heritage Protection Act (Official Gazette of the Republic of Slovenia [Uradni list RS], Nos. 16/08, 123/08, 8/11 – ORZVKD39, 90/12, 111/13, 32/16 in 21/18 – ZNOrg), the Government of the Republic of Slovenia issues an

ORDINANCE

amending the Ordinance designating the work of the architect Jože Plečnik in Ljubljana as a cultural monument of national importance

Article 1

Paragraph four of Article 3 of the Ordinance designating the work of the architect Jože Plečnik in Ljubljana as a cultural monument of national importance (Official Gazette of the Republic of Slovenia [Uradni list RS], Nos. 51/09, 88/14, 19/16, 76/17 and 17/18) shall be amended to read as follows:

Article 4

In Article 37, paragraphs three and four shall be amended as follows:

- "(3) The monument comprises plots nos. 70/11, 70/8, 71/16, 71/36, 71/4, 77/54 (central northern part of the plot/road in front of the Roman Walls), 77/55, 78/27, 78/4, 78/6, all k. o. Krakovsko predmestje.
- (4) Buffer zone of the monument includes plots nos. *147, 70/10 (southern part of the plot), 70/7 (southern part of the plot), 71/3, 71/30, 71/35 (central part of the plot), 71/41 (southern part of the plot), 77/54 (central southern part of the plot/road in front of the Roman Walls), 78/23, 78/26, 78/8, all k. o. Krakovsko predmestje."

Article 5

In Article 40, paragraph three shall be amended as follows:

"(3) The monument comprises plots nos. 73/65, 73/66, 73/67, 73/68, 73/87, 73/89, 73/93 (southern part of the plot on the northern embankment of the Gradaščica), 73/94, 73/95, 73/96, 73/97, 73/98, 81/42, 81/43, 81/44, 81/51 (southern part of the plot, northwest of the Trnovo Bridge), 81/52, all k. o. Krakovsko predmestje; plots nos. 1692/1, 1692/48, 1703/6 (western part of the plot/riverbed up to the bridge on Groharjeva Road), 1703/7, 1703/8, 1703/9, 183/4, 183/5, 186/16 (northernmost part of the plot along plot no. 186/20, k. o.

Trnovsko predmestje), 186/17, 186/18, 186/19, 186/20, 187/13, 187/14 (northern part of the plot on the southern embankment of the Gradaščica), 187/16 (northern part of the plot on the southern embankment of the Gradaščica), 187/21 (northern part of the plot on the southern embankment of the Gradaščica), 187/22, 187/25, 187/26, 193/10, 193/11, 193/3, 193/4, 193/5, 193/8 (northern part of the plot between plots nos. 193/11 and 187/21, both k. o. Article 6

After Article 54, a new Article 54a shall be added as follows:

"Article 54a

- (1) A wider buffer zone shall be determined for maintaining the integrity and authenticity of Plečnik's arrangements and monuments in the centre of the city of Ljubljana.
- (2) The boundaries of the wider buffer zone run from the bridge across the Gradaščica on Riharjeva Road southeast to the garden of Plečnik House and onwards to the south between the buildings on Kolezijska Street 11 and Karunova Street 14 where it turns east and follows Karunova Street to Ziherlova Street, all the way to Borsetova Street. At the house at 10, Borsetova Street, the line turns northwest, runs to Ižanska Road and continues along it, crosses the Gruber Canal and reaches Roška Road along its left embankment. On Roška Road, the line turns north to Poljanska Road and along it before turning into Potočnikova Street, follows the Poljane Embankment and crosses the Mortuary Bridge along Očetovska Street to Zaloška Road. On Zaloška Road, the line turns west. From there, it runs to Croatian Square, encircles it and continues along Ilirska, Komenskega and Tavčarjeva streets and crosses Slovenska Road. It continues along Gosposyetska Road where it turns south at the crossroads to Bleiweisova Road and runs all the way to Puharjeva Street where it turns west to Pod Turnom Path and onwards to the western edge of the Jakopič Promenade. The line then follows the walking paths in Tivoli Park to Cesta 27. aprila Road where it encircles Tivoli Park towards the east. It crosses the railway line and continues along the eastern edge of Bleiweisova Road, crosses Trg mladinskih delovnih brigad Square and continues all the way to Groharjeva Road and along its edge to the Gradaščica River.
- (3) The boundaries of the wider buffer zone are displayed on the topographic map in 1:10000 scale in the Annex, which is an integral part of this Ordinance.
- (4) In the wider buffer zone where a negative impact on the conservation of the material condition of Plečnik's works and views of them can be observed, the protection regime shall apply, which determines:
- Adjustment of planning and all spatial interventions to preserve the integrity of Plečnik's works;
 - Preservation of the existing unbuilt open space;
 - Preservation of the existing height dimensions;
 - Avoidance of interventions whose volume exceeds Plečnik's works."

Article 7

Paragraph two of Article 55 shall be amended as follows:

"(2) The data on all cadastral municipalities from the preceding paragraph are in the original scale of 1:1000 and 1:2000; files of 1 February 2007, 22 April 2008, 16 July 2008, 15 September 2008, 30 May 2014, 27 October 2015, 16 February 2017 and 24 January 2021."

Article 8

Article 58 shall be amended to read as follows:

"Article 58

- (1) The cultural-heritage protection conditions shall be met, and a cultural-heritage protection approval of a responsible public institution shall be obtained in advance for all interventions involving monuments, their buffer zones and the wider buffer zone, unless stipulated otherwise by law.
- (2) When planning interventions involving monuments, which are protected on the basis of international treaties and whose signatory is the Republic of Slovenia, their buffer zones and the wider buffer zone, a heritage impact assessment shall be undertaken where this is required by the competent international organisation."

TRANSITIONAL AND FINAL PROVISION

Article 9

Pursuant to paragraph three of Article 13 of the Cultural Heritage Protection Act (Official Gazette of the Republic of Slovenia [Uradni list RS], Nos. 16/08, 123/08, 8/11 – ORZVKD39, 90/12, 111/13, 32/16 and 21/18 – ZNOrg), the status of a cultural monument shall be registered ex officio in the land register for plot no. 78/27, k. o. 1720 Krakovsko predmestje, and for plots nos. 1692/48, 186/16 (northernmost part of the plot along plot no. 186/20, k. o. Trnovsko predmestje), 186/17, 186/18, 186/19, 186/20, 187/13, 187/14 (northern part of the plot on the southern embankment of the Gradaščica), 187/16 (northern part of the plot on the southern embankment of the Gradaščica), 187/21 (northern part of the plot on the southern embankment of the Gradaščica), 187/22, 187/25, 187/26, 193/10, 193/11, 193/3, 193/4, 193/5, 193/8 (northern part of the plot between plots nos. 193/11 and 187/21, both k. o. Trnovsko predmestje), 196/2, 224/5, 224/8, 225/75, all k. o. 1722 Trnovsko predmestje.



6. Implication for management arrangements

The minor modifications of the boundaries will reinforce the commitments of the Management Plan as defined in the established management system. As a result of the expanded buffer zone the responsible institutions will extend the scope of impact assessment for the inscribed heritage to provide a more comprehensive analysis of effects of development in view of the context of Plečnik's interventions. The Institute for the Protection of Cultural Heritage of Slovenia, the City of Ljubljana, and the Ministry of Culture will assume even stronger roles in spatial planning arrangements and in planning interventions into the heritage site. The owners of inscribed components already have in place relevant management plans that encompass management of the property or the property's area, which means that respective owners or managers will not be affected by the modification (expansion) of the buffer zone.








2 — GREEN PROMENADE ALONG VEGOVA STREET




