This report on the state of conservation of the "Spiritual and Political Center of the Tiwanaku Culture" was prepared by the designated institution, in accordance with Supreme Decree No. 1004/2011, which creates the Tiwanaku Archaeological, Anthropological and Administration Research Center.— CIAAAT, with technical, legal and economic autonomy.

In this context, the Ministry of Cultures, Decolonization and Depatriarchalization has received the conservation report of the "Spiritual and Political Center of the Tiwanaku Culture", in accordance with the recommendations made by ICOMOS and ICCROM, advisory institutions of the World Heritage Committee, according to the "DECISION of WHC/18/42.COM/7B Paris, May 14, 2018 and WHC/21/44.COM/7B - Paris, June 4, 2021". Therefore, the report prepared by the CIAAAT considers the recommendations and attaches supporting documents of the prioritized elements within the framework of its attributions.

Likewise, within the framework of the competences and decisions taken by the CIAAAT Board of Directors, the Executive Directorate of the CIAAAT entity, has complied with the elaboration of the Management Plan and Conservation Plan according to the guidelines required by UNESCO, likewise In order to guarantee the meaning of the Outstanding Universal Value - VUE, the verification and consolidation management of the limits of the patrimonial asset declared World Heritage has begun. For this purpose, the Ministry of Cultures, Decolonization and

Depatriarchalization - MCDyD, has signed an Agreement with the Military Geographic Institute - IGM, and within this framework the CIAAAT, which is a decentralized entity under the supervision of the MCDyD, has signed a service contract with the Military Geographic Institute - IGM, to fulfill this purpose. Once the verification is completed, the management of expansion of the buffer zone will begin according to the results of aerial photogrammetry, of 2017.

The Ministry of Cultures, Decolonization and Depatriarchalization, in accordance with the commitments assumed as a State Party to UNESCO, will make all necessary efforts to comply with the recommendations of ICOMOS and ICCROM, in coordination with all the instances of Law and society, in order to conserve, preserve and maintain the significance of the Outstanding Universal Value of the "Spiritual and Political Center of the Tiwanaku Culture".

2. Response to the decision of the World Heritage Committee.

The Plurinational State of Bolivia, through the Ministry of Cultures, Decolonization and Depatriarchalization and the Center for Archaeological, Anthropological Research and Administration of Tiwanaku - CIAAAT, has prepared the responses to the "DESICIONS of WHC/18/42.COM/7B Paris, May 14, 2018 and WHC/21/44.COM/7B - Paris, June 4, 2021" as well as in the context of the recommendations and analysis of its advisory bodies ICOMOS and ICCROM. Therefore, the responses to each of the paragraphs requested by the World Heritage Committee are attached to this "Report on the State of Conservation by the State Party", in accordance with the Decisions referred to above. The following paragraphs a); b); and c), of this question 2, does not correspond to the site declared World Heritage "Spiritual and Political Center of the Tiwanaku Culture", considering that it is not inscribed on the List of World Heritage in Danger.

According to the report of the "Centro de Investigaciones Arqueológicas, Antropológicas y Administración de Tiwanaku - CIAAAT" sent on November 29, 2022, it refers to other elements, the management of proprietary rights, which is being addressed by the CIAAAT, after verification of the limits and their respective buffer zone, which is being addressed by the competent legal entity, the Instituto Geográfico Militar - IGM, for the consolidation of the limits of the declared property, with which the management of property rights will be carried out to the corresponding instances. In this context, the Ministry of Culture, Decolonization and Depatriarchalization will help with what is necessary to achieve the right of ownership of the property in favor of the Plurinational State of Bolivia. According to the Management Plan and Conservation Plan, no restoration, alteration or new construction has been prioritized in the short term, if there are these activities referred to in the request of the World Heritage Center, they must be submitted by the General Director Executive, to the CIAAAT Board of Directors, for their respective consideration and validation, in accordance and considering the recommendations issued in the "DESICIONS of WHC/18/42.COM/7B Paris, May 14, 2018 and WHC/21/44.COM/7B - Paris, June 4, 2021". Therefore, the current
