8C. Update of the List of World Heritage in Danger

Summary

Following the examination of Items 7A and 7B (state of conservation reports) and 8B (nominations), the Committee is asked to confirm decisions to inscribe, maintain or remove properties from the List of World Heritage in Danger.

This document also contains statistical data concerning decisions taken on nominations and the State of Conservation of properties inscribed on the World Heritage List.

I. UPDATE OF THE WORLD HERITAGE LIST AND OF THE LIST OF WORLD HERITAGE IN DANGER

The World Heritage Committee at its 46th session (New Delhi, India, 21-31 July 2024) inscribed 24 new properties on the World Heritage List, 4 natural, 1 mixed and 19 cultural, and approved the extension of 2 properties already inscribed on the List. Among the successful nominations, there are 3 new cultural landscapes and with these additions we have now 129 properties officially recognized as such on the World Heritage List which represents 10.5% of the List.

Breakdown by region of the new 24 properties inscribed and the 2 extensions approved at the 46th session:

- Africa: **5** properties
- Arab States: **3** properties
- Asia-Pacific: **8** properties
- Europe/North-America: 9 properties
- Latin America/Caribbean: 1 property
- 2. The new overall figures of the World Heritage List are now **1223** properties of which **952** are cultural, **231** natural and **40** mixed.

Breakdown by region of the World Heritage List:

- Africa: **108** properties
- Arab States: **96** properties
- Asia-Pacific: 295 properties
- Europe/North-America: **574** properties
- Latin America/Caribbean: **150** properties

The trans-regional properties are counted in only one region.

Out of the 27 nominations examined, 4 (that is 15%) are situated on the territory of current World Heritage Committee members. Following the debates on Item 8B, 1 nomination was referred. At this session, in 4 cases the Committee changed the Advisory Body recommendation which was presented in the Draft Decision.

- 3 Referrals became Inscriptions

- 1 Deferral became Inscription
- 4. As a result of the decisions relating to the Status of Conservations of properties inscribed on the List and the decisions on nominations of properties to the World Heritage List, at this session, the Committee decided to inscribe 1 property on the List of World Heritage in Danger:
 - State of Palestine, Saint Hilarion Monastery/ Tell Umm Amer

- 5. At the same time, **1** property was removed from the List of World Heritage in Danger:
 - Senegal, Niokolo-Koba National Park
- 6. According to these decisions, there are now **56** properties inscribed on the **List of World Heritage in Danger**.
- 7. At this session, the World Heritage Committee did not confirm the recommendation presented in the Draft Decisions relating to the **inscription on the List of World Heritage in Danger** of **2** properties.
