He established two charities focusing on nature conservation, the Ivan Dejmal Foundation for Nature Conservation (1993) and ProAfrica (2012). The former at first aimed at restoration of Jizerské hory/Jizera Mts. forests drastically damaged by air pollution, namely acid rains, in the 1970s – 1990s, later it has been supporting various nature conservation and landscape protection measures in the field within the region.

The later supports nature conservation including involvement of local communities and indigenous people in some sub-Saharan countries through targeted projects and programmes. His long-term interest in Africa resulted in writing of dozens of articles dealing with African biodiversity conservation and sustainable use, protected areas and ecotourism. His more than 25 trips to various African countries would account minimally for a two-year full-time stay. Within international cooperation between the Czech Republic and Zambia (the Ministry of Tourism and Arts), he has conducted a feasibility study on the possibility of establishing an ecotourism/nature-based tourism infrastructure in Zambian National Parks as a part of the Czech Development Aid.

Author, co-author and editor of dozens of scientific papers, technical/expert studies and popular articles on nature conservation, landscape protection, environment management, conservation biology & ecology including key policy documents in nature conservation and landscape protection of the Czech Republic (*e.g.*, Nature Conservation and Landscape Protection Programme of the Czech Republic 1997, 2009).
