The boundaries are regularly monitored by the field staff and adherence is ascertained by taking legal action against the violators, wherever necessary.

5.2. Protective Measures

The arrangement for the protection of the property is done by implementing the provisions provided under AM ASR Act of 1958 Rules 59 and 92 notification declaring prohibited and regulated areas wherever necessary under the advice and guidance of Central Government Standing Counsels for effective preservation and maintenance of the World Heritage property. In addition, at the local State Govt. level the Govt. of Goa also has enacted Planning Development Authority (Development Plan) regulation 1989 and 2000 as per which special conservation/preservation zones have been created including Old Goa and all the constructions, developments, repairs, demolition within this zone shall be referred to Heritage Committee whose decision shall be binding on the part of the Planning Department authorities/Panchayats. Archaeological Survey of India is one of the members in the above Heritage Committee. At the local Panchayat level, the Panchayat Raj Act of 1994 has its own regulations for lay out, new roads, new bridges etc and the Panchayat generally refers any construction proposed near the monument to the Archaeological Survey of India.

There is a need to work with the State Tourism Department, Collectorate of North Goa and Chief Architect, Govt. of Goa to work out a development plan to enhance the visitor amenities in the buffer zone by appointing a suitable consultant and preparing a concept paper and submitting to the Central / State Government for approval before being implemented by the respective agencies. This plan may then be given legal status.

If the work is continued further without acquiring the necessary permissions, a request for issuing a demolition order is sent to the DG, ASI who, in turn, orders the District Collector to effect the demolition.

14. Good Practice in the Implementation of the World Heritage Convention

The Novena of St. Francis Xavier is celebrated every year in the last week of November and the first week of December. Devotees from all over the world, belonging various demographic and cultural backgrounds representing not only Christian but also several other religions visit the Basilica of Bom Jesus and participate in this annual Novena. Each year, apart from several hundred thousand tourists visiting the WH Site, the number of pilgrims visiting the site during the Novena alone soars to additional few hundred thousand. The Exposition, scheduled every ten years is even more important and calls for preparations, which are multiple times more intensive and extensive in nature. It is during these events, that the Archaeological Survey of India, Goa Circle as the site manager works in association with the Church Authorities, the State Government and all of the concerned departments to ascertain that these socio – cultural and religious practices are preserved and continued intact. Joint meetings are called wherein all concerned departments of the State Government, the members of the Archdiocese and Church Authorities and the officials of Archaeological Survey of India, Goa Circle engage in a dialogue to identify the needs and the necessities of the visiting pilgrims while ascertaining that the integrity of the World Heritage Site of "Churches and Convents of Goa" is preserved intact. This entails making available the necessary requirements of availability of visitor amenities like potable water, restroom facilities, disaster management provisions, traffic and movement plans and proper policing for maintaining the law and order while ascertaining that the integrity of the WH Site is uncompromised. The same is achieved with the help of a proper dialogue between the site manager and all other stakeholders.
