3. Statement of Outstanding Universal Value

3.1 - Statement of Outstanding Universal Value for the property as adopted by the World Heritage Committee

Déclaration de valeur universelle exceptionnelle

Brève synthèse

Situés dans le vaste Massif calcaire, au nord-ouest de la Syrie, une quarantaine de villages antiques offrent un aperçu cohérent et d'une amplitude exceptionnelle sur les modes de vie ruraux et villageois de l'Antiquité tardive et de l'époque byzantine. Abandonnés au cours des VIIIe-Xe siècles, ils possèdent toujours une grande partie de leurs monuments et constructions d'origine, dans un remarquable état de conservation : maisons d'habitation, temples païens, églises et sanctuaires chrétiens, monuments funéraires, thermes, édifices publics, bâtiments aux fonctions économiques et artisanales, etc. C'est également une illustration exceptionnelle du développement du christianisme en Orient, au sein de communautés villageoises. Regroupés au sein de huit parcs archéologiques, l'ensemble forme une série de paysages culturels reliques uniques et exceptionnels.

Critère (iii) : Les villages antiques du Nord de la Syrie et leurs paysages reliques apportent un témoignage exceptionnel sur les modes de vie et sur les traditions culturelles des civilisations rurales qui se sont développées au Moyen-Orient, dans le cadre d'un climat méditerranéen de moyenne montagne calcaire, du Ier au VIIe siècle.

Critère (iv) : Les villages antiques du Nord de la Syrie et leurs paysages reliques apportent un témoignage exceptionnel tant de l'architecture de la maison rurale que des constructions collectives civiles et religieuses à la fin de l'Antiquité et durant l'époque byzantine. Leur association au sein des villages et des lieux de culte forme des paysages reliques caractéristiques de la transition entre le monde antique païen et le christianisme byzantin.

Critère (v) : Les villages antiques du Nord de la Syrie et leurs paysages reliques apportent un exemple éminent d'un établissement rural durable, du Ier au VIIIe siècle, basé sur une utilisation rationnelle du sol, de l'eau et de la pierre calcaire et sur la maîtrise de productions agricoles de valeur. La fonctionnalité économique de l'habitat, les techniques hydrauliques, les murets de protection et le parcellaire romain inscrits dans les paysages reliques en témoignent.

Intégrité

L'intégrité architecturale s'exprime de manière satisfaisante. Les biens ont une extension suffisante ; ils comprennent un nombre important de villages, de lieux de culte, de témoignages monumentaux et archéologiques pour exprimer convenablement la valeur universelle exceptionnelle. Le nombre et la qualité des paysages reliques est également satisfaisante et essentielle à l'expression de cette valeur. Toutefois, la tendance récente d'une réoccupation agricole du Massif calcaire pourrait affecter l'intégrité du bâti de certains villages ainsi que les paysages associés.

Authenticité

Grâce à une situation de déprise humaine millénaire, à l'absence de remploi des pierres et à l'absence de campagnes de restaurations - reconstructions au XXe siècle, les biens et leurs paysages ont gardé un haut degré d'authenticité. Toutefois, les réimplantations rurales récentes pourraient les affecter, mais une remise en culture respectueuse de l'ancien parcellaire devrait contribuer à revitaliser les paysages sans en affecter les conditions d'authenticité.

Mesures de protection et de gestion

La dynamique de la protection légale est bien orientée, notamment à la suite des décrets de création des parcs, à des fins de contrôle d'un développement agricole et urbain compatible avec les valeurs archéologiques, monumentales et paysagères des biens. Elle doit être confirmée par la révision de la Loi des antiquités, dans le sens de la protection des paysages culturels reliques.

La gestion du bien est actuellement (2010) assurée par la Direction générale des antiquités et des musées (DGAM), mais de manière transitoire. La structure finale de la gestion du bien comprendra huit parcs associés à chacun des biens, deux Centres de gestion et la Maison du patrimoine pour le pilotage de l'ensemble et la coordination de la conservation, sous le contrôle de la DGAM, du ministère du Tourisme et des gouverneurs de provinces. Ces entités sont en cours d'instauration et elles sont indispensables. Elles auront pour défi, en concertation avec les municipalités, de réussir un développement économique, social et touristique compatible avec la conservation et l'expression de la valeur universelle exceptionnelle du bien.

Several cases of violations and vandalism were described at various sites. Breaking existing ancient wall stones.

Les monuments et sites archéologiques de plus de 200 ans dépendent de la *Loi des antiquités* (n° 222, 1963, révisée en 1974 et en 1999). La DGAM définit les sites qui constituent le patrimoine national et qui doivent être protégés sous forme d'une inscription officielle sur le *Registre des sites archéologiques et des monuments*. Elle oblige les municipalités à prévoir leur conservation dans les plans de développement locaux et dans les cadastres. Elle prévoit l'interdiction de constructions et de travaux dans un périmètre de 500 m, ainsi que la restauration éventuelle sous le contrôle de la DGAM.

L'inscription des premiers monuments du bien a commencée en 1937. Actuellement, 36 sites archéologiques dans le bien sont protégés par la Loi des antiquités. Les principales autres lois nationales qui s'appliquent au bien sont le Code civil et la Loi de punition (n° 148, 1949), la Loi de gestion et d'administration municipale (n°12, 1971, révisée en 2003, loi n° 15), la Loi sur les sites urbains (1974), le Décret sur les forêts et la protection de l'environnement (n°25, avril 2007) et la Loi de planification régionale (n°26, juin 2010). Les décisions récentes concernant la nouvelle structure de gestion du bien sont les décrets ministériels (Premier ministre) de création des huit parcs archéologiques (n° 52/A à 59/A, 31 janvier 2010), la décision ministérielle (Culture) de création des deux Centres de gestion des parcs (336/A, 29 juillet 2010) et le décret de création de la Maison du patrimoine (26 août 2010). Un programme de sensibilisation aux valeurs du bien des populations vivant dans les limites des parcs a été initié.
