



## Talayotic Menorca (Spain) (1528rev)

### 1. Executive Summary of the Report

Most of the work related to drafting plans is currently underway through external contracting.

The drafting of the various master plans is at different stages of execution. The master plans for the main sites of components C2, C5, and C8 have already been completed. The master plans for the main sites of component C1 have been contracted and are in the drafting process. The drafting of the remaining master plans is in the process of being contracted.

The development of a general research strategy depends partly on the research objectives defined in the master plans of the sites, although the current five-year management plan of the Talayotic Menorca Agency establishes priority research lines.

The preparation of the risk prevention strategy and climate change adaptation plan is currently contracted and in the drafting process.

The development of a specific tourism strategy for Talayotic Menorca is currently in the documentation preparation phase for its contracting.

The creation of a harmonised interpretation strategy for all components of Talayotic Menorca depends partly on the dissemination and interpretation objectives defined in the master plans of the sites, although the Talayotic Menorca Agency has a document containing basic guidelines for the creation of informational supports at archaeological sites.

The update of the Talayotic Menorca Management Plan will be carried out as significant sets of new content are finalised, so as to optimise work and avoid unnecessary multiple updates.

Currently, possible alternatives are being studied for the stainless-steel bar supporting the right jamb of the entrance to the hypostyle hall and for the concrete support stabilising the horizontal slab of the taula at Trepucó, constructed during the first half of the 20<sup>th</sup> century.

The Department of Mobility of the Island Council of Menorca has commissioned a Heritage Impact Assessment document, which aims to find a solution to the road junction near the navetas of Rafal Rubí (Component C6) and that does not affect their Outstanding Universal Value.

A study has been contracted and is underway to determine the exact route of the electrical and telephone lines, as well as possible corrective measures.

Advances have been made in the understanding of talayots, especially regarding intervisibility networks and chronology.

New findings have also emerged in the field of archaeoastronomy.

At the 46<sup>th</sup> meeting of the World Heritage Committee, the name change of the inscribed property was approved through Decision 46 COM 8B.1, now referred to as Talayotic Menorca.

There are no other current conservation issues, nor are there any anticipated significant restorations, alterations, and/or new constructions that could impact the property's Outstanding Universal Value.
