I. EXECUTIVE SUMMARY OF THE REPORT.

Following paragraph 169 of the Practical Guidelines, the Plurinational State of Bolivia submits the report on the "State of Conservation of the City of Potosí," prepared by the Ministry of Cultures, Decolonization, and Depatriarchalization, following "DECISION 46 COM 7A. 7" which consists of the following:

- 1. Continuity of inter-institutional work and sustained agreements of the comprehensive and Participatory Management Plan of the City of Potosí 2021.
- 2. Compliance with the minor limit indicators and buffer zone activities.
- 3. Highlights the Evaluation of the Integrated and Participatory Management Plan of the City of Potosí 2021 in which the degree of development and scope of the same is determined
- 4. Highlights the development of the Integrated and Participatory Management Plan for the City of Potosí - 2024 update, in coordination with UNESCO consultant Luis Ignacio Gomes Arriola and the other institutions that make up the Plan.
- 5. Highlights the efforts of the State Party to remove the City of Potosí from the List of World Heritage in Danger.
- 6. Continuation of the stabilization work on Cerro Rico by COMIBOL and the Autonomous Government of the Department of Potosí.
- 7. Progress in the migration of mining cooperatives above the 4400 meters above sea level.
- 8. Continuity in monitoring and water quality in the Kari Kari lagoons.
- 9. Details the preservation and conservation work in the Historic Center carried out by the Autonomous Municipal Government of Potosí.
- 10. It details the technical collaboration of the Ministry of Cultures, Decolonization and Depatriarchalization with other institutions by providing digital information, surveys and reports.
