1. Executive Summary of the Report

The property was inscribed on the World Heritage List in 2021 - and simultaneously inscribed on the List of World Heritage in Danger – Decision 44 COM 8C.1. State of Conservation Reports were provided in January 2022, 2023 and March 2024.

A DSOCR – Desired State of Conservation to be reached to allow the property to be removed from the List of World Heritage in Danger – was produced after a thorough consultation process between the World Heritage Centre, ICOMOS, and State Party representatives in 2022 and 2023. The DSOCR was adopted by the Committee at its extended 45th Session in 2023 – Decision 45 COM 7A.56. At its 46 Session in 2024 the Committee adopted Decision 46 COM 7A.2 in which it is welcoming the decision of the World Bank's International Centre for Settlement of Investment Disputes of 8 March 2024 to dismiss Gabriel Resources' arbitration claim against the Government of Romania, is also welcoming the activation of the Management Committee and the progress made in the implementation of the established DSOCR measures and is encouraging the State Party to include in the Management Plan an archaeological research plan.

The State Party is working constantly for the implementation of the DSOCR corrective measures. Progress has been made since the simultaneous inscription on the World Heritage List and In-danger List. This includes establishment and activation of the Management Committee, initiation of the elaboration of the General Urban Plan (ongoing), the revision of the Property Management Plan (final reviews), constant improving of the state of conservation of some of the supporting attributes, general enhancement of the visitor experience, including the Roman galleries of the Mining Museum, improving accessibility and water quality.

Response to the Decision of the World Heritage Committee

While all actions developed are following the objectives of the World Heritage Committee Decision for inscription in 2021 - 44 COM 8C.1 – this SOC report is addressing the two most recent Decisions of the World Heritage Committee – 45 COM 7A.56, for the approval of the DSOCR and 46 COM 7A.2. All actions in response to the recommendations of the World Heritage Committee are timetabled, together with responsibilities and suggested indicators, as detailed in the documents submitted to the Centre and the Advisory Body during the consultation process. Such actions were also included as main priorities in the revision of the Property Management Plan.

The following table presents the main developments in the implementation of the DSOCR corrective measures:

	the attributes of OUV.		General Urban Plan (PUG), was operationalized in the second half of 2024. The four institutions steadily met and cooperate for the collection of the relevant data, the preliminary documentation and the specifications needed for the initiation of the PUG according with the Convention requirements and the Committee specific decisions. MDLPA ensured the necessary internal procedure and allocated a budget of approx. 400.000 EUR for 2025. The launch of the public procurement procedure is estimated for q2 2025 (national elections at the end of 2024 and the change of the Government, caused some delays in relation with the initial estimated schedule) and a support group will be organized in order to assist the public consultation of the elaboration process.

In addition to the above corrective measures updates and developments we are currently addressing the recommendation added in the last Committee Decision - 46 COM 7A.2 – "to include in the Management Plan, as part of its reassessment of the Roman archaeological sites, an archaeological research plan to guide future work on existing sites and on future survey work to clarify what further surface and underground mining, ore processing and settlement sites of the Roman period remain". This is to be correlated with and is also depending on the ongoing preliminary procedures (including updated surveys) that are being done for the handover of the mining perimeter by RMGC to ANRMPSG. The future regaining of the administration of the underground by the Romanian authorities will allow for an adequate archaeological research plan to be formulated. As a preliminary action, a series of experts and scholars were contacted to establish an expert working group capable of producing an informed and effective research plan to be integrated into the Property Management Plan.

Other current conservation issues identified by the State Party which may have an impact on the property's Outstanding Universal Value

Some of the state of conservation issues concerning supporting heritage elements within the property – such as houses, churches, header ponds from the 18^{th} - and 19^{th} -century etc. – are being currently addressed. These, while of a much later phase and not directly attributed to OUV, are nonetheless important in the presentation of the continuity of the property's wider mining heritage. They also contribute to the visitor experience and definitely to the wellbeing of the local community. All were thoroughly presented in the last SOC reports in 2023 and 2024 and we are now updating the information as follows: the Ministry of Culture, through the National Institute of Heritage, is continuing conservation works on built heritage, within its two main funding instruments: the National Restoration Programme (PNR approx. 2.2 million EUR), and the Historic Monuments Stamp Duty programme (TMI approx. 280,000 EUR in the former exercise to which an additional 2,077,322 EUR were added in the current exercise). One of the two complex ongoing conservation and restoration projects within the PNR – the Greek-catholic parish house – was finalized in April 2024 while the second one progressed substantially and is scheduled for reception in the third quarter of 2025, depending on the weather conditions.

Besides the 13 maintenance conservation and restoration works and design implemented within TMI – churches, houses and also repairs and presentation works for the Roman galleries of the Mining Museum – completed in 2023 following a call for projects launched immediately after inscription, the TMI calls in 2024 resulted in three more projects being contracted: the restoration works for the house of the Cantor of the Unitarian church as well as for the historic cinema and the restoration project for the Greek-catholic church.

- Repairs and conservation works for 8 historic buildings, financed by the Ministry of European Investments and Projects, through the National Resilience and Recovery Plan (PNRR) started in 2023 and are continuing with a progress of 20 to 75% of the total works, depending on each particular situation. The buildings are owned by local administration and churches, and the budget for each building is set to max. 65,000 EUR, totalling an approx. 500,000 EUR for Roşia Montana. This is included in the PNRR sub-programme Route of villages with traditional architecture within the Attractive Romania Programme which also integrates a strong online component for the presentation and enhancement of the included villages and sites.
- There are other heritage interventions, carried out by professional and/or local NGOs (in progress) as part of a larger community program ('Adopt a House') financed both from private donations and grants offered by the Administration of the National Cultural Fund (AFCN) and the Romanian Order of Architects (OAR) through the architectural stamp duty (total campaign budget of approx. 80,000 EUR in the past 2 years; pending approvals for further grants). The most recent works include the restauration of the Calvin Church (finished during the 2024 campaign) as well as emergency interventions at the Roman-catholic chapel, the former casino etc. (ongoing).
- Road infrastructure improvements financed through the PNDL National Local Development Programme – as well as the Anghel Saligny National Investments Programme and co-financed by the Roşia Montană Municipality, were approved by specialized bodies of the Ministry of Culture and are ongoing – total budget of approx. 3,816,917 EUR – and scheduled to be finalized in December 2026. These have special provisions for archaeological remains and landscape authenticity protection and will significantly improve accessibility. The project also covers historic roads in the World Heritage property and was developed with the assistance of the National Institute of Heritage.

- The process for elaborating the strategy for heritage interpretation and presentation was started through the efforts of the National Institute of Heritage and two interpretive agents, members of the local community, by participating in a pilotproject focused on the interpretation of Rosia Montana Mining Landscape World Heritage Site. The strategy will focus on communicating the meaning and values both for cultural and natural heritage, on the stories of different communities local, regional, national and international and on the involvement of the local community in interpretation through storytelling events and trainings. Part of the Learning Landscape Initiative, developed by Interpret Europe in partnership with UNESCO Venice Regional Office, the pilot-project is being implemented between October 2024 and December 2025 after a methodology elaborated for UNESCO designated sites. . Part of the project was integrated in an application elaborated by Roșia Montană World Heritage Association, which was selected for co-funding by the Administration of National Cultural Fund within the call for projects dedicated to immovable and movable heritage. For full funding, the National Institute of Heritage has initiated a partnership with Alba County Council.
- Four associations Association 37 in partnership with SNK Association, Roşia Montană World Heritage Association and InfomART Association - together with 'Simion Balint' Secondary School and other NGOs and specialists are implementing since April 2024, together with the local community, an environmental education project for the Property: 'Clean Waters in Roşia Montană'.

The main activities included: educational activities on the importance of recycling and its correct practice and the protection of the biodiversity of the Property; art and creative writing; organizing cultural events for and with the community; five clean-up campaigns along the watercourses and at header ponds-and; five selective waste collection systems built; setting up an environmental library in the hall of the secondary school; round tables organised with the local authorities - town hall, local collector, environmental protection guard - with the aim of creating a community alliance between institutions, organisations, informal leaders and local people for better management of waste resulting from the human activities and minimising the amount of waste that ends up in the commune's waters. With the help of mentors, the children learnt about the impact of micro-plastics in nature, learnt about water composition and how to analyse water with water testing kits. Thanks to the environmental library, pupils and teachers will be able to integrate the knowledge they have learnt into their lessons.

In conformity with Paragraph 172 of the Operational Guidelines, describe any potential major restorations, alterations and/or new construction(s) intended within the property, the buffer zone(s) and/or corridors or other areas, where such developments may affect the Outstanding Universal Value of the property, including authenticity and integrity.

None. This topic is being currently addressed within the elaboration of the Urban Regulations in the General Urban Plan (PUG) as well as in the Property Management Plan. Provisions regarding the use of Heritage Impact Assessment (HIA) are being introduced in the PUG in order to control interventions with potential impact upon the OUV.

The introduction of HIA as a mandatory procedure within the national legislation in the fields of construction, urban planning and natural and cultural heritage protection is also envisaged at the initiative of the Ministry of Culture and is being discussed currently with key partners such as Ministry of Development (MDLPA), Ministry of Environment (MMAP) and other relevant stakeholders.
