Item 6 of the Provisional Agenda: Requests for technical cooperation

COSTA RICA (Request No. 205.1(Rev.)

Financial contribution towards training programmes, improvement of infrastructure, transportation and boundary surveys of the Talamanca Range-La Amistad Reserve Complex (nominated for inclusion in the World Heritage List) amounting to \$50,770 for 1984 and \$49,230 for 1985. The 1984 request can be broken down into \$13,050 for training activities and \$37,720 for technical cooperation.

ETHIOPIA (Request No. 9.1(3)

Equipment for the environmental education programme in Simen National Park and surrounding rural area of the Simen Mountains, at a cost of \$45,000.

HAITI (Request No. 180.1)

Financial support towards masonry work and purchase of equipment for the restoration of the Citadel Henry National History Park amounting to \$24,930.

HONDURAS

- Request No. 129.1

Equipment, consultant services and support to training activities for the conservation and development of the Maya Ruins of Copan, at a cost of \$47,000. This sum includes \$26,850 for training activities.

HONDURAS (cont'd)

- Request No. 196.1 (Rev.)

Financial assistance for the implementation of protective measures, for training activities and environmental education programmes for Rio Platano Biosphere Reserve, amounting to \$48,000 (\$42,080 for technical cooperation and \$5,920 for training activities).

IVORY COAST

- Request No. 195.1

Equipment, construction of buildings for park wardens, financial support towards maintenance of equipment and of the research station of Tai National Park, amounting to \$350,000. Further details of this request, including co-ordination with the World Wildlife Fund programmes, are currently being discussed with the Ivory Coast Authorities.

- Request No. 257.1

Vehicles and financial assistance for the construction of guard posts and various buildings, delimitation of boundaries and well-boring at Mount Nimba (Ivory Coast part) at a cost of \$220,000. This request is being discussed with the Ivory Coast Authorities.

JORDAN (HACHEMITE KINGDOM OF) (Request No. 148.1)

Consultant services to undertake an architectural survey of monuments of the Old City of Jerusalem which are in need of restoration and to prepare a plan for the preservation work to be undertaken, at a cost of US\$60,000.

NEPAL (Request No. 120.1(4)

Financial contribution towards the reafforestation programme, improvement of the displays at the visitors' centre and provision of a small electric pump for Sagarmatha National Park, at a cost of \$30,000.

PANAMA (Request No. 159.1 (Rev.)

Services of specialists and field equipment for Darien National Park at a cost of \$45,000.

POLAND (Request No. 32.1)

Equipment for preparatory work, safeguarding activities and security measures in the Wieliczka Salt Mine, at a cost of \$95,500.
