Item 7A of the Provisional Agenda: State of conservation of the properties inscribed on the List of World Heritage in Danger

SUMMARY

As announced in Document *WHC-07/31.COM/7A.Add.2*, the present document presents an up-date on the state of conservation of the Old City of Jerusalem and its Walls since 12 June 2007.

Document WHC-07/31.COM/7A.Add 2 indicated that "any new information which would be available after the issuance of the present document will be presented in an Addendum".

Decision required: The Committee is requested to review the information provided in Document WHC-07/31.COM/7A.Add.2 and in the present document. The Committee may wish to adopt the draft Decision contained in this document.

Draft Decision: 31 COM 7A.18

The World Heritage Committee,

- 1. <u>Having examined</u> Documents WHC-07/31.COM/7A.Add.2, WHC-07/31.COM/7A.Add.3, WHC-07/31.COM/INF.7A.1, WHC-07/31.COM/INF.7A.2 and WHC-07/31.COM/INF.7A.3,
- 2. <u>Recalling</u> Decision **30 COM 7A.34**, adopted at its 30th session (Vilnius, 2006),
- 3. <u>Further recalling</u> 176 EX/Special Plenary Meeting/Decision, adopted at the 176th session of the UNESCO Executive Board (April 2007),
- 4. <u>Also recalling</u> the relevant provisions on the protection of cultural heritage including, as appropriate, the four Geneva Conventions (1949), the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict of 1954, the Convention for the Protection of the World Cultural and Natural Heritage of 1972, the inscription of the Old City of Jerusalem and its Walls at the request of Jordan on the World Heritage List (1981) and on the List of World Heritage in Danger (1982), and of the recommendations, resolutions and decisions of UNESCO,
- 5. <u>Affirming</u> that nothing in the present decision, which aims at the safeguarding of the cultural heritage of the Old City of Jerusalem and its Walls, shall in any way affect the relevant United Nations resolutions and decisions, in particular the relevant Security Council resolutions on the legal status of Jerusalem,
- 6. <u>Welcomes</u> the Action Plan for the Safeguarding of the Cultural Heritage of the Old City of Jerusalem developed in the context of the Director-General's comprehensive initiative for the safeguarding of the cultural heritage of the Old City of Jerusalem and its Walls and <u>strongly supports</u> its implementation in coordination with the concerned parties;
- 7. <u>Also welcomes</u> the information provided by the Israel National Commission for UNESCO in its letter dated 8 June 2007, indicating that the archaeological excavations at the Mughrabi ascent have stopped and <u>urges</u> the Israeli authorities to limit on-going activities at the Mughrabi ascent to consolidation and stabilization works;
- 8. <u>Asks</u> the World Heritage Centre to facilitate the professional encounter at the technical level between Israeli, Jordanian and Waqf experts to discuss the detailed proposals for the proposed final design of the Mughrabi ascent, prior to any final decision;
- 9. <u>Requests</u> the Israeli authorities, in addition to the above encounter, to provide the World Heritage Centre, as soon as possible, with the proposed final design of the Mughrabi ascent, whose principle aim should be to maintain the authenticity and integrity of the site;
- 10. <u>Further asks</u> the World Heritage Centre to make technical expertise and assistance available for the future conservation works at the Mughrabi ascent, as needed;

- 11. <u>Calls on</u> the international donor community to support, through extra-budgetary funding, activities aimed at the safeguarding of the cultural heritage of the Old City of Jerusalem and its Walls, in particular in the context of the Action Plan;
- 12. <u>Further requests</u> the World Heritage Centre to report on the state of conservation and on the progress in the implementation of the Action Plan for the Safeguarding of the Cultural Heritage of the Old City of Jerusalem at its 32nd session in 2008;
- 13. <u>Decides</u> to recommend the application of the reinforced monitoring mechanism subject to the procedures in Document WHC-07/31.COM/5.2 and Decision **31 COM 5.2.Rev** in monitoring the state of conservation of the Mughrabi ascent and <u>requests</u> a report every two months from the World Heritage Centre until its 32nd session in 2008;
- 14. <u>Decides</u> to retain the Old City of Jerusalem and its Walls on the List of World Heritage in Danger.
